REQUEST TO APPROVE AN AMENDMENT TO THE FUNDING AGREEMENT FOR THE FAMILY FIRST PREVENTION SERVICES ACT PREVENTION AND PROMOTION SERVICES (ALL SUPERVISORIAL DISTRICTS) (3-VOTES)

#### **SUBJECT**

The Department of Children and Family Services (DCFS) requests the Board's approval to amend the existing Funding Agreement (FA) with Southern California Grantmakers (SCG), originally executed on June 5, 2023, for the Family First Prevention Services Act (FFPSA) Prevention and Promotion Services.

#### IT IS RECOMMENDED THAT THE BOARD:

- 1. Delegate authority to the Director of DCFS, or designee, to execute Amendment Number Four, substantially similar to Attachment A, to the FA for FFPSA Prevention and Promotion Services with SCG to increase the agreement amount by \$1,900,000, financed by 100 percent State funds. The amendment is effective upon execution through June 30, 2027, with an option to extend effective July 1, 2027 through April 30, 2028.
- 2. Delegate authority to the Director of DCFS, or designee, to exercise the extension option effective July 1, 2027 through April 30, 2028, by written notice or amendment, provided that: a) funding is available; b) County Counsel approval is obtained; and c) the Director of DCFS, or designee, notifies the Board and the Chief Executive Officer (CEO), in writing, within ten (10) business days after execution.

- 3. Delegate authority to the Director of DCFS, or designee, to execute amendments to make changes to the agreement term and conditions, if necessary to accommodate unanticipated changes in service needs, provided that: a) County Counsel's approval is obtained; and b) the Director of DCFS, or designee, notifies the Board and the CEO, in writing, within ten (10) business days after execution.
- 4. Delegate authority to the Director of DCFS, or designee, to terminate the agreement for convenience or default by written notice or amendment, provided that: a) County Counsel's approval is obtained; and b) the Director of DCFS, or designee, notifies the Board and the CEO, in writing, within ten (10) business days of execution.

#### PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The Community Cultural Broker Program (CCBP) plays a critical role in advancing the goals of the FFPS by offering culturally responsive, community-driven support to prevent unnecessary child welfare involvement and promote family stability. CCBP helps bridge systemic gaps by connecting Black/African American families to tailored resources and services that address the root causes of disproportionality in the child welfare system.

Despite success in increasing family engagement, improving child safety outcomes and reducing entry and re-entry into care, the program remains underfunded. An increase in available funding is necessary to streamline data collection methods, finalize a training curriculum, conduct a process evaluation and quasi-experimental study and resource the community-based organizations leading this effort, all of which increase the availability of culturally relevant service delivery.

The increase to the FA meets the intent of the Federal legislation and affirms the County's commitment to racial equity and community-based prevention.

#### IMPLEMENTATION OF STRATEGIC PLAN GOALS

The recommended actions are consistent with the principles of the County Strategic Plan North Star #1, Make Investments That Transform Lives by supporting vulnerable populations through efforts that promote prevention by utilizing youth development program and services for at-risk, justice-involved, transitional aged children, youth, families and communities at all stages of the sequential intercept model and child welfare continuum of care model; as well as investing in efforts that support child safety, protection, and family well-being.

#### FISCAL IMPACT/FINANCING

The agreement will be increased by \$1,900,000, financed by 100 percent State funds. Funding is included in the Department's Fiscal Year (FY) 2025-2026 Adopted Budget and will be included in the Department's subsequent budget requests.

#### FACTS AND PROVISIONS/LEGAL REQUIREMENTS

In August 2021, California elected to opt-in to the Federal FFPSA. Subsequently, California enacted Assembly Bill 153 (Chapter 86, Statutes of 2021), which established the FFPS Program and encouraged counties to consider a holistic view of the prevention of child maltreatment. The California Department of Social Services (CDSS) provided a three-year grant to support implementation of FFPS and required counties to develop a Comprehensive Prevention Plan. Los Angeles County received FFPS SBG allocation of \$49 million for DCFS, which had to be spent by June 30, 2024. In January 2024, CDSS announced the extension of the deadline for the FFPS SBG spend down to the end of FY 2028.

The Board letter and the Amendment (Attachment A) were reviewed by County Counsel and the CEO.

#### **CONTRACTING PROCESS**

The Board motion, approved by the Board on April 18, 2023, directed the Director of DCFS to enter into an FA with the Center for Strategic Partnerships' fiscal agent, SCG, to facilitate an expedited funding pathway to community-based organizations and consultants for the provision of ten (10) prevention and promotion pilot services and supports identified in the Los Angeles County Comprehensive Prevention Plan, with the option to extend the agreement contingent upon the availability of funding and approval of County Counsel. The FA was executed effective June 5, 2023.

The Board motion, approved by the Board on September 24, 2024, directed the Director of DCFS to amend the agreement, as needed, for the development and implementation of the Preventive Legal Services Hub and Warmline to increase the provision of preventive services and increase the agreement amount by \$1,070,000. The amendment was executed and is effective September 30, 2025.

The Board motion, approved by the Board on December 17, 2024, directed the Director of DCFS to amend the agreement, as needed, for the development and implementation of the Plans of Safe Care for Pregnant and Parent People Struggling with Substance Use for the provision of prevention services and increased the agreement amount by \$950,000. The amendment is effective through June 30, 2027.

#### **IMPACT ON CURRENT SERVICES (OR PROJECTS)**

Approval of the recommended actions will allow DCFS to continue to provide FFPS services to children and youth at imminent risk for entry into the child welfare system.

#### AMENDMENT NUMBER FOUR FAMILY FIRST PREVENTION SERVICES ACT PREVENTION AND PROMOTION FUNDING AGREEMENT NUMBER SCG-6523

This Amendment Number Four (hereinafter referred to as "Amendment") to the Family First Prevention Services Act (FFPSA) Prevention and Promotion Pilot Funding Agreement Number SCG-6523, (hereinafter referred to as "Agreement") is made and entered into by and between the Department of Children and Family Services (DCFS) on behalf of the County of Los Angeles and its Board of Supervisors (hereinafter referred to as "COUNTY") and Southern California Grantmakers (SCG) (hereinafter referred to as "CONTRACTOR"), in Los Angeles, California this \_\_\_ day of \_\_\_\_\_\_\_, 2025.

**WHEREAS,** on April 18, 2023, the Board of Supervisors approved a Board Motion directing the Director of DCFS to enter into a funding agreement with the CONTRACTOR to facilitate an expedited funding pathway to community-based organizations and consultants for the provision of ten prevention and promotion pilot services and supports identified in the Los Angeles County Comprehensive Prevention Plan.

**WHEREAS,** COUNTY and CONTRACTOR are parties to this Agreement, executed by all parties on June 5, 2023.

**WHEREAS,** Amendment No. One extended the Agreement, effective July 1, 2024, to June 30, 2025, using delegated authority as per the expenditure extension granted by the California Department of Social Services (CDSS) released in January 2024.

**WHEREAS,** Amendment No. Two increased the Agreement amount by \$1,070,000 for the development and implementation of the Preventive Legal Services Hub and Warmline, and extended the Agreement through September 30, 2025, using the Board Motion approved by the Board of Supervisors on September 24, 2024.

**WHEREAS**, Amendment No. Three increased the Agreement amount by \$950,000 for the development and implementation of the Plans of Safe Care (POSC) for Pregnant and Parent People Struggling with Substance Use and extended the Agreement through June 30, 2027.

**WHEREAS**, Amendment No. Four increases the Agreement amount by \$1,900,000 for the provisions of the Community Cultural Broker Program (CCBP).

**WHEREAS**, this Amendment is prepared and executed by COUNTY and CONTRACTOR as set forth in the Agreement, SECTION B, AGREEMENT TERM; and

**NOW, THEREFORE, COUNTY** and CONTRACTOR mutually agree to the following changes to the Agreement:

**1. SECTION A, APPROVED FUNDING AND COSTS**, is revised to add Subsection 5c:

5c. The County agrees to pay the CONTRACTOR, for the term of this agreement an additional amount of \$1,900,000 for the provisions of the CCBP.

#### 2. SECTION B, AGREEMENT TERM, is revised to read as follows:

The term of this agreement will be effective upon date of execution through <u>June 30, 2027</u>, unless sooner terminated or extended, in whole or in part, as provided in this agreement.

Funding for this agreement is contingent on continued SBG funding allocations. In the event the State discontinues funding, DCFS has the option to terminate this agreement, or to claim towards other available funds.

The DCFS Director, or designee, shall have the sole option to extend the Contract term <u>effective July 1, 2027 through April 30, 2028</u>, provided: (a) availability of funding; (b) approval by County Counsel; and (c) written notification to the Board and Chief Executive Officer. Such extension shall be exercised at the discretion of the Director of DCFS by written notification to SCG thirty (30) days prior to the expiration of the funding agreement

EXCEPT AS AMENDED HEREIN, ALL TERMS AND CONDITIONS OF THIS AGREEMENT SHALL REMAIN IN FULL FORCE AND EFFECT.

IN WITNESS WHEREOF, the Board of Supervisors of the County of Los Angeles has caused this Amendment Number Four to be subscribed on its behalf by the Director of the Department of Children and Family Services and the CONTRACTOR has caused this Amendment Number Four to be subscribed on its behalf by its duly authorized officer(s) as of the day, month and year first above written. The person(s) signing on behalf of the CONTRACTOR warrants under penalty of perjury that he or she is authorized to bind the CONTRACTOR in this Agreement. This Amendment may be executed in separate counterparts and may be delivered by electronic facsimile; each counterpart, when executed and delivered, shall constitute a duplicate original but all counterparts together shall constitute a single agreement.

#### Fostering Inclusivity Through Closed Captioning in Los Angeles County

Los Angeles County (County) recognizes the importance of inclusive communication and equal access to information for all residents and visitors. The County is home to a significant population of individuals who are D/deaf or hard of hearing, as well as diverse communities of English language learners, and many neurodivergent individuals, including those with Autism, who benefit from captioning.

According to the non-profit organization, HEAR Center, over 800,000 individuals with some level of hearing loss reside in Greater Los Angeles and its surrounding counties<sup>1</sup>. Additionally, one-third of all individuals with autism in California live in the County.<sup>2</sup>

Extensive research shows that closed captioning on screens improves comprehension, attention, and memory for viewers of all ages and abilities.<sup>3</sup> Captions are particularly beneficial for people who are D/deaf or hard of hearing, English language learners, children and adults developing literacy skills, and those in noisy public

environments.<sup>4</sup> These benefits extend beyond the D/deaf and hard of hearing communities to the general public.

Despite federal laws requiring captioning<sup>5</sup> in many contexts, this essential accessibility feature often remains deactivated on televisions in public spaces, creating unnecessary barriers to information access. Since 1993, all television sets with screens 13 inches or larger sold in the United States have included the capability to activate closed captioning.<sup>6</sup>

Several jurisdictions, including Washington State, San Francisco, Portland, Rochester, Boston, and the City of Los Angeles, have successfully implemented or are in the process of implementing closed captioning requirements for public facilities with an emphasis on education and compliance rather than punishment.

Ensuring accessibility and inclusivity of our D/deaf and hard of hearing communities should be a standard that the County continually strives to uphold. By adopting a phased ordinance requiring public spaces to activate closed captioning, we move closer to meeting this standard.

#### I THEREFORE MOVE THAT THE BOARD OF SUPERVISORS:

- 1. Direct the Director of the Department of Aging & Disabilities, in consultation with the Commission on Disabilities and directors of any other relevant agencies or departments, including the Department of Economic Opportunity, and County Counsel, to report back in writing within 90 days with a proposed implementation plan for Los Angeles County (County) to adopt a Closed Captioning ordinance in the unincorporated areas of the County. The report back should discuss, at a minimum:
  - a. Clear definitions of key terms and reasonable exceptions.

	The Child Abuse Prevention and Early Intervention Program for Developmentally Disabled Children is a specialized program that was recommended for funding by Supervisorial District 1.			
	In 2009, the Child Abuse Prevention and Early Intervention Program for Developmentally Disabled Children was solicited through the Inter-Agency Council on Child Abuse and Neglect's (ICAN's) multi-disciplinary selection process.			
	On March 19, 2025, DCFS released a Request for Information to gain familiarity with the current market, and gather general information related to operational management of a child abuse prevention and early intervention program for developmentally disabled children, which resulted in seven (7) responses from vendors who indicated that they currently provide similar services.

#### SUBJECT

This is to request the Board's approval to extend the current Child Abuse Prevention and Early Intervention Program for Developmentally Disabled Children contract with Alma Family Services to initiate and complete the solicitation process required for a new contract execution. This contract is funded by the County Children's Trust Fund. The current contract expires on December 31, 2025.

#### IT IS RECOMMENDED THAT THE BOARD:

1. Delegate authority to the Director of Department of Children and Family Services (DCFS), or designee, to execute an amendment substantially similar to the attached amendment, to the Child Abuse Prevention and Early Intervention Program for Developmentally Disabled Children contract with Alma Family Services. Delegate authority to the Director of DCFS, or designee, to exercise the two six-month extension options option by written notice or amendment, provided that: (a) sufficient funding is available; (b) County Counsel approval is obtained prior to execution of such amendment(s); and (c) the Director of DCFS notifies the Board and the Chief Executive Officer (CEO), in writing, within 10 business days of executing such amendment(s).
- 3. Delegate authority to the Director of DCFS, or designee, to execute amendments to the Child Abuse Prevention and Early Intervention Program for Developmentally Disabled Children contract to meet program needs, and for any revisions required by changes in local, State, and Federal regulations, provided that: (a) applicable Federal, State and County contracting regulations are observed; (b) sufficient funding is available; (c) County Counsel approval is obtained prior to execution of such amendment(s); and (d) the Director of DCFS notifies the Board and the CEO, in writing, within 10 business days of executing such amendment(s).

#### PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Alma Family Services developed a child abuse and neglect prevention/early intervention program that serves children with special and unique needs. For purposes of this program special and unique needs include a developmental delay or disability, mental health diagnosis, learning disability, receiving special education services or displaying behavioral challenges. The program goals are to provide child abuse prevention/early intervention and specialized case management services for parents and caregivers of children and youth with special and unique needs. The population to be served includes children and youth who are at risk of or have been abused or neglected, and the program seeks to prevent re-victimization. Alma Family Services also works toward building and strengthening the bridge between DCFS staff, Regional Center staff, school districts, county agencies and community service providers.

National research shows that children and adolescents with special and unique needs are known to be vulnerable to abuse and neglect and are likely to be victimized at a much higher rate than other children (four to 10 times more often). In addition, these-children are often inadequately educated and supported to seek alternatives to abusive situations. It is also known that there is often an underreporting of abuse, neglect and victimization for children and adolescents with special and unique needs. Through this program, Alma Family Services is providing important and necessary services to this underserved and highly at-risk group of children.

The current contract for Alma Family Services is \$300,000/year. Services have been provided at four sites. Given that Alma Family Services is one of very few agencies that currently provide case management and parenting classes for caregivers of children with special needs in Los Angeles County, extending the Alma Family Services contract will continue to significantly impact children and families and continue providing important and necessary services to this population.

The recommended extension will enable Alma Family Services to continue providing case management and parenting classes for caregivers of children with special needs in Los Angeles County. Alma Family Services' service delivery model is significantly impactful and it is important to offer these critical preventive services to this hard-to-reach population.

#### Implementation of Strategic Plan Goals

The recommended actions are consistent with the Countywide Strategic Plan Goal North Star 1, Make Investments that Transform Lives, Focus Area Goal D, Support Vulnerable Populations; Strategy I – Prevention: Provide child welfare prevention supports (a continuum of primary, secondary, and tertiary) and youth development related program services, for at-risk, justice-involved, and transitional aged children, youth, families, and communities at all stages of the sequential intercept model and child welfare continuum of care model; Strategy II – Child Safety and Family Well-Being: Invest in efforts and supports that promote child safety, protection, and family well-being using the child welfare continuum of care model, while building out the County's System of Care.

In addition, they provide collaboration and coordination between County departments, the community and contracting partners. This program promotes interventions and specialized case management services for parents and caregivers of children and youth with special and unique needs and for children and youth who are at risk of or have been abused or neglected, while significantly preventing re-victimization.

Children and adolescents with special and unique needs are known to be vulnerable to abuse and neglect and are likely to be victimized at a much higher rate than other children. Providing specialized services to this vulnerable population has at its core a focus on keeping these children safe while facilitating paths for connections to resources, helping caregivers build protective capacities and change behaviors or conditions that caused these children to be unsafe or at risk of future harm; these activities enhance children's well-being and stabilize families.

This program also builds and strengthens the bridge between DCFS, Regional Centers, school districts, the Department of Mental Health and other specialty service providers who work with children with special and unique needs. These activities promote connections with health and mental health providers to ensure child and family well-being as well as public safety with greater emphasis on improving reports of child abuse/neglect for this population. Also, a focus on early intervention and education are recognized child abuse prevention approaches.

#### FISCAL IMPACT/FINANCING

The aggregate Maximum Contract Sum is \$600,000. The Maximum Annual Contract amount is \$300,000, financed using 100 percent AB 2994 funds. Sufficient funding for this contract is included in the Department's Fiscal Year 2025-2026 Final Adopted Budget and will be included in the Department's budget requests for subsequent years.

There is no fiscal impact to the County. AB 2994 funds stem from birth certificate surcharge fees deposited into the County Children's Trust Fund. The DCFS Finance Section has assured the Inter-Agency Council on Child Abuse and Neglect (ICAN) that sufficient funds remain with the Children's Trust Fund to continue this program for an additional three years.

#### FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The first bill, AB 1733/Papan (Chapter 1398, Statutes of 1982), authorized the allocation of state funding to counties for child abuse prevention and intervention services offered by public and private, non-profit agencies. The second bill, AB 2994/(Chapter 1399, Statutes of 1982), established a County Children's Trust Fund for the purpose of funding child abuse and neglect prevention and intervention programs operated by private, non-profit organizations. AB 2994 requires that \$4.00 of any fee for a certified copy of a birth certificate shall be paid to a County Children's Trust Fund. Both laws provide that a designated multi-disciplinary child abuse council develop and recommend funding priorities to the Board of Supervisors. In Los Angeles County, the designated child abuse council is ICAN.

The program provides in-home parent-child education and support to children and their parents who reside in the First Supervisorial District and have been identified or suspected of having special and unique needs.

Special and unique needs include a developmental delay or disability, mental health diagnosis, learning disability, receiving special education services or displaying behavioral challenges. The needs of this specialized population have often been inadequately addressed in the past and this program will promote effective services and case management for them.

On June 11, 2025, in accordance with Board Policy 5.100, Sole Source Contract and Amendments, the Department notified the Board of its intent to request delegated authority to extend the term of the current contract beyond its original term.

This Board letter has been reviewed by County Counsel and the CEO. County Counsel has approved the amendment (Attachment A) as to form. The CEO has approved the Sole Source Checklist (Attachment B).

#### CONTRACTING PROCESS

In 2009, the Child Abuse Prevention and Early Intervention Program for Developmentally Disabled Children was solicited through ICAN's multi-disciplinary selection process.

ICAN reviewed and evaluated the proposal for this program. ICAN formed a special Ad Hoc Group comprised of members from numerous county and city agencies. This Ad Hoc Group held a face-to-face meeting and engaged in an extensive process to vet Alma Family Services proposal so that any concerns about the program could be addressed, and to reach consensus regarding recommending approval for funding. The ICAN Policy Committee approved funding for this specialized program. Specialized programs are currently funded in all five (5) supervisorial districts. ICAN works with DCFS Program staff to monitor the effectiveness of the services provided and it has been determined that this program fills a vital need in the County and the services should be expanded and continued.

On March 19, 2025, DCFS released a Request for Information to gain familiarity with the current market, and gather general information related to operational management of a child abuse prevention and early intervention program for developmentally disabled children, which resulted in seven responses from vendors who indicated that they are providing similar services.

Therefore, DCFS requests the Board's approval to extend the current contract with Alma Family Services to provide sufficient time for DCFS to initiate and complete the solicitation process.

#### **IMPACT ON CURRENT SERVICES**

Linking children and families with service providers who specialize or are familiar with children with special and unique needs, providing education on child abuse and prevention, and building and strengthening the bridge with service providers for this population are important activities for maintaining family relationships and supporting goals for stability. These services promote connections with health and mental health providers to ensure child and family well-being and can alleviate problems such as safety concerns and fear of ongoing abuse experienced by these children. This program provides an opportunity to assess the impact of interventions designed to improve parenting skills and parent-child interactions.

Without extending the Alma Family Services contract, the County will not have sufficient services to provide continuous services to link children and families with service providers who specialize or are familiar with children with special and unique needs. Services including education on child abuse and prevention and building and strengthening the

bridge with service providers for this population, are important activities that support family relationships and stability. These services promote connections with health and mental health providers to ensure the children's and family's well-being. Services also alleviate problems such as safety concerns and fear of ongoing abuse experienced by these children. This program provides an opportunity to assess the impact of interventions designed to improve parenting skills and parent-child interactions.

The investment in supportive interventions to address educational needs, parenting, and skill building, are integral to the process of healing for families with children with special and unique needs. The program further strengthens the bridge between DCFS, Regional Centers and other specialty service providers working with this population to provide access to highly specialized services that otherwise would be difficult to obtain. This program increases DCFS' and the community's ability to reduce trauma to this population of children and youth.

This Amendment made and entered into by and between the County of Los Angeles, hereinafter referred to as "County" and <u>Alma Family Services</u>, hereinafter referred to as "Contractor." Alma Family Services is located at <u>1000 Corporate Center Drive</u>, <u>Suite 650 Monterey Park</u>, CA 91754.

**WHEREAS**, COUNTY and CONTRACTOR are parties to the Contract and CONTRACTOR has been providing services to the COUNTY;

**WHEREAS**, This Amendment extends the Contract beyond the original contract term effective January 1, 2026 through December 31, 2027, with two optional six-month extension periods through December 31, 2028, as authorized by the COUNTY'S Board of Supervisors on October 7, 2025;

**WHEREAS**, Assembly Bill 2994 County Children's Trust Fund for the purpose of funding child abuse and neglect prevention and intervention programs is available to extend the CONTRACT;

**WHEREAS**, this Amendment is prepared pursuant to the provisions set forth in Part II, Standard Terms and Conditions, Section 7.0, Changes and Amendments; and

**NOW, THEREFORE**, COUNTY and CONTRACTOR agree to amend the Alma Family Services Contract as follows:

- 1. Part I, Unique Terms and Conditions, Section 2.0, Term, Sub-section 2.1, Sub-section 2.1.6 is added as follows:
  - 2.1.6 The Contract term is extended, effective January 1, 2026 through December 31, 2027, with two optional six-month extension periods, to be exercised at the sole option of the County, through December 31, 2028, unless sooner terminated or extended, in whole or in part, as provided in this Contract.
- 2. Part I, Unique Terms and Conditions, Section 3.0, Contract Sum, Sub-section 3.1.7, and 3.1.8 are added as follows:
  - 3.1.7 The Maximum Annual Contract amount for each year is \$300,000. The total Maximum Contract Sum for both years is \$600,000, effective January 1, 2026 through December 31, 2027.
  - 3.1.8 The Maximum Contract amount for each six-month optional extension period is \$150,000. The total Maximum Contract Sum for the two optional six-month extension periods is \$300,000, effective January 1, 2028 through December 31, 2028.

3. Part II, Standard Terms and Conditions, Section 82.0 Survival is deleted in its entirety and replaced with Section 82.0 Campaign Contribution Prohibition Following Final Decision in Contract Proceeding as follows:

#### 1. What is being requested?

The Department of Children and Family Services (DCFS) seeks delegated authority to extend the current Child Abuse Prevention and Early Intervention Program for Developmentally Disabled Children contract with Alma Family Services for Contract Number 10-039-01, effective January 1, 2026 through December 31, 2027, with two optional six-month extension periods through December 31, 2028, to allow sufficient time to initiate and complete the solicitation process required for a new contract execution. The current contract expires on December 31, 2025.

#### 2. Why is the product needed – how will it be used?

Alma Family Services developed a child abuse and neglect prevention/early intervention program that serves children with special and unique needs. For the purposes of this program, special and unique needs include: a developmental delay or disability; mental health diagnosis; learning disability; receiving special education services; or displaying behavioral challenges. The program goals are to provide child abuse prevention/early intervention and specialized case management services for parents and caregivers of children and youth with special and unique needs. The population to be served includes children and youth who are at risk of being, or have been, abused or neglected, and the program seeks to prevent re-victimization. Alma Family Services also works toward building and strengthening the bridge between DCFS staff, Regional Center staff, school districts, county agencies and community service providers.

National research shows that children and adolescents with special and unique needs are known to be vulnerable to abuse and neglect and are likely to be victimized at a much higher rate than other children (4 to 10 times more often). In addition, these children are often inadequately educated and supported to seek alternatives to abusive situations. It is also known that there is often an underreporting of abuse, neglect and victimization for children and adolescents with special and unique needs. Through this program, Alma Family Services is providing important and necessary services to this underserved and highly at-risk group of children.

#### 3. Is this brand of product the only one that meets the user's requirements?

Yes. In 2009, the Child Abuse Prevention and Early Intervention Program for Developmentally Disabled Children was solicited through the Inter-Agency Council on Child Abuse and Neglect's (ICAN's) multi-disciplinary selection process.

The ICAN Policy Committee approved funding for this specialized program. Specialized programs are currently funded in all five (5) supervisorial districts. ICAN works with DCFS Program staff to monitor the effectiveness of the services provided and it has been determined that this program fills a vital need in the County and the services should be expanded and continued.

4. Have other products or vendor been considered?

Yes. Alma Family Services was selected as a vendor by a special Ad Hoc Group formed by ICAN comprised of members from numerous county and city agencies. This Ad Hoc Group held a face-to-face meeting and engaged in an extensive process to vet Alma Family Services' proposal so that any concerns about the program could be addressed, and to reach consensus regarding recommending approval for funding.

The extension of the current contract with Alma Family Services will provide sufficient time for DCFS to initiate and complete the solicitation process.

5. Will purchase of this product avoid other costs?

Alma Family Services was selected as a vendor by a special Ad Hoc Group formed by ICAN comprised of members from numerous county and city agencies. ## NOTICE OF INTENT TO EXTEND THE CHILD ABUSE PREVENTION AND EARLY INTERVENTION PROGRAM FOR DEVELOPMENTALLY DISABLED CHILDREN CONTRACT

In accordance with Board Policy 5.100, Sole Source Contract and Amendments, this is to notify the Board that the Department of Children and Family Services (DCFS) intends to submit a Board letter to request delegated authority to execute Amendment Number Seven to extend the current Child Abuse Prevention and Early Intervention Program for Developmentally Disabled Children Contract Number 10-039-01 with Alma Family Services effective January 1, 2026 through December 31, 2027, with one optional one-year extension period through December 31, 2028.

In compliance with Board Policy 5.100, Sole Source Contracts and Amendments, County departments must provide advance written notice and justification to the Board when the departments do not have delegated authority to extend the term of the current contract beyond its original term.

#### **BACKGROUND**

In 1992, the Governor of California signed into law two bills aimed at preventing and treating child abuse and neglect. The first bill, Assembly Bill (AB) 1733/Papan (Chapter 1398, Statutes of 1982), authorized the allocation of state funding to counties for child abuse prevention and intervention services offered by public and private, non-profit agencies. The second law, AB 2994/(Chapter 1399, Statutes of 1982), established a County Children's Trust Fund for the purpose of funding child abuse and neglect prevention and intervention programs operated by private, non-profit organizations. AB 2994 requires that \$4.00 of any fee for a certified copy of a birth certificate shall be paid

to a County Children's Trust Fund. Both laws provide that a designated multi-disciplinary child abuse council develop and recommend funding priorities to the Board of Supervisors. In Los Angeles County, the designated child abuse council is ICAN.

ICAN engaged in a very serious and lengthy process to review and evaluate the proposal for this program. ICAN formed a special Ad Hoc Group comprised of members from numerous county and city agencies. This Ad Hoc Group held a face-to-face meeting and engaged in an extensive process to vet Alma Family Services proposal so that any concerns about the program could be addressed, and to reach consensus regarding recommending approval for funding. The ICAN Policy Committee approved funding for this specialized program. Specialized programs are currently funded in all five (5) supervisorial districts. ICAN works with DCFS program staff to monitor the effectiveness of the services provided and it has been determined that this program fills a vital need in the County and the services should be expanded and continued.

#### **JUSTIFICATION**

Alma Family Services developed a child abuse and neglect prevention/early intervention program that serves children with special and unique needs. For the purposes of this program, special and unique needs include a developmental delay or disability, mental health diagnosis, learning disability, receiving special education services or displaying behavioral challenges. The program goals are to provide child abuse prevention/early intervention and specialized case management services for parents and caregivers of children and youth with special and unique needs. The focus population includes children and youth who are at risk of or have been abused or neglected. The program also seeks to prevent revictimization. Alma Family Services also supports building and strengthening the bridge between DCFS staff, Regional Center staff, school districts, county agencies and community service providers.

National research shows that children and adolescents with special and unique needs are known to be vulnerable to abuse and neglect and are likely to be victimized at a much higher rate than other children (four to 10 times more often). In addition, these children are often inadequately educated and supported to seek alternatives to abusive situations. It is also known that there is often an underreporting of abuse, neglect and victimization for children and adolescents with special and unique needs. Through this program, Alma Family Services provides important and necessary services to this underserved and highly at-risk group of children.

Alma Family Services' current contract is for \$300,000/year. Services have been provided at four sites. Given that Alma Family Services is one of very few agencies that currently provide case management and parenting classes for caregivers of children with special needs in Los Angeles County, extending the Alma Family Services contract will continue to significantly impact children and families and continue providing important and necessary services to this population.

The recommended extension will enable Alma Family Services to continue providing case management and parenting classes for caregivers of children with special needs in Los Angeles County. Alma Family Services' service delivery model is significantly impactful, and it is important to offer these critical preventive services to this hard-to-reach population.

Without extending the Alma Family Services contract, the County will not have sufficient services to provide continuous services to link children and families with service providers who specialize or are familiar with children with special and unique needs. Services including education on child abuse and prevention and building and strengthening the bridge with service providers for this population are important activities that support family relationships and stability. These services promote connections with health and mental health providers to ensure the well-being of children and families. Services also alleviate problems such as safety concerns and fear of ongoing abuse experienced by these children. This program provides an opportunity to assess the impact of interventions designed to improve parenting skills and parent-child interactions.

The investment in supportive interventions to address educational needs, parenting and skill building are integral to the process of healing for families with children with special and unique needs. The program further strengthens the bridge between DCFS, Regional Centers and other specialty service providers working with this population to provide access to highly specialized services that otherwise would be difficult to obtain. This program increases DCFS' and the community's ability to reduce trauma to this population of youth.

#### **NOTIFICATION TIMELINE**

Consistent with the procedures of the Board Policy 5.100, DCFS is informing the Board of its intent to extend the current contract. DCFS will file a Board letter in the near future to request delegated authority to execute a contract amendment for extension.






# Education Information Sharing for Systems-Involved Youth

- ➤ One of the Education Coordinating Council's <u>Strategic Plan</u> Priority Areas is to improve information sharing and data integration to ensure youth get the education services they need in a timely manner and agencies can make data-driven policy decisions
- > OCP has been convening LACOE and DCFS to determine strategies to address current barriers/gaps to information sharing around education data for systems-involved youth
- Consensus amongst partners is to hire an expert consultant team to complete an independent assessment and provide options/recommendations for a data solution
- > OCP would fund and manage this consultant team; funding request in supplemental budget

## Youth Behavioral Health Convening

- > OCP hosted, in partnership with the Board offices, on June 26
- ➤ Goal: To ensure that County and community partners are aware of the ways that behavioral health policy and funding changes, coupled with health and child welfare reforms, have and will continue to impact children and youth, and to identify action steps for ensuring that children and youth remain a priority in implementation of these policies.
- Action Items:
  - Mapping of Behavioral Health Initiatives
  - > Feedback to the State on Behavioral Health Services Act (BHSA) Prevention funds and guidance on the intersection of multiple initiatives
  - Ensuring County department and community stakeholders' engagement in the BHSA Community Planning Team (CPT) process, and that there's a feedback loop between the BHSA CPT, System of Care, and other collaboratives
  - Further exploring workforce opportunities under BH-CONNECT (new Medi-Cal waiver) to expand peer specialists and navigators, and build career pathways for people with lived expertise; and opportunities to support upstream prevention services

- ➤ November 7, 2023 motion by Supervisor Janice Hahn <u>Maximizing CalAIM's Enhanced</u> Care Management Benefit for Children and Youth Involved in Child Welfare
  - ➤ Understanding Medi-Cal fee-for-service (FFS) vs MCP enrollment for DCFS-involved youth OCP's consultants from HMA completed a <u>retrospective analysis</u> of children in foster care/former foster youth's engagement in services in FFS vs MCP
  - > With DCFS, managed care plans, and two providers, launched an ECM pilot with the DCFS Glendora office
- ➤ May 13, 2025 motion by Supervisors Hilda L. Solis and Janice Hahn <u>Advancing CalAIM</u> <u>Benefits for Transition Age Youth</u>
  - Filed report back with findings and recommendations on August 27
- Providing a multiagency briefing to Cluster in October
