I appreciate the great presentation from Mr. Arnold Chandler. I feel this is so much more than an academic exercise. There are alot of people with lived experience that feel that police don't have to be a part of the prevention process. My own father was murdered by the Police inside of a Church Indiana from excessive force and inappropriate response.

I have lived experience in Family court and DCFS. I had my own child removed from me by police knocking in my door with a battering ram and weapons draw, snatching my child from me while he was screaming "NO NOT MY MOM!" at the tender age of 5, because he thought they were going to kill me. I had always been the Primary Caregiver from his birth. He was snatched from me at gunpoint while I had a two year protection order in place that was ignored by the Family Court

I am honorably retired from the military and still until this day I have never been charged with a crime, never been arrested. I have never drank nor did any drugs. During my experience with Family Court and DCFS I noticed that the Family Court and DCFS never ask people if they are veterans. I have experienced being ordered to take a class and then later those classes that were taken at U.S. Vets, the VA and the UCLA Veterans and Family Wellness Center were completely ignored. It was written in a court order that I didn't take any classes. It was written in a court order that I only had a temporary protection order and that I didn't request an extension which is totally false. There is a push to remove qualified immunity from Police Officers but there also needs to a push to remove immunity from Judges as they too write false reports to cover up the true story.

I had submitted a bill proposal which is now SB 1182 (Eggman) to start identifying military veterans when cases are open with Family Court. This is just a start to change what is happening amongst the veteran community in Family Court as there is so much more to do.







After listening to a meeting for 2 1/2 hours filled with County Workers it's saddening to give the Public 1 minute to speak. How can public trust be gained by only giving them 1 minute to speak. Everyone may not be tech savvy enough to send an email. I encounter people all the time that barely know how to log into a meeting and to compose and send an email may be an even greater challenge to them.

The Board of Supervisors gives 2 minutes or a minute per agenda item during the Public Comment portion.

My mother started beating me at (1yrs old.) Tried to beat me to death at 3yrs old. Beaten almost everyday, for 4yrs straight. At 11yrs old, vowing never to Live with her again. My father, and grandmother raised me. Truly honored to have been her grandson, and my father's son.

I thank the Lord Almighty, for his many blessings. As I've suffered thru so much. Lost everything. Trying my hardest to just be a normal person. I'm not demanding anything. Just respectfully requesting to have this matter resolved quickly, and quietly. PLEASE.

My address is 2003 East 7th Street, Apt#4 long Beach, CA 90804. My phone number is 213-837-8468. I'm just tired of it all. Needing a real break. I'm so grateful to findly be in a place. I could just get comfortable I'm not.

My PTSD, won't allow me to be threatened, bullied, punked, my manhood threatened. I didn't ask for this, I just wanted to see if my groin was torn. This was a retaliation for filling a complaint against a white shirt security officer, of the la county sheriff's department.







Had no idea it would lead to this. I'm not afraid to die. Made peace with my Lord many yrs ago. I've asked only that he not give, not those who seek my down fall, victory over me. I'm trusting the Mayor's office, the board of supervisors, the district attorney, the United States Attorney General, and the Federal authorities, to handle this situation.

I'm staying out of the way. Under the penalty of perjury, I declare that all stated information I've written here is true and correct, to the Best of my knowledge. On this date, the 13th day of July. At 5:07pm.
