6. Chair Scorza provided an overview of Task Force next steps, including an overview of the proposal on the Prevention and Promotion Implementation Team (PPIT) and a summary of members' responses to the recommendation forms circulated in the week prior to the meeting. This included organizing the recommendations into groups based on the level of consensus across member responses, including some recommendations which were removed from consideration because existing authority already exists relating to the action. Members provided overall feedback on the recommendations and this review process.

The Task Force then launched into a discussion regarding six of the recommendations where there was strong consensus among members (Recommendations #1, 3, 12, 13, 16, 19 under the numbering system used during the meeting). Members provided specific comments and proposed line edits to the recommendations to strengthen and clarify the language. ARDI staff publicly screenshared a Word document upon which changes were applied and marked up, so members and the public could see the application of feedback in real-time.

After staff and members applied these proposed edits across the six recommendations with strong consensus, Chair Scorza suggested that the Task Force conduct a consent item vote. Member Ghaly (DHS) called for a motion to adopt the six recommendations. Member Byrd (DMH) seconded the motion. The motion was approved by the following vote:
