The patrons were underneath the picnic shelter when it collapsed.

Briefly describe the root cause(s) of the claim/lawsuit:

- Root Cause 1: The picnic shelter was not in conformity with its original design.
- Root Cause 2: The picnic shelter was at such an advanced age and so weathered that it was no longer able to withstand extreme weather conditions such as high wind.
- Root Cause 3: A lack of departmental picnic shelter observations contributed to the potentially compromised structures.
- Root Cause 4: A lack of formal repair/replace procedures contributed to the potentially compromised structures.

Briefly describe recommended corrective actions: (Include each corrective action, due date, responsible party, and any disciplinary actions if appropriate)

Root cause 1: Repairs, remediation or replacement of any structural components of picnic shelters will not be executed without first consulting with qualified personnel in the Department's Planning and Development agency.

Root cause 2: At risk shelters were identified by field staff and referred to Planning and Development for further review. Shelters that were identified as at risk due to the potential of collapse were removed.

Root cause 3: Picnic structures in the Department will be observed on an annual basis. Any structures deemed too old or unsafe will be removed or replaced.

On April 30, 2015, Riva Higgins, a 49-year-old female, underwent a hysterectomy procedure at Harbor-UCLA Medical Center. During the procedure, a sponge was used to stabilize organs around the surgical site. The sponge caused inflammation and infection and needed to be removed approximately four weeks after the procedure.

Ms. Higgins filed a lawsuit against the County of Los Angeles alleging that the providers were negligent in performing the April 30, 2015 surgery.
