4. Report of actions taken in Closed Session.

At 10:47 a.m., the Claims Board reconvened in open session and reported the actions taken in Closed Session as follows:

**a. Kimberly Bartoli, et al. v. County of Los Angeles, et al.
Los Angeles Superior Court Case No. BC 655 690**

This claim seeks compensation from the Department of Public Works – Water Works District No. 40 for real and personal property damage allegedly caused from a sewage backflow which occurred when the main waterline was being repaired by County employees.

Action Taken:

The Claims Board approved the settlement of this matter in the amount of \$95,000.

b. **Tomas Estarella, et al. v. County of Los Angeles, et al.**
Los Angeles Superior Court Case No. BC 527 749

This lawsuit arises from an alleged dangerous condition in which Plaintiff's vehicle struck a utility pole after colliding with an ambulance.

Action Taken:

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$300,000.

c. **Jasmine Purifoy v. County of Los Angeles**
Los Angeles Superior Court Case No. BC 655 220

This lawsuit concerns allegations made by a former employee of the Office of the Assessor who alleges discrimination and wrongful termination.

Action Taken:

The Claims Board approved the settlement of this matter in the amount of \$32,500.

d. **Stacy Johnson v. County of Los Angeles, et al.**
Los Angeles Superior Court Case No. BC 683 552

This lawsuit concerns allegations made by a former employee of the Department of Public Social Services who claims that the County discriminated against her.

Action Taken:

The Claims Board approved the settlement of this matter in the amount of \$50,000.

e. **Enid Goldenberg v. County of Los Angeles, et al.**
Los Angeles Superior Court Case No. BC 674 920

This lawsuit concerns allegations made by a former employee of the Department of Public Social Services who claims that the County discriminated against her.

Action Taken:

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$600,000.
