NATURE OF CASE

This is a recommendation to settle for \$80,000, inclusive of attorneys' fees and costs, a federal civil rights lawsuit in which Anthony Louis Gallo, Jr. ("Plaintiff") alleges that deputies/custody assistants failed to protect him from an assault by other inmates and deliberately misclassified him for general population housing while at Men's Central Jail ("MCJ"). Specifically, Plaintiff claims jail staff failed to properly treat him as a "K-10" (keep away – protective custody) inmate and allowed the assaulting inmates access to him..

Given the risks and uncertainties of litigation, a reasonable settlement at this time will avoid further litigation costs. The full and final settlement amount of \$80,000 is recommended.

a. Maria Reza v. County of Los Angeles, et al.
United States District Court Case No. 19STCV09463

This wrongful death lawsuit arises out of the shooting of Plaintiff's son by a Sheriff's Deputy.

#### Action Taken:

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$925,000.

# b. <u>Duncan Roy v. County of Los Angeles, et al.</u> United States District Court Case No. 2:12-CV 09012

This federal civil rights class action lawsuit alleges over-detentions arising from the Sheriff's Department's former policy and practice of detaining inmates beyond the expiration of their sentences because of immigration detainers.

## Action Taken:

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$14,000,000.

c. <u>Tui Wright v. County of Los Angeles</u> Los Angeles Superior Court Case No. 19STCV40769

This lawsuit brought by a retired Sheriff's Sergeant alleges that he was subjected to discrimination and retaliation.

The Claims Board approved the settlement of this matter in the amount of \$99,000.
