NATURE OF CASE On December 24, 2016, Plaintiff Matthew

Richardson's sedan collided with a Sheriff's Department SUV in the intersection of Fairfax Avenue and Fountain Avenue in the City of West Hollywood. It is alleged that the Deputy Sheriff driving the SUV caused the collision by running a red light. Plaintiff alleges he sustained bodily injuries, loss of earnings and general damages as a

result of the incident.

Due to the risks and uncertainties of litigation, a full and final settlement of the case in the amount of

\$165,000 is recommended.

Briefly provide a description of the incident/event:	Matthew Richardson v. County of Los Angeles Summary Corrective Action Plan 2020-2023	
	On December 24, 2016, at approximately 9:10 a.m., two on-duty Los Angeles County Sheriff's Department deputy sheriffs, were assigned to patrol at West Hollywood Station. The first deputy sheriff (driver) was driving a marked black and white patrol vehicle (2016 Ford Explorer) south on Fairfax Avenue in West Hollywood when they were involved in a traffic collision.	
	The deputy sheriffs just completed a call for service at 1317 Fairfax Avenue in the city of West Hollywood when they received an additional non-emergent call for service on Melrose Avenue.	
	The first deputy sheriff accelerated approximately 50 feet from the number two lane southbound curb line. The first deputy sheriff observed a southbound green light traffic signal on Fairfax Avenue as he proceeded at approximately 15-25 miles per hour into the intersection. The first deputy sheriff did not see the light had cycled from green to red before entering the intersection.	
	Note: The first deputy sheriff did not have his overhead red lights operating as he entered the intersection. However, he still had the rear yellow directional light bar activated from his previous call for service at 1317 Fairfax Avenue.	
	Simultaneously, the plaintiff was driving at approximately 35 miles per hour, in his 2015 Volkswagen Tiguan eastbound on Fountain Avenue in the number one lane when he entered the intersection. Both drivers were unable to stop or avoid each other, resulting in a traffic collision.	
	The front end of the patrol vehicle collided with the driver's side of the plaintiff's vehicle. The plaintiff's vehicle sustained minor damage to the driver's side front bumper area. The patrol vehicle sustained moderate damage to the passenger front fender.	
	Note: The second deputy sheriff (passenger) had his head down as he was placing his seatbelt on and was looking at some paperwork at the time of the incident and did not see the traffic signal's color.

The plaintiff did not complain of any injuries at the time of the incident. Approximately, two-and-a-half weeks after the accident, on January 10, 2017, the plaintiff sought medical care for the pain in his neck, lower back, and knee due to the incident.

Both deputy sheriffs were wearing their factory-installed seat belts at the time of this incident and were not injured due to the traffic collision.

1. Briefly describe the root cause(s) of the claim/lawsuit:

The **Department** root cause of this incident is the first deputy sheriff failed to stop at a red light and collided into the plaintiff's vehicle who had a green light.

2. Briefly describe recommended corrective actions: (Include each corrective action, due date, responsible party, and any disciplinary actions if appropriate)

Traffic Collision Investigation

This incident was thoroughly investigated by investigators from the West Hollywood Station, Traffic Unit.

The collision investigation concluded the first deputy sheriff caused the collision a he failed to stop at a red light, in violation of California Vehicle Code section 21453(a) CVC.

Administrative Investigation

This incident was investigated by representatives at West Hollywood Station to determine if any administrative misconduct occurred before, during, or after this incident. The results of the investigation were presented for Department executive adjudication.

Executive evaluation of this incident found some of the deputy sheriff's actions were in violation of Department policy. Appropriate administrative action has been taken.

Traffic Collison Assessment Review

As a result of this collision, an assessment of employee-involved traffic collisions was conducted from January 1, 2016, to December 31, 2019, at West Hollywood Station

The audit revealed the following:

In an attempt to improve employee safety and reduce the Department's liability exposure, West Hollywood Station continually schedules personnel to attend the Department's Sheriff Traffic Accident Reduction (S.T.A.R.) driving program. This program focuses on low speed parking and starting maneuvers. The Emergency Vehicle Operations Center (EVOC) traffic simulator replicates driving Code-3 through crowded city conditions and reacting to various introduced hazards.

Since this incident, 15 West Hollywood Station employees have successfully completed the S.T.A.R. driving program and 10 employees have completed the EVOC driving simulator.
