inclusive of attorneys' fees and costs, this federal civil rights lawsuit filed by Jasmine Lopez, Breanna Lopez, Gabriele Lopez, Joseph Lopez, and Cienna L., a minor by and through her guardian ad litem Sonia Trujillo ("Plaintiffs"), against the County arising out of the fatal shooting of Frank Lopez.

Given the risks and uncertainties of litigation, a reasonable settlement at this time will avoid further litigation costs. The full and final settlement of the case in the amount of \$30,000 is recommended.
