Plaintiff may have violated California Vehicle Code Section 29154(a) which requires pedestrians to yield the right-of-way to all vehicles in a marked or unmarked crosswalk at an intersection. Conversely, the Public Works driver may have violated California Vehicle Code Section 21950 (a) which requires vehicles to yield the right-of-way to a pedestrian crossing the roadway within any marked or unmarked crosswalk at an intersection.

The Public Works Automotive Safety Committee reviewed the matter and found the vehicle incident to be Non-Preventable. No further actions contemplated.



- On October 3, 2018, the Plaintiff was assigned to an inmate work crew at the Pitichess Detention Center. The inmate work crew was tasked with moving tree stumps and rounds from one trailer to another.
- While the inmate work crew was in the process of transferring several wood rounds and stumps, the custody assistant crew leader stepped away for a drink of water. As the inmate crew continued to work, the plaintiff's hand became pinned between the side of the trailer and a tree stump.
- Custody staff immediately called paramedics and the Plaintiff was taken to Henry Mayo Newhall Hospital for medical treatment.

The primary **Departmental** root cause in this incident was the failure of custody staff to have direct visual contact of the work being performed to properly ensure every member of the inmate work crew was alert and ready for the movement of the wood logs between trailers.

2. Briefly describe recommended **corrective actions**:

Training

- In an effort to reduce injuries to inmates and staff, custody personnel who supervise inmate work crews attend daily morning briefings. Topics covered at these briefings include how to properly communicate to inmate workers instructions, ensure all inmate workers are familiar with the requested task, and ensure all proper safety protocols are in place before performing any laborious task
- Inmate crew leaders are also briefed on the importance of having proper visual contact on tasks being performed by their inmate work crews.
