#### AUGUST 2, 2021

### 1. Call to Order.

The meeting of the County of Los Angeles Claims Board was called to order at 9:37 a.m. The meeting was held via teleconference with all Claims Board Members participating telephonically. Claims Board Members online for the teleconference meeting were: Chair Steve Robles, Arlene Barrera, and Adrienne Byers.

3. Closed Session – Conference with Legal Counsel – Existing Litigation (Subdivision [a] of Government Code section 54956.9).

At 9:38 a.m., the Chair convened the meeting into closed session to discuss the items listed as 4(a) through 4(g).

#### 4. Report of actions taken in Closed Session.

No members of the public were on the public teleconference phone line to hear the reportable actions of the Claims Board.

At 11:59 a.m., the Claims Board reconvened in open session via the public teleconference phone line and reported the actions taken in closed session as follows:

#### a. <u>Georgia F. Law v. County of Los Angeles, et al.</u> Los Angeles Superior Court Case No. 19STCV37498

This dangerous condition lawsuit arises from injuries allegedly sustained in an alleged trip and fall accident on a street maintained by the Department of Public Works.

#### Action Taken:

The Claims Board approved settlement of this matter in the amount of \$25,000.

### b. <u>Korrie O'Neal v. Jessica Martinez, et al.</u> Los Angeles Superior Court Case No. 20STCV26201

This lawsuit arises from injuries plaintiff allegedly sustained in an automobile accident involving an employee of the Department of Children and Family Services.

#### Action Taken:

The Claims Board approved settlement of this matter in the amount of \$26,640.02.

## c. Long Beach Memorial Medical Center, et al. v. Los Angeles County Department of Health Services

Los Angeles Superior Court Case No. 19STCV04018

This lawsuit against the Department of Health Services alleges breach of contract arising out health care services provided by plaintiff.

#### Action Taken:

The Claims Board approved settlement of this matter in the amount of \$45,000.

#### d. <u>Memorial Health Services v. Los Angeles County Department of Health Services</u> Los Angeles Superior Court Case No. 20LBCV00261

This lawsuit against the Department of Health Services alleges breach of contract arising out of health care services provided by plaintiff.

#### Action Taken:

The Claims Board approved settlement of this matter in the amount of \$50,000.

#### e. <u>Nathan Booker v. County of Los Angeles</u> Los Angeles Superior Court Case No. 20STCV02257

This lawsuit concerns allegations that a Department of Health Services employee was subjected to harassment, discrimination and retaliation.

#### Action Taken:

The Claims Board recommended to the Board of Supervisors settlement of this matter in the amount of \$175,000.

### f. <u>Michael Rathbun, et al. v. County of Los Angeles, et al.</u> Los Angeles Superior Court Case No. BC526951

This lawsuit concerns allegations that a Sheriff's deputy was subjected to retaliation by the Sheriff's Department.

Action Taken:

The Claims Board recommended to the Board of Supervisors settlement of this matter in the amount of \$400,000.

#### g. <u>Danessa Valentine v. County of Los Angeles</u> Los Angeles Superior Court Case No. BC602184

This lawsuit concerns allegations that the Department of Children and Family Services subjected two applicants for employment to discrimination, violation of privacy, and unlawful medical inquiries.

#### Action Taken:

The Claims Board recommended to the Board of Supervisors settlement of this matter in the amount of \$1,250,000.
