Briefly provide a description of the incident/event:	On January 17, 2018, at 4:22 p.m., Lanthia Douglas was traveling southbound on La Cienega Boulevard at Knowlton Street when she was rear-ended by a County vehicle driven by a Public Works Laborer, Road Maintenance Division.

The collision occurred due to the inattentiveness of the Public Works driver when he was distracted by the noise at the rear of his vehicle. When the driver looked ahead he realized he was too close to the rear of Ms. Douglas' vehicle in front of him. The driver applied his brakes, but was unable to avoid rearending Ms. Douglas' vehicle.

The driver appeared before the Department's Automotive Safety Committee on May 10, 2018, to review this matter, and the findings were deemed preventable, with the following cause code: "R"- lack of control due to inattention to driving.

Briefly provide a description of the incident/event:	On January 18, 2018, at approximately 8:00 a.m., Plaintiff, Jeong Jin Cha, claims he sustained a TBI and soft tissue injuries as a result of a collision that occurred at the intersection of Hacienda Boulevard and Glenmark Avenue in Hacienda Heights. While traveling southbound on Hacienda Boulevard, Plaintiff alleges that a street sweeper operated by County of Los Angeles Department of Public Works employee who made an unsafe U-Turn from southbound onto the northbound side of Hacienda Boulevard. While the employee was attempting to make the U-Turn and as he was completing the turn, his street sweeper vehicle was "T-Boned" by Mr. Cha's vehicle on his left-hand driver's side.

1. Briefly describe the **root cause(s)** of the claim/lawsuit:

The collision occurred due to the Public Works employee's negligence in the operation of his vehicle by making an unsafe turning movement in front of Mr. Cha.

The County driver's collission was reveiwed by the Departmental Automotive Safety Committee, which concluded the vehicle incident was preventable. Corrective measures were taken in the form of appropriate discipline.

Briefly provide a description of the incident/event:	On December 5, 2018 at approximately 6:00 a.m., a Pomona Police Department officer (hereinafter "Plaintiff") had exited his personal vehicle in the parking lot on the southwest corner of Park Avenue and 6 <sup>th</sup> Street. The weather conditions at this time were cold, cloudy, and rainy. The roadway was wet, and it was still dark outside.
	Plaintiff approached the crosswalk on the south side of the intersection and activated the pedestrian walk signal. Once the pedestrian signal phase switched to "walk," Plaintiff began to walk eastbound across Park Avenue (south of 6 <sup>th</sup> Street) within the crosswalk. Plaintiff was struck in the crosswalk by a County vehicle being operated by a then-Battalion Chief (BC). In an attempt to avoid the collision, Plaintiff tried to jump out of the way and turned his body to the left. The County vehicle made contact with Plaintiff, Plaintiff rolled off the hood of the County vehicle and fell to the ground.
	The BC stated he was adjusting his eyeglasses and looked down at the radio before he heard a yell and felt an impact to the front of the County vehicle. The BC stated that he was traveling 15-20 mph, the ambulance reports indicate he was traveling 20-30 mph, and the videos provided by Pomona Police Department indicate a higher rate of speed. The County vehicle AVL indicates the BC was traveling from 64 mph, 62 mph, to 20 mph right before impact.
	Plaintiff was transported to the Pomona Valley Hospital Medical Center where he sustained an injury to his nose, three broken ribs, abrasions, facial lacerations and facial fractures, broken teeth, bruising, pain and swelling, shoulder and back pain. Plaintiff missed 11 months of work.

# 1. Briefly describe the root cause(s) of the claim/lawsuit:

The Department root cause in this incident is the BC's failure to stop at a red light.

- 2. Briefly describe recommended corrective actions: (Include each corrective action, due date, responsible party, and any disciplinary actions if appropriate)
  - 1. The Department Safety Officer recommended the following training action plan, which were all completed:
    - Emergency Vehicle Operations Course (4 hours);
    - Search and Scan (2 hours);
    - Hazard Recognition (3 hours);
    - Backing (2 hours);
    - Attention and Distraction (2 hours);
    - Judging Safe Distance (3 hours); and
    - Sight Speed and Space Management (2 hours).
  - 2. An administrative internal investigation was initiated. The BC was ultimately issued a Notice of Suspension for three (3) days, which was served.
