County of Los Angeles</u> Summary Corrective Action Plan 2022-17</p> <p>On Tuesday, October 31, 2017, at approximately 6:40 a.m., an on-duty Los Angeles County Sheriff's Department deputy, assigned to Community Partnerships Bureau, was driving a marked black and white Sheriff's Department Ford Crown Victoria patrol vehicle northbound on Rye Canyon Road when he stopped at a red light at the intersection of Newhall Ranch Road in the city of Santa Clarita.</p> <p>While at the red light, the deputy observed a white Honda hatchback traveling at a high rate of speed (approximately 60-70 miles per hour) eastbound on Newhall Ranch Road. The white Honda then made a left turn northbound onto Copperhill Road, skid, and struck an adjacent curb.</p> <p style="text-align: center;">Note: The city of Santa Clarita posted speed limit for Newhall Ranch Road is 50 miles per hour.</p> <p>After observing the violation of 22350 California Vehicle – "Basic Speed Law" and believing the driver of the Honda was impaired or under the influence, the deputy drove the patrol vehicle into the intersection, on a red light to initiate a traffic stop. Prior to entering the intersection, the deputy activated the overhead emergency lights, however, did not recall if he activated the siren. The deputy cleared the intersection, lane-by-lane, at approximately 10 miles per hour. While clearing the intersection, the plaintiff's vehicle collided into the left rear of the patrol vehicle.</p> <p>The plaintiff was driving a 2015 Dodge Charger, traveling eastbound on Newhall Ranch Road at 55 miles per hour when entering the intersection of Rye Canyon Road on a green light. The plaintiff did not see the black and white Sheriff's vehicle, nor the vehicle's overhead emergency lights.</p> <p>The plaintiff saw the patrol vehicle just before the impact, and she attempted to apply the brakes, however, the vehicle did not stop prior to the collision.</p> <p>The plaintiff's vehicle came to rest, facing southeast in the northeast lanes of the intersection. The plaintiff's vehicle sustained damage to the front end.</p> <p>The deputy's vehicle came to rest, facing east in the number one east lane of Newhall Ranch Road just east of Rye Canyon Road. The deputy's vehicle sustained damage to the left rear quarter panel and trunk area.</p>

	<p>The deputy advised he was involved in a traffic collision and asked for fire department paramedics and a supervisor via the vehicle radio. The deputy checked on the welfare of the plaintiff prior to the arrival of the fire department paramedics and Santa Clarita Sheriff's Station deputies and supervisor.</p> <p>The plaintiff complained of general body soreness and pain to her left knee as a result of the collision. The plaintiff was evaluated by paramedics at the scene and declined transportation to a hospital. The plaintiff was later driven by a friend to the emergency room for medical treatment. The plaintiff was released approximately an hour later, the same day.</p> <p>The deputy complained of pain to his neck and left shoulder as a result of the collision. The deputy was transported via ambulance to the hospital for medical treatment.</p>

1. Briefly describe the **root cause(s)** of the claim/lawsuit:

A **Department** root cause in this incident was the deputy failed to activate the siren when he activated the emergency overhead lights prior to entering the intersection on a red light.

A **Department** root cause in this incident was the deputy failed to yield to oncoming traffic in the intersection.

A **non-Department** root cause was the plaintiff failed to see the patrol vehicle with its overhead emergency lights activated prior to the plaintiff entering the intersection.

2. Briefly describe recommended corrective actions:

Traffic Collision Investigation

The incident was thoroughly investigated by the Santa Clarita Sheriff's Station. The collision investigation concluded, the deputy caused the collision by failing to yield – 21804 (a) California Vehicle Code to oncoming traffic prior to entering the intersection on a red light.

Supervisor's Report of Incident or Damage to County Vehicle

The incident was investigated by representatives of the Community Partnerships Bureau to determine if any administrative misconduct occurred as a result of the traffic collision. The results of the investigation were presented for Department executive adjudication. Appropriately administrative actions were taken.

Traffic Collision Assessment and Review

Community Partnerships Bureau conducted a review and assessment of all traffic collisions for calendar year 2017 through the end of 2021. The audit revealed there were 110 total collisions for this four-year period, 58 of which were classified as preventable, and 52 classified as non-preventable.

During the audit, it was discovered there was a spike in 2017, with a progressive reduction in the following years.

Personnel who have been involved in more than one traffic collision are directed to attend Department training, such as the Sheriff's Traffic Accident Reduction (S.T.A.R.) driving program, Emergency Vehicle Operations training, and/or the Alternatives to Discipline Driving Course.

The primary **Department** root cause in this incident was the possible criminal misconduct committed by members of the Los Angeles County Sheriff's Department.

Criminal and Administrative Action

Once Department executives became aware of the allegations, a criminal investigation was opened into the incident. Several Department members were named as suspects and relieved of duty pending the outcome of the criminal investigation.

As a result of this incident, Department executives have recognized the importance of supervisors engaging their staff on a shift by shift basis. Supervisors have been briefed and encouraged to make several unannounced visits to inmate housing areas under their supervision in an effort to ensure staff are following all policies and procedures.

Briefly provide a description of the incident/event:	<p><u>Mika Marvin Lamar O'Neal v. County of Los Angeles, et al.</u> Summary Corrective Action Plan 2021-44</p> <p>On February 1, 2019, at approximately 8:00 a.m., an on duty Los Angeles County Sheriff's Department deputy sheriff (driver), assigned to Court Services Transportation Bureau, was driving a marked black and white Los Angeles County Sheriff's Department bus (Braun) passenger transportation vehicle. The deputy sheriff as required inspected the vehicle which included a brake check prior to departing the transportation compound. The deputy sheriff was traveling southbound in the number one lane, on the 5 freeway north of Carmenita Road. The deputy sheriff was traveling at approximately 25 miles per hour when he was involved in a traffic collision.</p> <p>Note: On January 31, 2019, a vehicle maintenance check was conducted by a Los Angeles County Sheriff's Department fleet mechanic. The brakes were inspected and found to be within compliance during the vehicle maintenance process.</p> <p>The deputy sheriff (driver) and the second deputy sheriff (security deputy) transported sixteen inmates, including the plaintiff. The plaintiff was chained at the wrists to another inmate and seated in the middle sitting section of the Braun. The plaintiff was being transported from Court Services Transportation Bureau to Orange County.</p> <p>The deputy sheriff was traveling on the 5 freeway into the morning sun and reached up to adjust the sun visor down to block the sun glare. While the deputy sheriff was adjusting the sun visor, the freeway traffic came to a stop. The deputy sheriff applied the brakes but could not stop in time to avoid a collision. The front of the vehicle (vehicle one) collided into the rear of vehicle two (black, 2020 4-door, Audi), which pushed into the rear of vehicle three (white, 2015, 4-door, Honda). Afterward, all the deputy sheriffs and the parties involved moved their respective cars out of the traffic lanes onto the center median.</p> <p>Vehicle one sustained minor damage to the front bumper and grills. Vehicles two and three sustained minor damage to the trunk of their vehicles.</p> <p>The driver in vehicle two complained of pain to his shoulder and neck and was transported to the hospital for medical treatment and released. The driver and passenger in vehicle three did not complain of any injuries on scene.</p>

<p>A Department root cause of this incident is the deputy sheriff failed to stop before colliding with vehicle two, which led to a chain reaction collision.</p> <p>A Department root cause in this incident was the deputy sheriff was inattentive while driving by looking up to put down his sun visor, which caused him to collide with vehicle two.</p> <p>A Department root cause in this incident was the deputy sheriff was traveling at an unsafe speed, causing him to be unable to stop prior to colliding with vehicle two.</p> <p>Another Department root cause in this incident was the Braun was not equipped with seatbelts to secure the inmates during transport.</p>

2. Briefly describe recommended corrective actions:

<p>Traffic Collision Investigation This incident was investigated by representatives from the Court Services Transportation Bureau and California Highway Patrol, at the Santa Fe Springs area office. The deputy sheriff was distracted while driving and failed to slow down or stop prior to colliding into the vehicle in front of him.</p> <p>Training The supervisor re-briefed the deputy sheriff and personnel regarding inattention and driving speed.</p> <p>Traffic Collision and Assessment and Review As a result of this collision, Court Services Transportation Bureau conducted a review an assessment of employees involved traffic collisions from January 1, 2017, to December 31, 2021. The audit revealed the following:</p>

Based on the audit, a traffic reduction-risk management plan was developed.

- 123 preventable collisions occurred during the past five years.
- 79% of preventable collisions involved fixed objects or parked vehicles during low speed, parking, or starting maneuvers.
- The most common causal factor was misjudgment of measurement.

In an attempt to improve employee safety and reduce the Department's liability exposure, Court Services Transportation Bureau Training Office continually schedules on-going unit training.

Vehicle Inspection

The vehicle driven by the deputy was retrofitted to transport multiple inmates. This special customization allowed inmate to be transported while sitting on seats, as well as wheelchairs. The seating area is not equipped with seatbelts.

The Court Services Transportation Bureau is currently in discussions with the Department's Fleet Coordinator regarding seatbelts as an available option when transporting inmates in the back seat.




