Briefly provide a description of the incident/event:	In October 2019, Juan Jose Quijivix ("Mr. Quijivix") underwent a surgical procedure at LAC+USC Medical Center ("LAC+USC") whereby a mass was removed from his toe. The mass was sent to pathology; it was determined that the mass contained cancerous cells. LAC+USC staff sent a letter to Mr. Quijivix requesting that he return to LAC+USC for further work up and treatment. Mr. Quijivix did not appear for a follow up visit, and LAC+USC staff could not reach him.  In August 2020. Mr. Quijivix began his cancer treatment. The County disclosed the matter to Mr. Quijivix, helped him to complete a claim form, and agreed to recommend the proposed settlement.
