Briefly provide a description of the incident/event:	<p>Reginaldo Guzman-Serrato underwent a laparoscopic surgical procedure at High Desert Regional Health Center (HDRHC). The procedure caused accidental bleeding requiring conversion to an open surgery. The bleeding continued and it became apparent that Mr. Guzman required a higher level of care. Mr. Guzman was transported to the Antelope Valley Hospital, a non-County facility near HDRHC, where the bleeding was controlled. Four days later, Mr. Guzman was discharged home in stable condition.</p> <p>Upon re-examination of the case, HDRHC administration determined that the bleeding could have been avoided. The staff reached out to Mr. Guzman, explained the error, offered an apology, and confirmed that the County was willing to compensate him for his injuries. The County also paid for out-of-pocket expenses incurred by Mr. Guzman.</p>

1. Briefly describe the root cause(s) of the claim/lawsuit:

- At the start of the procedure, the surgeon recognized that this surgery carried a higher risk of intra-operative complications.
- Certain surgical equipment useful to control bleeding had not been requested to be prepared prior to the surgery.
- Some OR Team members were not familiar with items and equipment needed to respond to the surgical complications.
- Too many staff members entered the OR when the procedure was converted from laparoscopic to open.


2. Briefly describe recommended corrective actions:



- The surgeon was counseled regarding his decision to proceed with the surgery when he first recognized that this surgery carried a higher risk of intra-operative complications.
- The surgeon was counseled regarding the need to ensure appropriate items were prepared for these procedures.
- The involved surgeons and OR staff members attended an in-service training to ensure understanding and use of equipment that would be helpful in responding to complications in this type of surgery and were also reminded not to enter the OR unless they are called in to assist. Additionally, the Ambulatory Care Network (A.C.N.) started implementation of TeamSTEPPS intended to improve communication among A.C.N. staff members.
- Process is in place to ensure that equipment needed to address complications with this type of surgery is readily available.
- Quarterly hands-on refresher drills on set up of equipment will be conducted.
