NATURE OF CASE	This dangerous condition of public property lawsuit arose when Oliver Maldonado ("ePlaintiff") was injured when struck by a minivan driven by defendant Jesus Gonzalez (not a County employee) while Plaintiff crossed Meyer Road on his bicycle, at Fidel Avenue, in the unincorporated area of the County known as South Whittier. Plaintiff alleges Meyer Road, at the accident location, represents a dangerous condition of public property. Plaintiff claims to have suffered injuries and damages from the accident. Due to the risks and uncertainties of litigation, a full and final settlement of the case is warranted.

Date of incident/event:	April 18, 2018
Briefly provide a description of the incident/event:	On April 18, 2018, 13-year-old Oliver Maldonado was riding his bicycle northbound on the wrong side of Fidel Street when he entered the intersection with Meyer Road and his bicycle was struck by a vehicle driven by Jesus Gonzalez, traveling eastbound on Meyer Road. Subsequent to the collision, Mr. Gonzalez fled the scene on foot but was later apprehended. As a result of the collision, Oliver Maldonado sustained severe injuries.

1. Briefly describe the **root cause(s)** of the claim/lawsuit:

The collision occurred due to Oliver Maldonado's negligence in the operation of his bicycle at night and the driver's inebriated condition.

According to the Traffic Collision Report, Oliver Maldonado caused the collision by riding his bicycle in violation of VC 21650.1; which states: "A bicycle operated on a roadway, or the shoulder of a highway, shall be operated in the same direction as vehicles are required to be driven upon the roadway."

Mr. Jesus Gonzalez was also in violation of the Vehicle Codes:

2001(a) – "Felony hit and run causing great bodily injury to another person."

23152(a) – "Misdemeanor driving while under the influence of an alcoholic beverage."

16028(c) – "Infraction failure to provide evidence of financial responsibility at the scene of the traffic collision."

2. Briefly describe recommended corrective actions:

Traffic Safety and Mobility Division reviewed the subject location as part of their January 2018 Traffic Engineering Report:

Highly visible "Yield Here to Pedestrian" signs and corresponding yield line pavement markings were installed in each direction of Meyer Road ten days prior to the collision, near the existing marked crosswalk and the intersection with Fidel Avenue. The signs were added to the Maintenance Management Inventory on March 29, 2018.

The installation of pedestrian-actuated flashing beacons for the existing marked crosswalk at the intersection of Meyer Road and Fidel Avenue was completed on January 23, 2019, and accepted for maintenance on February 13, 2019.
