Paying court-ordered child support is among the most basic and important responsibilities of a non-custodial parent. A parent who is able to pay child support and, without lawful excuse, fails to do so may be guilty under: Penal Code Section 270 [Failure to Provide], Penal Code Section 166(a)(4) [Contempt of Court] or Code of Civil Procedure Sections 1209 & 1218 [Contempt of Court]

Danillo "Danny" Tartabull Sr.

Amount Owed \$276,204.93

On January 24, 2011, Mr. Tartabull entered a plea of no contest to Penal Code Section 166(a)(4) for failing to support his two sons. He failed to comply with the terms of his probation and on May 2, 2012, he was ordered to surrender and serve 180 days in county jail. Mr. Tartabull failed to appear and the court issued a **warrant for his arrest** with bail set at \$200,000. Mr. Tartabull is a former star baseball player.



Michael David Crockett

Amount Owed \$54,550.74

On August 30, 2012, contempt of court charges were filed against Mr. Crockett for failing to pay court-ordered child support. The case was opened in 2009. Since that time, Mr. Crockett made one payment in May 2011. Mr. Crockett is an attorney.

Amount Owed \$121,091.35

On November 15, 2012, contempt of court charges were filed against Mr. Lewis for failing to pay court-ordered child support. He was personally served with the charges on December 12, 2012 and when he failed to appear on March 7, 2013, a **warrant was issued for his arrest**. Mr. Lewis is known online as the "Lead Pastor" for a church in Long Beach.



Randolph Everett Lowe

Amount Owed \$65,833.55

On September 21, 2012, contempt of court charges were filed against Mr. Lowe for failing to pay court-ordered child support. He was personally served with the charges on October 5, 2012 and when he failed to appear on December 13, 2012, a **warrant was issued for his arrest**. Mr. Lowe has owned a mini-market for approximately 20 years.



Gerald Thomas Hightower

Amount Owed \$84,702.17

On May 4, 2010, Mr. Hightower entered a plea of no contest to Penal Code section 166(a)(4) for failing to support his daughter. On October 15, 2010, he admitted that he was in violation of his probation and agreed to new probation terms. When he failed to appear on December 13, 2011, a **warrant was issued for his arrest**. Mr. Hightower is known online as a pastor, relationship counselor and motivational speaker.

On January 15, 2013, contempt of court charges were filed against Mr. Shahpoor for failing to pay court-ordered child support. He was personally served with the charges on February 6, 2013 and when he failed to appear on June 6, 2013, a **warrant was issued for his arrest**. Mr. Shahpoor is believed to be in the high end auto sales business.

On September 3, 2008, Mr. Chinchilla entered a plea of no contest to Penal Code section 166(a)(4) for failing to support his daughter. On September 20, 2011, he admitted that he was in violation of his probation and agreed to new probation terms. Mr. Chinchilla failed to appear on April 25, 2012 and **a warrant was issued for his arrest**. He is believed to be an experienced bill collector.
