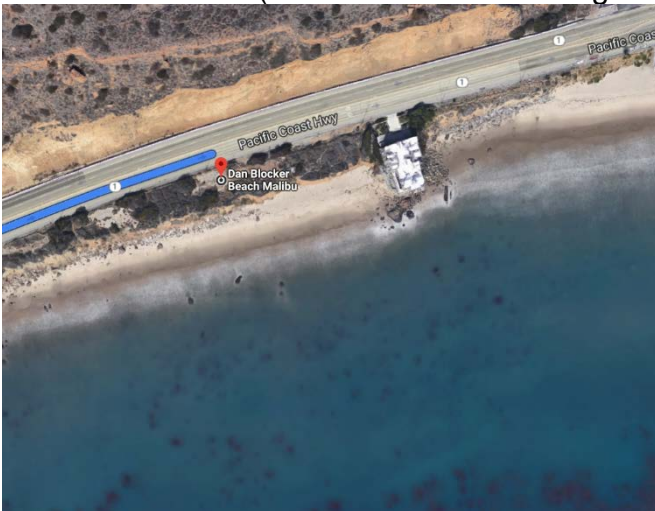
Stop #4 Zuma Beach – 5 minutes

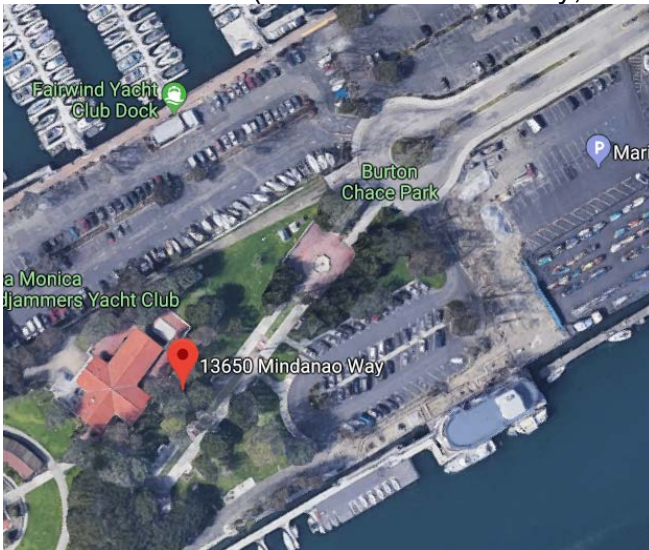


Stop #6 Gladstones / Will Rogers Parking Lot – 15 minutes

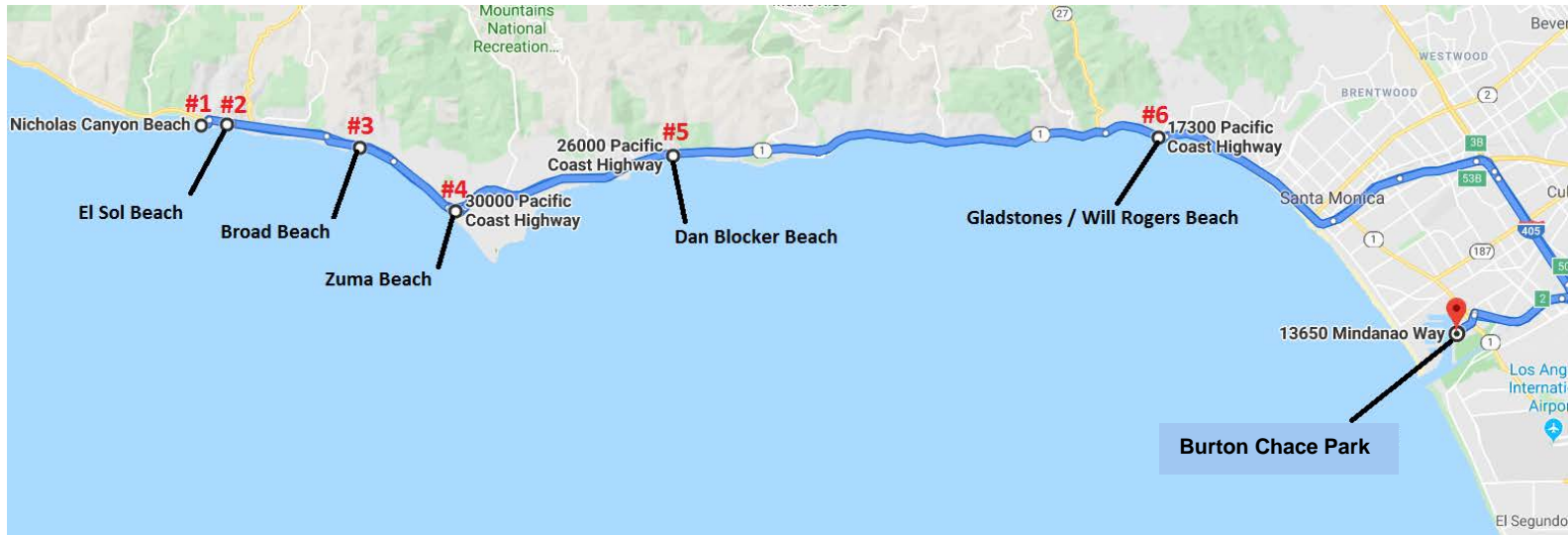
