1. CALL TO ORDER, LAND ACKNOWLEDGEMENT AND PLEDGE OF ALLEGIANCE

Chair Damon Nagami called the meeting to order at 9:41 a.m. and read the Land Acknowledgement. At Chair Nagami's request, Commissioner Kurt Weideman led Commissioners in reciting the Pledge of Allegiance.

2. APPROVAL OF MINUTES

Chair Nagami requested a motion to approve the January 24, 2024, and February 22, 2024, minutes. Commissioner Weideman so moved; Commissioner Teresa Furey seconded the motion.

The minutes were approved.

3. OLD BUSINESS

A. ELECTION AND INSTALLATION OF VICE CHAIR

Commissioner Weideman moved to nominate Commissioner Judith Meister for the Vice Chair position of the Beach Commission; Commissioner Rosi Dagit seconded the motion.

The motion carried.

Vice Chair Meister thanked the Commissioners for their vote of confidence and said she was happy to serve as Vice Chair.

B. COASTAL RESILIENCY UPDATE AND ADVOCACY LETTER

Deputy Director Carol Baker introduced Department of Beaches and Harbors Planning Division Chief Warren Ontiveros to provide an update on the Department's coastal resiliency efforts. Mr. Ontiveros said the Department completed the final report for its Coastal Resiliency Plan and reported to the Los Angeles County Board of Supervisors twice. He said the Department is applying to the California Governor's Office of Planning and Research for a planning grant that would advance the feasibility, early design and permitting of the coastal resiliency projects identified in the 2023 report. He also noted one large stakeholder meeting was held, and he said additional meetings will be held with stakeholders and partners to discuss work product, outreach, further grants and permitting.

Commissioner Madelyn Glickfeld raised concerns about the number and effectiveness of the existing sand dunes and their replenishment costs.

Vice Chair Meister asked why the dune restoration projects seemed far from the shore at Zuma Beach in the proposed plans. Mr. Ontiveros explained that seasonal erosion greatly narrows Zuma Beach, and he encouraged Commissioners to visit the Trancas and Westward stretches of Zuma Beach to see how erosion narrowed the areas for themselves. He said the restoration plan for Zuma Beach calls for bringing in enough sand to widen the beaches by 25 feet. He also noted the dune projects will be completed in phases.

Chair Nagami asked when the next feasibility and concept design phase update would be presented to the Commission. Mr. Ontiveros said the next update would be in about nine months. Chair Nagami recommended Commissioners review the handout on the subject that was included in the agenda packet.

Chair Nagami also asked if Commissioners had any input or questions regarding the letter supporting the Department's efforts regarding coastal resiliency and pursuing funding resources before it is sent to the Board.

Commissioner Dagit moved to send the letter to the Board. Commissioner Michael Bustamante seconded the motion.

Commissioner Glickfeld asked that the letter emphasize the percentage amount of budget cuts. Ms. Baker said that would be checked and added into the letter.

Chair Nagami asked for approval of the letter, including Commissioner Glickfeld's addendum.

C. CAN THE TRASH! CLEAN BEACH POSTER CONTEST

Program Manager II Joan Hernandez provided an update on the *Can the Trash!* Clean Beach Poster Contest. He said the Department received 437 entries, surpassing 2023's entries of 331. He attributed the increase in submissions to personal outreach to teachers and specialized staff, along with a focus on individual schools. He showed a few of this year's winning posters, which will be displayed on beach trash barrels.

Mr. Hernandez also said the Department partnered with Heal the Bay to host a Kids Earth Day Beach Cleanup at the Dockweiler Youth Center on April 13, 2024.

D. D.E.I. WORKGROUP

Chair Nagami explained that the Diversity, Equity, and Inclusion (DEI) Workgroup provides an opportunity for a small group of Commissioners to meet informally with Department staff quarterly or on an as-needed basis. He welcomed Commissioners Michael Bustamante and Shannon Ross to the group. Chair Nagami said there had been discussions about developing the Equity-Based Beach Use Permitting Policy as part of the Department's "Beaches for All" initiative. He said the policy aims to increase beach access and recreational opportunities, especially among marginalized communities, through the issuance of beach use permits.

Ms. Baker said lack of transportation and not knowing how to swim are significant issues within marginalized communities. She also said the Department's Russell Walker WATER Program helps youth experience the coast, including those who live within five miles of the beach but have never visited.

4. NEW BUSINESS

A. MARINE MAMMAL CARE CENTER

Ms. Baker welcomed John Warner, CEO of the Marine Mammal Care Center (MMCC) located in San Pedro, California. Mr. Warner's presentation provided background on the center, which is responsible for marine animal rescues and stranding response along the Los Angeles County coast. The MMCC treated thousands of sea lions suffering from domoic acid toxicity during the summer of 2023. Mr. Warner discussed the MMCC's financial situation, research, rehabilitation and community outreach. He also shared success stories of animals who were rescued and returned to the ocean.

Commissioner Bustamante asked if U.S. Rep. Robert Garcia, who represents Long Beach, had been contacted regarding funding for the MMCC. He also asked for information on volunteering at the center. Mr. Warner said the congressional delegation in California is very supportive of increased funding and recommended going to the MMCC's website to learn more about volunteering.

Commissioner Meister asked if the MMCC had relationships with coastal cities for additional funding. Mr. Warner said the MMCC uses a fee-for-services model with cities, rather than relying on donations from municipalities.

5. STAFF REPORTS

A. ONGOING ACTIVITIES REPORT

Ms. Baker submitted the report and noted the concession license agreements for beaches operated by the County, which were approved by the Commission, went to the Board for approval.

B. BEACH SPECIAL EVENTS/ACTIVITIES

Community and Marketing Services Division Chief Catrina Love said the Dockweiler Youth Center had been open to the public for over a year, and bird watching, shore fishing, Zumba and yoga classes have resumed. She highlighted upcoming programming at Burton Chace Park, including Marina Culture Jam sessions and the Marina del Rey Summer Concert Series.

C. BEACH PROJECTS REPORT

Operational Services Division Chief Ken Foreman submitted the report and announced the Department was in the process of hiring maintenance workers for the summer.

Chair Nagami announced that this would be Mr. Foreman's final Beach Commission meeting as he was retiring.

Mr. Foreman said he was retiring after spending most of 39 years of County service with the Department. He said he enjoyed working with all the Commissioners and planned on staying in contact with Department staff.

Department of Beaches and Harbors Director Gary Jones said the Department was sorry to see Mr. Foreman retire, but wished him the best after his distinguished, lengthy career.

D. LIFEGUARD REPORT

Lifeguard Section Chief Daniel Murphy said two Ocean Lifeguard academies were currently under way, with graduation set for June. Chief Murphy said lifeguards expect the Junior Lifeguard Program to have about 4,000 children enrolled this summer.

Commissioner Bustamante asked how the Junior Lifeguard Program's registration system works. Chief Murphy said the current program's application period was over; however, the information for next year's program will be posted on social media throughout the fall, and program applications will open in the winter. Four-week sessions are held in June and July.

6. COMMISSIONER COMMENTS

Commissioner Shannon Ross said some families are concerned about rusted equipment at White Point Beach. Ms. Baker said the Department is already addressing the issues.

Commissioner Dagit announced that the grunion are running. She encouraged anyone who hasn't experienced a grunion run to visit the beach in the evening during high tide.

7. COMMUNICATION FROM THE PUBLIC

Mr. Lee Barr addressed the Commission about the Los Angeles County Code's prohibition on flying motorized aircraft, including drones, over any beach. He would like the Department to establish an area on the beach where he can fly his drone.

8. ADJOURNMENT / NEXT MEETING DATE & LOCATION

SUBJECT: ITEM 3C – TOPANGA LAGOON RESTORATION

California State Parks, Caltrans, Los Angeles County Department of Beaches and Harbors and the Resource Conservation District of the Santa Monica Mountains are working to restore the Topanga Lagoon ecosystem, one of the last coastal wetlands in Southern California. Despite shrinking from 30 acres to only about a half-acre, lagoon is a natural filtration system, stormwater buffer, and home to rare and endangered species, and its associated beach sees more than one million visitors annually. The Topanga Lagoon Restoration project aims to preserve and expand the area's biological, cultural and recreational resources.

The Final Environmental Impact Report has been released for public review until August 13, 2024 and a summary of findings will be presented. The preferred hybrid alternative has been selected and a public zoom meeting to discuss the selection of the alternative will be held on August 5 from 6-8pm.

Speaker: Rosi Dagit, Principal Conservation Biologist, Resource Conservation District of the Santa Monica Mountains

Principal Conservation Biologist Rosi Dagit has been working to conserve nature's resources throughout the Santa Monica Mountains since 1987. Ms. Dagit has served as the Principal Investigator or Lead Scientist for a variety of long-term research and monitoring projects, including those concerning the federally endangered steelhead trout and tidewater gobies. Prior to coordinating the planning and grant funding for the Topanga Lagoon Restoration Project, she was instrumental in creating the Topanga Creek Watershed Committee, where she served as coordinator from 1998 – 2003, and her



expertise in strategic resource planning and implementation resulted in the restoration of Lower Topanga Creek by removal of the Rodeo Grounds Berm in 2008.

As technical advisor and editor, she helped develop a multitude of conservation management plans for the Topanga Creek watershed and L.A. County's oak and native trees, as well as a rapid response plan for invasive beetles in the Santa Monica Mountains. Ms. Dagit currently serves as a technical advisor to the California Oak Foundation and the Caltrans Fish Passage Advisory Committee Leadership Action Team. She has served on the Los Angeles County Beach Commission since 1996.

SUBJECT: ITEM 4A – NEW BEACH CERTIFICATION PROGRAM

The Beach Ecology Coalition, a 501(c)(3) nonprofit organization that aims to balance natural resource conservation and recreational use at beaches by providing educational outreach for beach management. The group, which includes beach managers and maintenance staff, lifeguards, coastal ecologists and engineers, aquarium staff and marine biologists, among others, is developing a basic curriculum for certification and continuing education in beach ecology. The program will teach beach workers on topics such as ecology, local species, seasonal beach changes, climate change, cultural and spiritual beach uses, and more.

Speaker: Karen Martin, PhD

Dr. Martin has lived in Los Angeles for 40 years. She earned a doctorate in biology at UCLA, completed a Friday Harbor Post-Doctoral Fellowship at the University of Washington, and is Distinguished Professor Emeritus at Pepperdine University in Malibu. She has published over 60 papers and three scholarly books on coastal fish physiology and beach ecology. She co-founded the Grunion Greeters, a group of community scientist volunteers that have monitored grunion runs for the past two decades. She works with the Beach Ecology Coalition to improve beach management and coastal resilience in southern California.

SUBJECT: **ITEM 5A - ONGOING ACTIVITIES REPORT**

BOARD ACTIONS ON ITEMS RELATING TO BEACHES

On May 7, 2024, the Los Angeles County Board of Supervisors, waived the \$9 per vehicle parking fee for 60 vehicles for two days for a total amount of \$1,080, excluding the cost of liability insurance, at the parking lot located at 2100 Ocean Front Walk, for participants of the Women's Lifeguard Prep Academy event, held on May 18 and 19, 2024.

On May 21, 2024, the Board waived the \$250 beach use permit fee, the \$933.90 gross receipts fee, and the \$15 per vehicle parking fee for 30 vehicles, in the amount of \$450, excluding the cost of liability insurance, at Will Rogers State Beach, for the 37th Annual Los Angeles Black Pride Beach Party hosted by Los Angeles Black Pride on June 29, 2024.

Also on May 21, 2024, the Board approved and authorized the Director of Beaches and Harbors to execute a contract with Hornblower Yachts, LLC, for the provision of WaterBus service during the summer months for community events for residents of, and visitors to Marina del Rey, for a three-year term, with three one-year extension options, commencing on June 21, 2024 through June 20, 2027, at an annual contract amount of \$1,392,200, for a total maximum amount of \$9,188,520 over the potential total term of six years, which is inclusive of an additional 10% annually for unforeseen services, with sufficient funding included in the Department of Beaches and Harbors' Operating Budget to cover the cost; found that the proposed action is not subject to the California Environmental Quality Act; and authorized the Director to take the following actions:



Prepare and execute contract amendments to extend the contract for three additional one-year optional renewals, if, in the opinion of the Director, Hornblower Yachts, LLC has effectively performed the services during the previous contract period and the services are still needed and required;

Increase the contract amount by up to an additional 10% in any year of the contract, including any extension option period, for any additional or unforeseen services within the scope of this contract, subject to the availability of funds in the Department's operating budget; and

Approve and execute change orders and amendments to incorporate necessary changes within the scope of work, execute amendments should the contracting entity merge, be acquired or otherwise change entities, and suspend or terminate the contract if, in the opinion of the Director, it is in the best interest of the County.

Also on May 21, 2024, the Board waived parking fees in an amount not to exceed \$33,975 for 25 vehicles, where the total fee includes the \$6 Winter Season rate per space on 78 regular weekdays, \$8 per space rate on five County holidays, the \$9 Summer Season rate on 86 regular weekdays, and the \$18 per space on four County holidays, excluding the cost of liability insurance, at the Rose Avenue parking lot located at 300 Ocean Front Walk, for the Departments of Mental Health and Health Services, the Los Angeles Homeless Services Authority, Venice Community Clinics, and St. Joseph's Center staff parking for the Venice Ocean Front Walk Homeless Outreach Pilot Program, held Monday through Friday from May 3, 2024, through December 31, 2024.

On June 4, 2024, the Board approved and instructed the Chair to execute an amendment to the Second Amended and Restated Lease for Parcel 125-R Marina del Rey Small Craft Harbor, as amended, which will provide for a revised rent schedule for the remainder of the Lease term and establish a payment schedule to fund, in part, infrastructure and capital improvements needed on the Marina City Club leasehold facilities, and Memorandum of Lease;

Authorized the Director of Beaches and Harbors, on behalf of the County, to execute and deliver such other ancillary documentation, including without limitation, a ground lease estoppel certificate and the Memorandum of Lease, as is acceptable to the Director relating to the implementation of the Amendment;

Authorized the Director to execute and deliver, on behalf of the County, any required amendment to the Master Sublease or any other documents

relating to the prior and future conversion of Category B units to Category A units; and

Found that the proposed actions are exempt from the California Environmental Quality Act.

Also on June 4, 2024, the Board revised a recommendation, instructing the Executive Director of Racial Equity to consult with each County Department, and any other parties that the Director deems appropriate, to review the Final Report of the California Task Force to Study and Develop Reparation Proposals for African Americans and report back to the Board in writing within 120 days with the following:

Actions that each County Department can take or initiate within the six months following the report back to provide reparations to County residents consistent with the Report including, but not limited to, residents of the class that the Report recommends should be eligible for cumulative compensation ("Community of Eligibility Residents"); and

Proposed language for a Board resolution that acknowledges and apologizes to African Americans and their descendants on behalf of the County and the County's role in structural racism, acts of violence, and other such harms, including but not limited to those described in the Report, and recommits the County to ending the ongoing harms resulting from these past actions, with the resolution to do the following:

Be developed using a robust community engagement strategy and, in consultation with the affected communities, including individuals with lived experience, and established or recognized experts in civil rights, racial justice, history, and other relevant fields;

Recognize and affirm the County's responsibility for all harms and atrocities it has committed its active participation and facilitation of chattel slavery and its enduring legacy, from which the systemic structures of racism and discrimination have come to exist; and

Commit to additional specific County actions that restore dignity and repair harm of affected peoples; and

Instructed the Executive Director of Racial Equity to report back to the Board in writing within 180 days on potential additional County actions to provide reparations consistent with the Report, incorporating best practices from other local, State, Federal and international efforts including, but not limited to, the following:

Establishing a framework for a policy to prioritize housing for descendants of those who were displaced from their homes in the County;

A framework for financial restitution to individuals who have suffered particular injuries;

A study of best practices in providing monetary reparations with recommendations on a sustainable source of funding, including a review of current or future specialized taxes, Federal, State, and local grants, and philanthropic sources;

Targeted support for economic empowerment and wealth-building, including technical assistance to access grant and loan funding for those who have been harmed, and waived permitting fees for Black-owned businesses; and

Assessment of all County services or facilities for which a fee is charged and identification of which may be appropriate to waive;

Instructed the Executive Director of Racial Equity, in collaboration with the Center for Strategic Partnerships, to identify and pursue philanthropic resources to support the work set forth in the above directives;

Adopt the findings of the Report (pages 16 and 17), in support of its recommendations for reparations, and further, find that extending access to Community of Eligibility Residents to County assets from which they historically have been excluded, which advances the County's commitment to addressing racial discrimination by government, serves a direct and substantial public purpose; and

Instructed the Directors of the Natural History Museum, the Los Angeles County Museum of Art, Beaches and Harbors, and other relevant Department Heads, in coordination with the Executive Director of Racial Equity, to provide free access for one day on or about, and in celebration of, Juneteenth 2024, to appropriate facilities, such as museums and beach parking, for Community of Eligibility Residents who self-attest to their eligibility in writing and register with the County for formal confirmation of eligibility through a future local or State-run process.

On June 25, 2024, the Board waived the \$250 permit fee and the \$1,350 gross receipts fees, excluding the cost of liability insurance, at Torrance Beach, for the 18th Annual

South Bay Dozen Lifeguard Competition hosted by the Jimmy Miller Memorial Foundation on July 6, 2024.

On July 9, 2024, the Board waived \$4,000 in parking fees for up to 500 vehicles, excluding the cost of liability insurance, at the Dockweiler Youth Center parking lot for participants of the Ocean Lifeguard Candidate Swim at Dockweiler State Beach, hosted by the County Fire Department, to be held on October 12, 2024.

Item 5C on your agenda provides the Commission with a summary of the Department's beach projects that exceed \$50,000 and are being planned, designed, or under construction.

SUPERVISORIAL DISTRICT 3

- Zuma Beach – Renovate restrooms (#2, #3, #4, #5, #6, #7, #8, and #9) – estimated cost \$9,689,000.
- Zuma Beach Maintenance Yard – Installation of electric vehicle supply equipment for fleet vehicles.
- Blue Flag Update - Awarded Blue Flag eco-award for the second year in a row at Westward Beach.
- Point Dume Whale Watching Area – Refurbishment of accessway - estimated cost \$1,000,000.
- Topanga Beach – Installation of electric vehicle supply equipment.
- Will Rogers Beach – Installation of electric vehicle supply equipment.
- Venice Beach – Maintenance yard renovation (\$1,846,000) and Lifeguard Headquarters. demolition (\$1,000,000) – total estimated cost \$2,846,000.

SUPERVISORIAL DISTRICT 2

- Marina Del Rey Marina – USACE maintenance dredging – estimated cost \$8,500,000.
- Dockweiler Beach – Installation of electric vehicle supply equipment.
- Redondo Beach – Replace Avenue A access ramp – estimated cost \$6,800,000.
- Redondo Beach – Installation of electric vehicle supply equipment.

SUPERVISORIAL DISTRICT 4

- Torrance Beach – Beach concession rehabilitation – estimated cost \$963,000.
- Torrance Beach – Installation of electric vehicle supply equipment.
- White Point Park – Refurbishment of existing park – estimated cost \$4,000,000.



SUPERVISORIAL DISTRICT 3

Zuma Beach Restrooms Renovation (#2, #4, #5, #6, #7, #8, and #9) – \$9,689,000

The project includes deferred maintenance structural repair, building accessibility improvements, replacing plumbing, electrical, and new exterior, and interior finishes.

Status: Restroom #2 expected completion by Labor Day 2024. Restrooms #3, #4, & #6 have been completed. Restrooms #5 and #7 were signed off by Inspector of Record. Restrooms #8 and 9 to follow. Project completion is anticipated by December 2024.

Zuma Beach Maintenance Yard Fleet EVSE Project

The project includes installation of EVSE for six fleet vehicles within the Zuma Beach Maintenance Yard, utilizing SCE's Charge Ready Transport Program funding. Under the SCE Charge Ready Transport Program, SCE designs, constructs, and installs the necessary infrastructure on both the utility-side and customer-side of the electric meter.

Status: The project is in the design phase and utility company coordination phase.

Blue Flag Update

For the second year in a row, the Department has been awarded the Blue Flag eco-award for the portion of Zuma Beach commonly referred to as Westward Beach. The flag will be flown during the Blue Flag summer season from May 1, 2024 to September 30, 2024. Blue Flag is a voluntary international eco-award program for beaches, marinas, and tourism boats, which promotes environmental education and information, environmental management, safety and services, social responsibility, and responsible tourism.

Point Dume Whale Watching Area– \$1,000,000

The project includes refurbishing the existing whale watching area with improvements to the access trail. Scope of work will include improvements to the access steps.

Status: Coordinating with consultant and California Conservation Corp. design and implementation.

Topanga Beach EVSE Project

The project includes installation of EVSE for twenty-two vehicles within the existing parking lot, utilizing SCE's Charge Ready 2 Program funding.

Status: SCE has obtained the required jurisdictional permits and awarded a construction contract for the project. A preconstruction meeting is being scheduled for late July 2024 and construction is expected to commence shortly thereafter.

Will Rogers Maintenance Yard Fleet EVSE Project

The project includes installation of EVSE for four fleet vehicles within the Will Rogers Maintenance Yard, utilizing funds provided by ISD through the County's Energy Efficiency Projects Master Agreement budget.

Status: The project is in the design phase and utility company coordination phase.

**Venice Beach Maintenance Yard Renovation and Lifeguard Headquarters Demolition–
\$2,846,000**

The project includes the demolition of the existing lifeguard tower, roof repairs, and general improvements to the maintenance yard. The removal of the tower and subsequent improvements to the maintenance yard will be done in two phases. Phase I will remove the tower and repair the roof structure, with an estimated cost of \$1,000,000. Phase II will include refurbishing the maintenance building and yard, with an estimated cost of \$1,846,000.

Status: Plans for Phase I were approved by Building and Safety in August 2020. The Coastal Development Permit waiver was cleared at the Coastal Commission's public meeting on July 14, 2022. The Venice Neighborhood Council and local residences recently voiced concerns with the demolition of the facility's upper level. DBH engaged a consultant firm to perform an updated assessment of the Lifeguard Tower to determine its condition. The resulting report was received in June 2024 and is currently being reviewed internally.

SUPERVISORIAL DISTRICT 2

Marina del Rey Marina, USACE Maintenance Dredging – \$8,500,000

Marina del Rey main channel dredging will address sediment that has accumulated in the harbor entrance and main channel. Maintenance dredging was last conducted in 2012. In addition to over a decade of accumulated sediment, the recent storm seasons, king tides, and huge surf have caused extreme shoaling of sediment at the harbor entrance and main channel.

Status: Project complete, USACE anticipates conducting the next dredge event in 2027-2028.

Dockweiler Maintenance Yard Fleet EVSE Project

The project includes installation of EVSE for four fleet vehicles within the Dockweiler Maintenance Yard, utilizing funding provided by ISD through the County's Energy Efficiency Projects Master Agreement budget.

Status: The project is in the design phase and utility company coordination phase.

Redondo Beach Avenue 'A' Access Ramp – \$6,800,000

The project consists of designing, permitting, and construction of an ADA-accessible replacement pedestrian access ramp to Redondo Beach from Esplanade at Avenue A.

Status: The existing ramp was closed in November 2021 after the County's consultant engineer concluded that the ramp was in deteriorating condition. DBH is engaging an Environmental Consulting firm to prepare an initial study for the project. Projected construction anticipated to start mid-2025.

Redondo Beach Warehouse Fleet EVSE Project

The project includes installation of EVSE for six fleet vehicles within the Redondo Beach Warehouse parking lot, utilizing SCE's Charge Ready Transport Program funding.

Status: The project is in the design phase and utility company coordination phase.

SUPERVISORIAL DISTRICT 4

Torrance Beach Concession Building Rehabilitation – \$963,000

The project includes general rehabilitation of the existing building by replacing flat roofing; repairing and replacing roof rafter hangers at four corners of hip roof and repairing broken clay tile pieces; HVAC and exhaust equipment replacement; patching stucco at rear of building; and repainting the patch stucco to match exterior.

Status: In April 2024, ISD has started the construction on the repairs.

Torrance Beach Electric Vehicle Supply Equipment

The project includes installation of EVSE for 50 vehicles within the existing parking lot, utilizing SCE's Charge Ready 2 Program funding.

Status: SCE provided final designs for the project, and SCE is moving forward with obtaining the required permits for the project.

White Point Park Improvement Project - \$4,000,000

The site improvement project will upgrade the irrigation system, existing landscaping, entry park monument sign, children's play area, and picnic and seating areas. Provide new fitness equipment, an ocean overlook, interpretive signage, improvements to meet the Americans with Disabilities Act standards.

Status: On July 9th, staff presented final design and sign package to SD4 and will present to Beach Commission on July 24th.
