

1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Vice Chair Kruger called the meeting to order at 9:35 a.m. Vice Chair Kruger asked Commissioner Powell to lead the Pledge of Allegiance. The Commissioners and staff stood and recited the Pledge of Allegiance.

Vice Chair Kruger introduced the new appointee by Supervisor Knabe, Commissioner Mitch Ward, to the Commission.

2. APPROVAL OF MINUTES

Vice Chair Kruger asked if there was a motion to approve the minutes. **Motion to approve by Commissioner Woodell, seconded by Commissioner Jennings, and unanimously approved.**

Vice Chair Kruger suggested new business be discussed first since there are a number of guests and presenters at the meeting. There were no objections.

3. OLD BUSINESS

A. Proposed Subcommittee/Task Force

Commissioner Bronowski suggested continuing this item to the next meeting since a majority of the Commissioners had left.

4. NEW BUSINESS

A. Healthy Design/Blue Zones Project

Ms. Baker introduces Jean Armbruster, from the Los Angeles County Public Health Department, who leads the Healthy Design effort, and Dr. Lisa Santora, from the Beach Cities Health District that provides extremely innovative funding for health-related programming in Hermosa Beach, Redondo Beach and Manhattan Beach. Ms. Armbruster presented a PowerPoint presentation and discussed the County's effort to promote healthy living with the collaboration from all county departments working as a Healthy Design workgroup developing policies and a demonstration project. Dr. Santora presented a PowerPoint presentation on the Blue Zone project that is based on communities around the world that have measurably improved the health and wellbeing of residents. Commissioner Barnes inquired about designated bike access routes across the county and plans for implementation of signage. Ms. Armbruster responded there is a Master Bicycle Plan in process. Vice Chair Kruger suggested staff discuss with outside agencies, particularly State Parks and the Santa Monica Mountain Conservancy, about what can be done together and provide an update at a future meeting on public transportation. Commissioner Milam suggests having the Los Angeles and South Bay Bicycle Coalition come to present. Ms. Baker stated the next step is to have a discussion and presentation on the bike path. Mr. Kelly stated it is a good idea to have a County Master Bike Plan summary presentation provided to the Commission. Vice Chair Kruger thanked both speakers for presenting.

B. Fire Rings

Vice Chair Kruger asked staff to provide a report first. Ms. Baker stated that there have been complaints in Orange County, especially in Newport Beach, from residents who live close to the fire rings. The AQMD is the air quality regulatory body for the area of Orange County, Los Angeles County, and the Inland Empire. AQMD is viewing this as a public health and environmental matter and has proposed banning beach fire rings. The Commission was given AQMD reports on the subject to review. Ms. Baker stated that the fire rings at Dockweiler are discussed in the AQMD staff reports, but the main AQMD focus is fire rings in Orange County. Since the AQMD is the regulatory body for air quality for this region, whatever decision the governing board makes could impact the fire rings here. Ms. Baker stated both staff from the AQMD and the opposing parties were invited to come and provide a presentation, but only one side, the fire ring ban opponents, is here today. Mike Bone, President of

the Huntington Beach Marketing and Visitor's Bureau gave his presentation and asked the Commission to support and recommend to the Board of Supervisors that this is a matter of local control. During the Commissioners' discussion, Commissioner Sachs pointed out the information provided on an AQMD PowerPoint slide was taken off the AQMD website but is not clear. Vice Chair Kruger asked if the Commission wanted to entertain a motion or look into obtaining further information. Commissioner Powell proposed a motion to recommend to the Board of Supervisors that they oppose the AQMD proposed ban on fire rings, **seconded by Commissioner Milam**. Commissioner Bronowski moved to amend the motion **to recommend the Board of Supervisor oppose the Amendment Rule 444 to cover fire rings as currently proposed or urge the South Coast Air Quality Management District to do further studies and further community outreach and make a formal presentation to the County on the impact. A voice vote was taken, and the motioned failed.**

Commissioner Dupont moved **for a motion to formally invite the AQMD to the next meeting of this Commission, and to instruct staff to obtain from AQMD all background information from the studies that staff has already obtained particular to Dockweiler Beach, and that AQMD be asked to make a formal presentation by PowerPoint or otherwise at the very next meeting, specifically to discuss their proposal for amending Rule 444. Commissioner Dagit asked to have their process be presented. Commissioner Ward would like to include any studies they have that would address the use of clean burning wood, seconded by Commissioner Sachs. A voice vote was taken and the motion carried.**

Vice Chair Kruger had to excuse herself and asked Commissioner Bronowski to continue to chair the meeting.

A. Ongoing Activities Report

Ms. Baker again welcomed Commissioner Mitch Ward, who was appointed on April 16th by the Board of Supervisors.

B. Beach and Marina del Rey Special Events

Ms. Baker informed the Commissioners about the Farmers' Market and the Beach Eats! gourmet food truck events at Marina "Mother's" Beach.

C. Facilities and Property Maintenance Division Report

Mr. Zimmerman gave an update on the various projects that were reported on at last month's meeting. He informed the Commissioners that the parking lot at Point Dume is being repaired with the completion date of September and that a new waterline has been put in. He also mentioned the three beach work crew shifts that allow for maintaining the restrooms in the summer have started.

D. Capital Projects Status Report

Ms. Miyamoto provided an update to Commissioners on items that have been updated since the mail out of the meeting materials. The construction at Will Rogers Coastline commenced on May 20, 2013. Staff is currently working on obtaining a Coastal Development Permit at the Coastal Commission's June meeting to use the dirt parking lot and west side of Topanga Creek for staging. She also reported the Third District Board Office is satisfied with the decision to remove the ramp and refurbish the stairs and access way at the easterly part of Dan Blocker Beach. She also mentioned that the American Shore and Beach Preservation Association awarded a Venice Beach nourishment project one of the best nourished beaches project of the year award and that the award will be presented at their next meeting in Washington DC.

6. COMMISSIONER COMMENTS

Commissioner Woodell stated that years ago the fence located at the El Sol Beach on the upland end of the three-parcel beach disappeared. He would like staff to check the site and, if the fence is not there, put it back up. Mr. Kelly responded that City of Malibu has taken enforcement action at that site. The County is holding enforcement action pending the city's resolution of how they are going to remove structures and vegetation planted without a permit, and restore the fence that was illegally removed.

SUBJECT: **AGENDA ITEM 3A – SOUTH COAST AIR QUALITY MANAGEMENT DISTRICT PROPOSAL TO RESTRICT BEACH FIRE RINGS; CONSIDERATION OF A RELATED BEACH COMMISSION RECOMMENDATION TO THE BOARD OF SUPERVISORS**

BACKGROUND:

The South Coast Air Quality Management District (SCAQMD), this region's air quality regulatory authority, recently revised its proposed restrictions on fire rings on beaches in Los Angeles and Orange counties. Rather than prohibit rings entirely, as had been the agency's proposal when originally considered by this Commission last month, SCAQMD staff now proposes imposing buffer zones that would eliminate or reduce the amount of fire ring smoke exposure to any nearby residents. A key provision of the new proposed restrictions – one that exempts beach bonfires more than 700 feet from residences – would allow fire rings to remain as currently configured at Dockweiler State Beach, which is operated by the Department.

The only other Los Angeles County beach that would be impacted by the SCAQMD's new proposed restrictions would be Cabrillo Beach in San Pedro, which is operated by the City of Los Angeles. According to an SCAQMD staff report, two or more of the half-dozen rings at Cabrillo Beach in San Pedro would need to be moved because they are less than 700 feet from residences.

Prior to the SCAQMD's release of its revised rules, the Los Angeles County Board of Supervisors voted to oppose the agency's initially proposed ban on fire rings. On a motion from Fourth District Supervisor Don Knabe, the Board expressed its support for fire rings as a low cost form of beach recreation and urged that the use of fire rings on beaches be left to the local control of jurisdictions in charge of those beaches.

At the May 22, 2013 Beach Commission meeting, Commissioners voted to direct staff to formally invite SCAQMD staff to present information to the Commission about proposed restrictions on fire rings and studies cited in SCAQMD reports and on its website linking fire rings to particulate pollution and a variety of health risks. The attached letter from Beach Commission Chair Cathy McCurdy was sent to the SCAQMD, communicating the Commission's request for further information and an SCAQMD staff presentation at this meeting.

DISCUSSION:

The SCAQMD's proposed new restrictions apparently aim to balance the interest of Orange County residents who had complained about constant exposure to smoke from fire rings near their homes and members of the public who oppose a complete ban on the popular fire rings, iconic symbols of Southern California beach culture. The new restrictions, for example, allow Newport Beach to eliminate fire rings in areas proximate to residences, as requested in a localized petition to the Coastal Commission to allow for a ban of rings near that city's Corona del Mar neighborhood. But as with the rings at Dockweiler Beach, the buffer zone restrictions also allow for the popular fire rings at Huntington Beach and at other Orange County beaches to remain entirely as configured or at least in some fashion, contingent on their proximity to residences.

Key elements of the newly proposed SCAQMD fire beach ring rules are as follows:

- Cities/counties may declare fire pits a public nuisance, which would eliminate fire pit devices in their jurisdiction under the proposed amendments.
- Cities/counties may retain fire pits that are: (1) more than 700 feet from the nearest residence; or (2) are at least 100 feet apart from each other; or (3) at least 50 feet apart from one another, if there are no more than 15 devices within the cities' boundaries.
- No burn days when the PM2.5 Air Quality Index is forecast for coastal areas to be 100 or more (this has only occurred one time in the last three years).
- A change in "beach burning" definition to restrict beach burning to fire rings specifically located on the sand.

Additionally, the following provisions are included in the SCAQMD staff recommendation:

- A cooperative city/county/SCAQMD demonstration for propane/natural gas fire pits for beach burning, funded by SCAQMD.
- A cooperative city/county/SCAQMD education program regarding the proper materials to burn in beach fire pits, and advice regarding the best time to exercise in the area surrounding fire pits.

- Enhanced public education regarding the harmful health effects of exposure to wood smoke health effects, especially as relates to sensitive individuals such as asthmatics.

SCAQMD staff presented the revised fire ring restrictions to its Board of Governors in an initial public hearing earlier this month. Additionally, the SCAQMD recently held public consultation meetings in Newport Beach and in El Segundo, at which staff presented the revised restrictions and results of smoke monitoring at beaches with fire rings. Commissioner Wayne Powell and Department staff attended the meeting in El Segundo. The SCAQMD's governing board is expected to vote on the new rules at its meeting on July 12, 2013.

COMMISSION PRESENTATION:

In response to the Beach Commission's letter requesting further information on fire ring restrictions, smoke monitoring results and other issues related to beach burning, Dr. Philip Fine, the SCAQMD's Assistant Deputy Executive Officer, has agreed to address the Commission and make a presentation.

Dr. Fine leads SCAQMD groups responsible for conducting ambient monitoring, source testing and laboratory analysis. He oversees the SCAQMD ambient network of over 35 air monitoring stations, the SCAQMD laboratory, and numerous special air monitoring projects focusing on air toxics and the local impacts of air pollution. His previous responsibilities at the SCAQMD have included developing the Air Quality Management Plan, strategies for particulate matter control, climate and energy, meteorology and forecasting, air quality evaluation, emissions reporting, and air toxics risk assessment. Dr. Fine serves as SCAQMD's member for the California Air Resources Board's legislatively mandated Research Screening Committee.

Prior to joining the SCAQMD, Dr. Fine was a Research Assistant Professor at the University of Southern California, Los Angeles where he taught courses and conducted extensive research on particulate pollution and its health effects, resulting in over 45 peer-reviewed scientific publications. He received his Ph.D. from California Institute of Technology in Environmental Engineering Science, and his bachelor's degree in Mechanical Engineering and Materials Science & Engineering from the University of California, Berkeley.

Item 5D on your agenda provides the Commission with a status report on the Department's four beach capital projects and other projects of interest.

CAPITAL PROJECTS

(1) Will Rogers State Beach – Coastline Drive Development

The project includes: reconstruction of the parking lot; construction of an engineered seawall and slope; removal of the existing wooden pilings to below grade; construction of a view deck and ADA-compliant beach access ramp; and landscaping, irrigation and security lighting improvements.

Status: Construction began on May 20, 2013. Substantial completion expected by August 2014. As required by the regulatory permits, grunion monitoring has begun at the site and will continue through the end of August 2013, and then starting again April 2013 through August 2014. One of the requirements of the U.S. Army Corps of Engineers' permit is to provide an additional Essential Fish Habitat survey. Field work for this survey was conducted on Friday June 14, 2013.

On June 17, Granite Construction Company began construction of a temporary cofferdam on the beach to allow for construction of the seawall. Construction of the seawall will take about six months.

(2) Dan Blocker Beach-West Improvement Project

The project involves the development of an unimproved westerly portion of this beach site, all of which will be ADA-complaint and includes a small paved parking lot;

restrooms; bluff top trail; benches and picnic facilities with protective railings; new perimeter fencing; and bluff top and slope native planting, with minimal irrigation for erosion control.

Status: The Department of Public Works' (DPW) consultant, TranSystems, is revising the construction documents to remove the ADA access ramp from the project. Once completed, these will be submitted to the City along with responses to the City's comments on the coastal development permit application. DPW expects to have all documents submitted to the City in mid July 2013.

(3) Beach Restroom Septic System Replacement Program

This program consists of replacing septic systems and leach fields at 16 County operated beach locations in the Topanga and Malibu areas. Each project includes the removal of existing septic pumps and tanks and installation of an advanced treatment septic system, including pumps, tanks, telemetry monitoring system, filter pods, and leach field.

Status: Replacement of the septic systems at Zuma restrooms Nos. 2, 7, 8 and 9 will begin after the summer season.

(4) Surfrider Beach Tank Preservation

The abandoned saltwater concrete tank was uncovered during the storms of 2004-05. This project is to leave the tank in place on the beach. The tank will be filled with slurry to prevent collapse, sealed, and covered with beach sand.

Status: The Board Letter to adopt the Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program, and approve budget and capital project has been prepared. The Board Letter is expected to go before the Board on July 30, 2013. Construction targeted for September 2013.

Zuma Beach Underpass

The City of Malibu has tentatively scheduled a hearing date of July 15, 2013 for the Coastal Development Permit (CDP) application submitted by Beaches and Harbors in October 2012. Beaches and Harbors and Public Works are working together to submit the permit application to the California Department of Fish and Wildlife.
