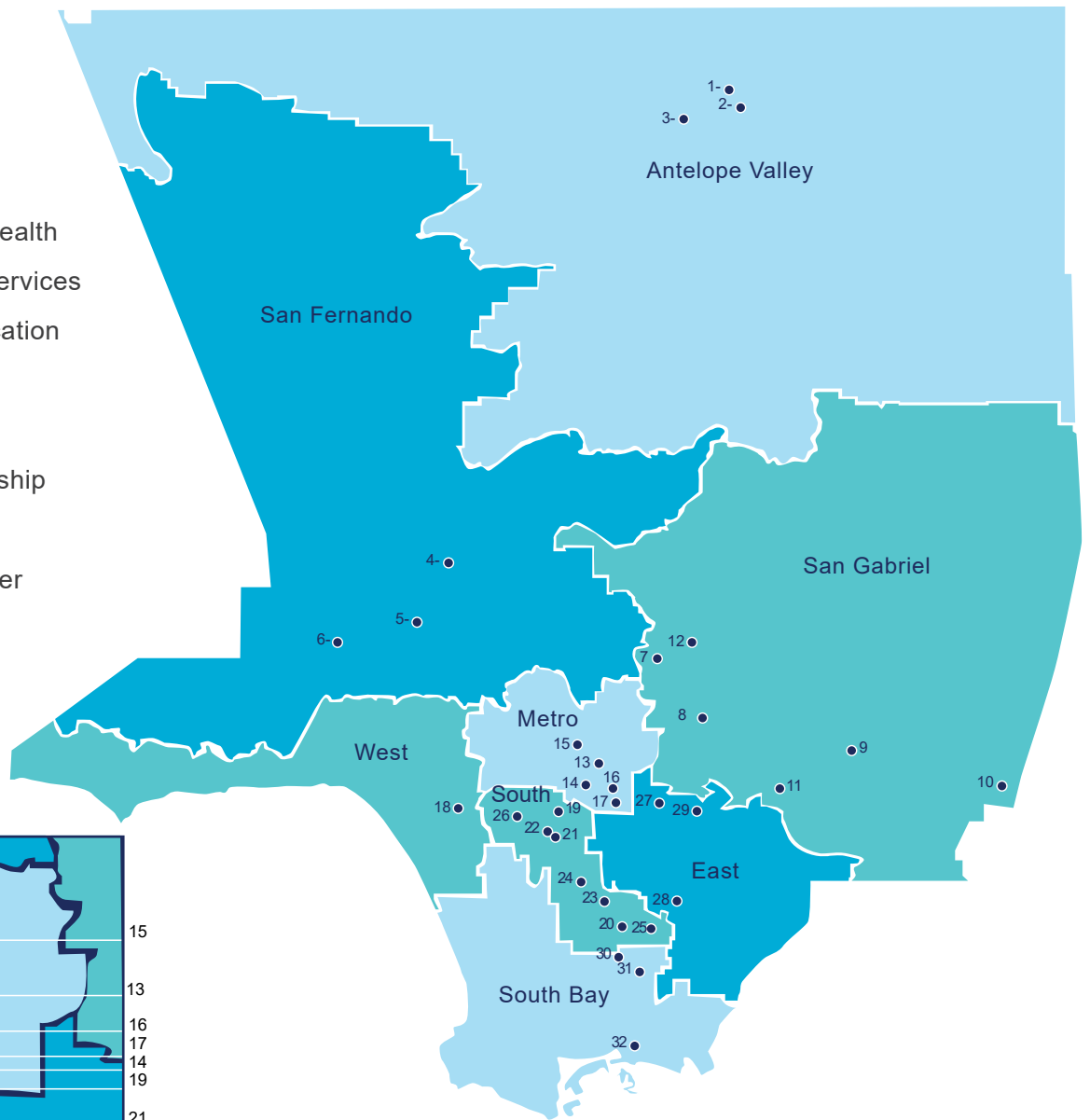


Reentry Intensive Case Management Services
