Organizational Provider's Manual Updates: Included ICD-10-CM Diagnoses

The Organizational Provider's Manual has been updated to reflect additions to the "Outpatient and Day Services 'Included' ICD-10-CM Diagnoses" and "Inpatient 'Included' ICD-10-CM Diagnoses". These updates correspond to the Department of Health Care Services (DHCS) Info Notice 17-004 (ICD-10 Included Code Sets). The changes to the included ICD-10-CM diagnosis codes identified in the Info Notice fall into two categories:

1. ICD-10-CM diagnosis codes that were inadvertently left off the original October 1, 2015 list of included diagnoses;
2. ICD-10-CM diagnosis codes recently released by the Centers for Medicare and Medicaid Services (CMS) that were effective October 1, 2016.

Newly Added Outpatient & Inpatient Included Diagnoses Effective October 1, 2015:

F20.89	Other Schizophrenia
F31.0	Bipolar Disorder, current episode hypomanic
F43.29	Adjustment Disorder with other symptoms
F90.8	Attention Deficit/Hyperactivity Disorder, other type
F91.8	Other Conduct Disorder

F34.81	Disruptive Mood Dysregulation Disorder
