The Department of Mental Health’s (DMH) Legal Entity (LE) Agreement will have a revised Financial Summary for fiscal year (FY) 2017-18. The Financial Summary will consolidate several Funded Programs/Subprograms for Mental Health Services Act (MHSA) related services and Psychiatric Emergency Services (PES) Relief Plan with DMH Mental Health Services (CGF).

The attached document provides a side by side comparison, or crosswalk, of the changes from the FY 2016-17 Financial Summary to the FY 2017-18 Financial Summary for the affected Funded Programs/Subprograms. The document also includes the FY 2016-17 and the FY 2017-18 IS Plans, Integrated Behavioral Health Information System (IBHIS) Funding Source ID, IBHIS Plan ID, and the IBHIS Plan Name. These new Funded Programs, plans, IDs, and names can be used to configure your system for the claiming of FY 2017-18 mental health services. The Provider Authorizations (P-Auths) for the LE Providers in IBHIS will be provided, as normal, upon adoption of the required actions by the Board of Supervisors.

Claims submitted in FY 2017-18 for FY 2016-17 services, should follow the FY 2016-17 LE Agreement Financial Summary and FY 2016-17 IS Plans, IBHIS Fund Source ID, IBHIS Plan ID, IBHIS Plan Name and P-Auths.

DMH will survey the LE Providers to get a sense of the time needed to set up their respective claiming systems. The Department is eager to implement these changes for the start of the new fiscal year and will work with LE Providers accordingly.
