**DEPARTMENT OF MENTAL HEALTH: APPROVAL TO FURTHER IMPLEMENT THE
MENTAL HEALTH SERVICES ACT – COMMUNITY SERVICES AND SUPPORTS
PLAN THROUGH THE TRANSFORMATION OF SERVICES
BY CONTRACT AGENCIES
(ALL SUPERVISORIAL DISTRICTS)
(3 VOTES)**

SUBJECT

Request approval to amend agreements with 62 agencies reflecting their transformation and/or expansion to further implement the Mental Health Services Act-Community Services and Supports Plan.

IT IS RECOMMENDED THAT YOUR BOARD:

1. Approve and authorize the Department of Mental Health (DMH or Department) to allow contract agencies meeting specified criteria the opportunity to provide Mental Health Services Act (MHSA) services through transformation to new and/or expanded MHSA programs as DMH moves from its traditional core mental health programs to a new recovery and wellness-based system of care.
2. Approve and instruct the Director of Mental Health, or his designee, to proceed with the preparation, signing, and execution of amendments, substantially similar to Attachment I, to DMH Legal Entity (LE) Service Agreements (Agreement) with 62 contract agencies (Attachment II) that have been identified

for County General Fund (CGF) curtailments and given the opportunity to deliver transformed services as part of the MHSA Community Services and Supports (CSS) Plan, effective upon Board approval through June 30, 2009. The Maximum Contract Amounts (MCAs) of the 62 contract agencies will remain unchanged by the curtailment and the compensatory transformative actions.

3. Delegate authority to the Director of Mental Health, or his designee, to prepare, sign, and execute future amendments to the Agreement and establish as a new MCA the aggregate of the original Agreement and all amendments, provided that: 1) the County's total payment to the contractor under this Agreement for FY 2008-09 shall not exceed an increase of 20 percent from the applicable revised MCA; 2) any such increase shall be used to provide additional services or reflect program and/or policy changes; 3) the Board of Supervisors has appropriated sufficient funds for all changes; 4) approval of County Counsel and the Chief Executive Officer (CEO), or their designee, is obtained prior to any such Amendment; 5) the parties may, by written Amendment, reduce programs or services and revise the applicable MCA; and 6) the Director of Mental Health shall notify the CEO's office after execution of the Amendment.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS

Consistent with the Board motion of February 12, 2008, Board approval is being requested to use MHSA funding for the delivery of transformed and/or expanded MHSA services by 62 LE contract agencies. These providers are subject to CGF curtailments, and potentially commensurate service reductions, as a result of the Department's deficit mitigation plan. MHSA transformation and/or expansion opportunities were offered to: 1) contract agencies who had under \$20,000 in curtailments and were already delivering MHSA services, and 2) contract agencies who had over \$20,000 in curtailments, and will allow these eligible contract agencies an opportunity to provide substantially different recovery and wellness-based services to hard-to-reach clients who have traditionally been unserved, underserved, or inappropriately served through traditional mental health programs.

Implementation of Strategic Plan Goals

The recommended Board actions support Goal 7, "Health and Mental Health" of the County Strategic Plan by improving mental health outcomes and implementing a recovery and wellness-based service delivery system.

FISCAL IMPACT/FINANCING

The transformation of traditional mental health services to recovery-oriented services for people who are diagnosed with severe and persistent mental illness is consistent with the use of the State Proposition 63 MHPSA funds.

The Department is requesting to allow the 62 LE contract agencies to transform and/or expand traditional mental health services to recovery-oriented services up to the amount of their CGF curtailment in FY 2008-09. These providers are subject to CGF curtailments, and potentially commensurate service reductions, as a result of the Department's deficit mitigation plan. The Department will use unspent FY 2007-08 MHPSA CSS Plan funds available from implementation delays in the directly operated and LE contract agencies CSS programs. The MCAs of the 62 contract agencies will remain unchanged by the curtailment and the offsetting transformation actions.

These amendments reduce net County cost in order to meet the Department's deficit mitigation targets.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Due to the Department's deficit mitigation plan, which was necessary due to a number of factors, including lower than projected Vehicle License Fee collections in FY 2006-07 and unchanged realignment funding, DMH is planning to undertake service and budget reductions. At the same time the Department anticipates receiving millions of MHPSA service dollars. As a result, the Department could experience simultaneous reductions in core mental health programs with concurrent growth in other programs, primarily MHPSA-funded programs. Therefore, approval of the recommended actions will allow DMH and its network of contract agencies to mitigate the impact of the FY 2008-09 budget deficit on core mental health services and to reflect the transformation and delivery of new MHPSA recovery and wellness based services.

The Amendment format has been approved as to form by County Counsel. The CEO has reviewed the proposed actions. Clinical and administrative staff of DMH will administer and supervise the agreements, evaluate programs to ensure that quality services are being provided to clients, and ensure that the LE Agreement provisions and DMH policies are being followed.

CONTRACTING PROCESS

All of the 62 contract agencies have existing LE Agreements with DMH. Of these, 43 currently provide some form of MHSA services. The Agreements are being amended to allow these 62 contract agencies the opportunity to transform and/or expand MHSA services. Amendments to their existing Agreements will be executed upon Board approval.


IMPACT ON CURRENT SERVICES

Board approval of the proposed amendments and allocations will initiate a large scale effort among contract agencies to transform service delivery to a recovery and wellness-based system of care, consistent with State guidelines for the MHSA. Such transformation will significantly enhance the availability of a broad array of mental health services to unserved, underserved, or inappropriately served children, transition age youth, adults, and older adults.

CONCLUSION

THIS AMENDMENT is made and entered into this ___ day of _____, 2008, by and between the COUNTY OF LOS ANGELES (hereafter "County") and _____ (hereafter "Contractor").

WHEREAS, County and Contractor have entered into a written Agreement, dated June 12, 2007, identified as County Agreement No. _____, and any subsequent amendments (hereafter collectively "Agreement"); and

WHEREAS, for Fiscal Year (FY) 2008-09 only, County and Contractor intend to amend Agreement described hereunder; and

WHEREAS, for FY 2008-09 only, County and Contractor intend to amend Agreement to decrease Local Mental Health Plan Non-Medi-Cal Plan funds – County General Funds (CGF) in the amount of \$_____, decrease non-Early and Periodic Screening, Diagnosis, and Treatment (non-EPSDT) CGF in the amount of \$_____, decrease non-EPSDT Federal Financial Participation (FFP) Medi-Cal in the amount of \$_____, decrease Healthy Families (HF) CGF in the amount of \$_____, and decrease HF FFP in the amount of \$_____, and (edit as necessary)

WHEREAS, as the Department moves from its traditional core mental health programs to a new recovery and wellness-based system of care, Contractor shall be given an opportunity to deliver transformed services as part of the Mental Health Services Act (MHSA) Community Services and Support Plan (CSS Plan); and

WHEREAS, for FY 2008-09 only, Contractor intends to "transform" a portion of its current outpatient services and therefore, County and Contractor intend to amend Agreement to enable Contractor to "transform" a portion of its curtailed outpatient services and resources to MHSA - CSS Plan services using unspent FY 2007-08 MHSA - CSS Plan funds. This will require Contractor to transform those general outpatient services previously funded with non-MHSA and/or other State and/or County funds to new and/or expanded MHSA CSS - Plan programs and will require Contractor staff to provide services prescribed and approved under the MHSA - CSS Plan; and

Whereas, for FY 2008-09 only, County and Contractor intend and agree that Contractor's transformation of a portion of its curtailed outpatient services and resources to MHSA CSS Plan services for FY 2008-09, does not guarantee to Contractor continued funding for such services after FY 2008-09; and

WHEREAS, (if applicable) for FY 2008-09 only, County and Contractor intend to amend Agreement to increase MHSA TAY Probation Camp services funds in the amount of \$_____; and

OUTREACH AND ENGAGEMENT:

WHEREAS, (if applicable) for FY 2008-09 only, County and Contractor intend to amend Agreement to increase MHSA Child, TAY, Adult, and/or Older Adult Outreach and Engagement funds in the amount of \$_____, \$_____, \$_____, and/or \$_____ respectively; and

ONE-TIME COSTS:

WHEREAS, County will determine allowable one-time amounts based on one (1) month of FY 2008-09 MHSA funding; and

WHEREAS, SDMH has not defined MHSA allowable one-time costs. Accordingly, anticipated MHSA allowable costs are identified in the "One-Time Expenses Associated with starting a new MHSA Program" Service Exhibit, which represents County's best effort to identify allowable one-time costs. Such costs may ultimately be subject to disallowance by SDMH; and

WHEREAS, if Contractor terminates its Agreement within 24 months of the effective date of this Amendment or execution of an Agreement that includes MHSA allowable one-time costs, or if Contractor fails to achieve a 75% enrollment level after 12 months, any or all of MHSA allowable one-time funds received by Contractor from County may be due by Contractor to County at the sole discretion of Director; and

WHEREAS, Contractor shall comply with all statutes, regulations, and directives pertaining to MHSA allowable one-time costs as they currently exist or as they may be modified by the State or County, and in no event shall County be obligated to pay contractor for one-time costs not claimable to the MHSA; and

AVAILABILITY OF MHSA FUNDS:

WHEREAS, for FY 2008-09, County and Contractor intend to amend Agreement to add Paragraph V. (1) under Financial Exhibit A (FINANCIAL PROVISIONS), Attachment II, to include whereby in the event MHSA funds are not made available by the State to pay MHSA claims or if the State denies any or all of the MHSA claims submitted by County on behalf of Contractor, County is not responsible for any substantive payment obligation; and

REDUCTION/REALLOCATION OF MHSA FUNDS:

WHEREAS, notwithstanding the provisions set forth in Financial Exhibit A (FINANCIAL PROVISIONS), Attachment II, Paragraph U (Delegated Authority) of this Agreement, County shall evaluate Contractor utilization of MHSA funding allocated under this Agreement and shall adjust and reallocate amounts to any one or a combination of the following: 1) another Legal Entity contractor, 2) DMH directly operated clinics, and/or 3) the County DMH reserve of unallocated funding for MHSA

services. Amounts to be reduced and reallocated will be based on County's projected underutilization of such MHSA funds; and

WHEREAS, County will perform its utilization review after the initial MHSA amendments are executed and annually thereafter, or as deemed necessary by County based on County's review of utilization of such MHSA funds under this Agreement. Notification of such actions to Contractor will follow timeframes prescribed in Financial Exhibit A (FINANCIAL PROVISIONS), Attachment II, Paragraph U (Delegated Authority); and

WHEREAS, for FY 2008-09 only, the total amount of MHSA funds from FY 2007-08 will be \$ _____ to be transformed to new and/or expanded programs in FY 2008-09 under the MHSA - CSS Plan; and

WHEREAS, for FY 2008-09 only, the total Maximum Contract Amount (MCA) of \$ _____ will remain unchanged.

NOW, THEREFORE, County and Contractor agree that Agreement shall be amended only as follows:

1. Paragraph 3 (DESCRIPTION OF SERVICES/ACTIVITIES), shall be deleted in its entirety and the following substituted therefore:

"3. DESCRIPTION OF SERVICES/ACTIVITIES: Contractor shall provide mental health services in the form as identified on the Financial Summary(ies) and Service Exhibit(s) and in the Program Description of Contractor's Negotiation Package for this Agreement as approved in writing by Director or his designee, including any addenda thereto as approved in writing by Director or his designee.

Services provided by Contractor shall be the same regardless of the patient's/client's ability to pay or source of payment.

Contractor shall be responsible for delivering services to new clients to the extent that funding is provided by County. Where Contractor determines that services to new clients can no longer be delivered, Contractor shall provide 30 calendar days prior notice to County. Contractor shall also thereafter make referrals of new clients to County or other appropriate agencies.

Contractor shall not be required to provide the notice in the preceding paragraph when County reduces funding to Contractor, either at the beginning or during the fiscal year. In addition, when County cuts the funding for a particular program provided by Contractor, Contractor shall not be responsible for continuing services for those clients linked to that funding. Contractor shall also thereafter make referrals of those clients to County or other appropriate agencies.

Contractor may provide activities claimable as Title XIX Medi-Cal Administrative Activities pursuant to WIC Section 14132.44. The administrative activities which may be claimable as Title XIX Medi-Cal Administrative Activities are shown on the Financial Summary and are described in the policies and procedures provided by SDMH and/or SDHS.

Contractor may provide mental health services claimable as Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) services.

If, during Contractor's provision of services under this Agreement, there is any need for substantial deviation from the services as described in Contractor's

Negotiation Package for this Agreement, as approved in writing by Director or his designee, including any addenda thereto as approved in writing by Director or his designee, then Contractor shall submit a written request to Director or his designee for written approval before any such substantial deviation may occur. A 30% variance of actual services from those projected and shown by Contractor in the Negotiation Package will be considered a substantial deviation in service delivery. The following language applies only to *Contractors found eligible to provide mental health services claimable under the Mental Health Services Act (MHSA)*: Contractor has been found to be eligible to provide mental health services claimable as MHSA services. Contractor has demonstrated experience and training in its specialized field and has submitted to the County a Statement of Qualifications (SOQ) in response to County's RFSQ for the provision of such services, and Contractor has met the minimum qualifications listed in the RFSQ and has been selected for recommendation for placement on a MHSA Master Agreement eligibility list. Placement on the Master Agreement eligibility list does not guarantee that Contractor will be selected to provide mental health services claimable as MHSA services. In order to provide mental health services claimable as MHSA services, a provider must have been selected to provide MHSA services pursuant to a Request for Services and/or through transformation to a new or expanded MHSA program(s)."

2. Financial Exhibit A (FINANCIAL PROVISIONS), Attachment II, Paragraph D (Billing and Payment Procedures and Limitations), Subparagraph 5 (a) (Special Claiming

Conditions – Mental Health Services Act) shall be deleted in its entirety and the following substituted therefor:

“(5) Special Claiming Conditions:

(a) Mental Health Services Act (MHSA): The execution of Amendments issued under the MHSA Request for Statement of Qualifications (RFSQ) does not guarantee a Contractor any amount of funding. Contractor shall not be entitled to any payment of MHSA funds by County under this Agreement except pursuant to validly executed and satisfactorily performed Work Orders or Amendments completed in accordance with County issued MHSA Request for Services (RFS) that includes a specific and detailed Statement(s) of Work and/or through transformation to a new or expanded MHSA program(s). Nothing herein is intended nor shall be construed as creating any exclusive arrangement with Contractor. This Agreement shall not restrict County from acquiring similar, equal or like MHSA goods and/or services from other entities or sources.”

3. Financial Exhibit A (FINANCIAL PROVISIONS), Attachment II, Paragraph B (Reimbursement For Initial Period) shall be deleted in its entirety and the following substituted therefor:

“B. Reimbursement For Initial Period: The Maximum Contract Amount for the Initial Period of this Agreement as described in Paragraph 1 (TERM) shall not exceed _____ DOLLARS (\$_____) and shall consist of County, State, and/or Federal funds as shown on the Financial Summary.”

4. Financial Exhibit A (FINANCIAL PROVISIONS), Attachment II, Paragraph K (Cash Flow Loan Advance in Expectation of Services/Activities to be Rendered), Subparagraph (8) (Business Rules for the Determination of the Maximum Amount of the Cash Flow Advance Request) shall be deleted in its entirety and the following substituted therefor (if applicable):

"K. Cash Flow Advance in Expectation of Services/Activities to be Rendered:

(8) Business Rules for the Determination of the Maximum Amount of the Cash Flow Advance Request:

(a) Each month of each fiscal year not to exceed three (3) consecutive months, or portion thereof, that this Agreement is in effect, Contractor may request, separately for each month, in writing from County a monthly County General Fund Cash Flow Advance for any funds which may be part of the Maximum Contract Amount for such fiscal year as identified on the Financial Summary Page. Contractor shall specify in their request the amount of the monthly Cash Flow Advance not to exceed \$_____ per month and the total Cash Flow Advance for the three (3) months shall not exceed \$_____. The Cash Flow Advance monthly amount is 1/12th of Maximum Contract Amount as identified on the Financial Summary Page, annualized Maximum Contract Amount if a partial year.

(b) A Contractor providing Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) Short-Doyle/Medi-Cal services as part of this Agreement, may for two (2) additional consecutive months, or portion thereof, that this Agreement is in effect, request, separately for each month, in writing

from County a monthly County General Fund Cash Flow Advance for any EPSDT Title XIX Medi-Cal funds which may be part of the Maximum Contract Amount for such fiscal year as shown on the Financial Summary Page. Contractor shall specify in their request the amount of the monthly Cash Flow Advance not to exceed \$ _____ per month for each of the two (2) additional consecutive months and the total Cash Flow Advance for the two (2) additional consecutive months shall not exceed \$ _____.”

5. For FY 2008-09, Financial Exhibit A (FINANCIAL PROVISIONS), Attachment II, Paragraph V (MHSA Funds) shall be added in its entirety:

“V: Mental Health Services Act (MHSA) Funds:

- (1) In the event MHSA funds are not made available by the State to pay MHSA claims or if the State denies any or all of the MHSA claims submitted by County on behalf of Contractor, County is not responsible for any substantive payment obligation and, accordingly, Contractor shall not seek any payment from County and shall indemnify and hold harmless County from any and all liability for payment of any or all of the denied MHSA claims or claims for which MHSA funds are not made available by the State.”
6. Financial Summary – ____ for FY 2008-09 shall be deleted in its entirety and replaced with Financial Summary – _____ for FY 2008-09, attached hereto and incorporated herein by reference.
