**APPROVAL OF AMENDMENTS TO MENTAL HEALTH SERVICES
LEGAL ENTITY AGREEMENTS TO ALLOW CONTRACT PROVIDERS TO USE, ON
A PROVISIONAL BASIS, COUNTY GENERAL FUNDS TO PAY FOR
UNCOMPENSATED INDIGENT/UNINSURED CARE SERVICES
(ALL SUPERVISORIAL DISTRICTS)
(3 VOTES)**

IT IS RECOMMENDED THAT YOUR BOARD:

Approve and instruct the Director of Mental Health or his designee to prepare, sign, and execute amendments, substantially similar to Attachment I, to 135 of the Department of Mental Health (DMH) Legal Entity Agreements (LE Agreement) listed on Attachment II. For Fiscal Year (FY) 2004-2005 only, the amendments will allow DMH to use, on a provisional basis, County General Funds (CGF) to pay for uncompensated indigent/uninsured care services pending the State Short-Doyle/Medi-Cal (SD/MC) Final Settlement to the Fiscal Audit Report for FY 2004-2005. There will be no change to each provider's Maximum Contract Amount (MCA). There will also be no change in DMH's appropriation.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS

Board approval is requested to authorize use of the Amendment format to allow Contractors, on a provisional basis, to shift unspent CGF categorically linked in the Financial Summary of the LE Agreement as Federal Financial Participation (FFP) local and/or baseline match ("Match"). Such CGF provisional disbursements will be made on the basis that Contractors have submitted true and accurate reimbursement claims and with Contractors' agreement to use, if necessary, any such provisional CGF disbursements to satisfy the local match certified public expenditures required to draw down Medi-Cal FFP for FY 2004-2005 as determined by the State's Final Settlement.

"To Enrich Lives Through Effective And Caring Service"

Implementation of Strategic Plan Goals

The recommended Board action is consistent with the principles of the Countywide Strategic Plan Programmatic Goal No. 7, "Health and Mental Health." Board approval of this request will allow Contractors to be reimbursed for FY 2004-2005 only, on a provisional basis, for uncompensated indigent/uninsured care services pending the State SD/MC Final Settlement to the Fiscal Audit Report for FY 2004-2005.

FISCAL IMPACT/FINANCING

There is no increase in net County cost.

Contractors must remain within the MCA specified in their respective Board approved LE Agreement. Contractors would not be paid any more CGF than has been authorized by your Board in the existing LE Agreement.

DMH will continue to enforce its settlement processes to ensure any shift of CGF complies with all County, State, and Federal regulations.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

It has been DMH's practice in the past to allow Contractors the ability to shift unspent CGF to pay for uncompensated indigent/uninsured care services. For FY 2003-2004, the State issued a "Change in Requirements For Certification of Medi-Cal Claims" on June 25, 2003. Specifically, a Department official must "...certify that claimant will provide the State's share of payment for Short Doyle/Medi-Cal covered services included in this claim in order to satisfy matching requirements for Federal Financial Participation pursuant to the Title XIX of the Social Security Act."

DMH, in order to ensure compliance, has budgeted and contractually specified in the LE Agreement the correct amount of CGF necessary to provide the Match for FFP as required by Title XIX of the Social Security Act. Certain Contractors have not been able to deliver the projected contracted level of Medi-Cal funded services. Accordingly, a portion of the CGF set aside for the mandated local match to FFP is then not required for that purpose. This Amendment to the LE Agreement for FY 2004-2005 will only enable Contractors to use any such unexpended CGF on a provisional basis for indigent/uninsured care services. This authorization will only be on a provisional basis because Medi-Cal services can be billed for up to one (1) year after the month of service. Consequently, it is unknown for some time whether the CGF under discussion here will be needed as the Match for Medi-Cal. This Amendment addresses this issue by specifying that the use of the CGF originally designated as Match be used for

indigent/uninsured care services and is provisional until such time as the State concludes its final settlement for FY 2004-2005.

DMH will be meeting with Contractors to develop a written policy pertaining to the use of unspent CGF for indigent/uninsured care services for FY 2005-2006 and any future years.


IMPACT ON CURRENT SERVICES

AMENDMENT NO. ____

THIS AMENDMENT is made and entered into this _____ day of June, 2005, by and between the COUNTY OF LOS ANGELES (hereafter "County") and _____ (hereafter "Contractor").

WHEREAS, County and Contractor have entered into a written Agreement, dated June 29, 2004, identified as County Agreement No. DMH-_____, and any subsequent amendments (hereafter collectively "Agreement"); and

WHEREAS, for Fiscal Year 2004-2005 only, County and Contractor intend to amend Agreement as only described hereunder; and

WHEREAS, for Fiscal Year 2004-2005, County and Contractor intend to amend the Agreement to add language to enable contractors to use, on a provisional basis, unspent County General Funds (CGF) categorically linked in the Legal Entity Agreement as Federal Financial Participation (FFP) local and/or baseline match ("Match"). This amendment will allow contractors to use on a provisional basis such CGF to pay for uncompensated indigent/uninsured care services pending the State Short-Doyle Medi-Cal (SD/MC) Final Settlement to the Fiscal Audit Report for FY 2004-2005. This referenced Final Settlement identifies the federally required amount of CGF certified public expenditures to draw down SD/MC FFP for FY 2004-2005. Such CGF provisional disbursements will be made on the basis that Contractors have submitted true and accurate reimbursement claims and with Contractors' agreement to use, if

necessary, any such provisional CGF disbursements for the local match certified public expenditures required to draw down Medi-Cal FFP for FY 2004-2005 as determined by the State's Final Settlement. Contractors in accepting the provisional CGF payments for indigent/uninsured services hereby acknowledge and agree that if it is determined after the State SD/MC Final Settlement to the Fiscal Audit Report for FY 2004-2005 that more CGF is needed for local match to draw down FFP than was originally paid, an adjustment to the Contractor's CGF provisional payments for the indigent/uninsured services claims will be made in the amount necessary to satisfy federal local match requirements; and

Whereas, the Maximum Contract Amount (MCA) shall remain the same.

NOW, THEREFORE, County and Contractor agree that Agreement shall be amended only as follows:

1. For FY 2004-2005 only, Subsection (12) shall be added to Paragraph 4 (FINANCIAL PROVISIONS), Subparagraph J (Payment):

"J (12). For FY 2004-2005 only, Contractor may, on a provisional basis, shift CGF between categories in the Financial Summary, based on actual services delivered, with the provision that at settlement, CGF will be first used for Match if the amount needed for Match exceeds the amount projected by Contractor. Any such shift of funds shall be in compliance with all County, State, and Federal regulations and shall not result in any increase to the MCA.

2. Contractor shall provide services in accordance with the Contractor's Fiscal Year _____ Negotiation Package for this Agreement and any addenda thereto approved in writing by Director.

3. Except as provided in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
