SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS FOR
JANUARY 2017**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of three Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of two new Agreements processed in the month of January 2017 as follows:

1. **Agreement (MH050179) with Constant and Associates, Inc.**, is a newly executed Consultant Services Agreement. The term of this Agreement commenced on January 1, 2017, and shall continue through June 30, 2021.
2. **Agreement (MH9147) with African Communities Public Health Coalition** is a newly executed Medi-Cal Professional Services Agreement. The term of this Agreement commenced on January 5, 2017, and shall continue through June 30, 2017.

The following one Amendment (3) revises provisions in Paragraphs 14 and 63 and deletes Attachment VII from the Agreement, to be effective immediately. There is no change to the Maximum Contract Amount (MCA):

3. **Amendment No. 1 (MH9147) with African Communities Public Health Coalition**

The following one Amendment (4) increases the Total Agreement Amount (TAA):

4. **Amendment No. 7 (MH190084) with Emotional Health Association dba SHARE! the Self-Help And Recovery Exchange** for Fiscal Year (FY) 2016-17 increases the TAA in the amount of \$150,000 to continue providing on-site and/or scattered supportive services to individuals with psychiatric disabilities and who reside in permanent supportive housing developments. The revised TAA is \$1,062,827.

The following one Amendment (5) changes the business address for Provider Numbers (PN) 6853A and 7622A. There is no change to the MCA:

5. **Amendment No. 44 (MH121150) with San Fernando Valley Community Mental Health Center, Inc.**, for FY 2016-17 changes the business address for PN 6853A from 6305 Woodman Avenue, Van Nuys, CA 91401, to 6400 Laurel Canyon Boulevard, Suite 500, North Hollywood, CA 91606, and changes the business address for PN 7622A from 14550 Sherman Way, Van Nuys, CA 91405, to 6400 Laurel Canyon Boulevard, Suite 500, North Hollywood, CA 91606.

Report Addendum

The following 25 items reflect additional actions from Agreement and Amendment reports from previous months as indicated.

Addendum for July 2016

The following one Amendment (1) extends the term of the agreement for three years beginning July 1, 2016, through June 30, 2019, and includes new provisions regarding Contractor's Obligations as a Business Associate under the Health Insurance Portability and Accountability Act (HIPAA) of 1996:

1. **Amendment No. 2 with Managed Career Solutions, Inc.**

Addendum for September 2016

The following one Agreement (2) was executed and processed in the month of September 2016 as follows:

2. **Agreement (MH010124) with University of Southern California Division of Occupational Science & Occupational Therapy** is a newly executed Affiliation Agreement for Student Professional Development Programs. The term of this Agreement commenced on September 6, 2016, and shall continue through June 30, 2021.

The following two Amendments (3 and 4) revise provisions in Paragraph 14, and 63 and delete Attachment VII from the Agreement, to be effective immediately. There is no change to the MCA:

3. **Amendment No. 1 (MH9109) with Dual Diagnosis Assessment and Treatment Center, Inc., dba Management Health Systems**
4. **Amendment No. 1 (MH9118) with Memorial Counseling Associates Medical Group, Inc., dba Memorial Counseling Associates**

The following one Amendment (5) decreases MHSA Field Capable Clinical Services (FCCS) MC/Non-MC/Invoice Funded Program funds:

5. **Amendment No. 14 (MH121110) with Barbour and Floyd Medical Associates** for FY 2016-17 decreases MHSA FCCS Non-MC Funded Program funds in the amount of \$20,592, decreases MHSA FCCS Invoice Funded Program funds in the amount of \$12,193, and decreases MHSA FCCS MC Funded Program funds in the amount of \$509,127. The revised MCA is \$2,973,572.

Addendum for November 2016

The following six Amendments (6 through 11) increase/decrease Post-Release Community Supervision (PCS) – Community Reintegration Program (CRP) Non-MC/MC Funded Program funds:

6. **Amendment No. 12 (MH121263) with Exodus Recovery, Inc.,** for FYs 2016-17 and 2017-18 decreases PCS – CRP Non-MC Funded Program funds in the amount of \$137,531 and increases PCS – CRP MC Funded Program funds in the amount of \$238,236. The revised MCA is \$26,071,678 and \$26,071,678, respectively.
7. **Amendment No. 17 (MH121193) with Exodus Foundation** for FY 2016-17 decreases PCS – CRP Non-MC Funded Program funds in the amount of \$140,000 and increases PCS – CRP MC Funded Program funds in the amount of \$160,000. The revised MCA is \$8,140,603.

8. **Amendment No. 25 (MH121148) with HealthRIGHT 360** for FY 2016-17 decreases PCS – CRP Non-MC Funded Program funds in the amount of \$606,122 and increases PCS – CRP MC Funded Program funds in the amount of \$159,276. The revised MCA is \$8,654,637.
9. **Amendment No. 41 (MH121150) with San Fernando Valley Community Mental Health Center, Inc.**, for FY 2016-17 decreases PCS – CRP Non-MC Funded Program funds in the amount of \$526,389 and increases PCS – CRP MC Funded Program funds in the amount of \$184,111. The revised MCA is \$37,836,844.
10. **Amendment No. 25 (MH121162) with Telecare Corporation** for FY 2016-17 decreases PCS – CRP Non-MC Funded Program funds in the amount of \$1,553,566 and increases PCS – CRP MC Funded Program funds in the amount of \$815,366. The revised MCA is \$25,641,509.
11. **Amendment No. 28 (MH121284) with Pacific Clinics** for FYs 2016-17 and 2017-18 decreases PCS – CRP Non-MC Funded Program funds in the amount of \$314,854 and increases PCS – CRP MC Funded Program funds in the amount of \$285,789. The revised MCA is \$94,892,414 and \$93,350,468, respectively.

The following two Amendments (12 and 13) increase/decrease MHSA Prevention and Early Intervention (PEI) MC/Invoice Funded Program funds:

12. **Amendment No. 14 (MH121261) with ENKI Health and Research Systems, Inc.**, for FYs 2016-17 and 2017-18 decreases MHSA PEI MC Funded Program funds in the amount of \$600,000. The revised MCA is \$34,279,516 and \$32,565,092, respectively.
13. **Amendment No. 13 (MH121130) with Heritage Clinic and the Community Assistance Program for Seniors** for FY 2016-17 increases MHSA PEI Invoice Funded Program funds in the amount of \$3,500. The revised MCA is \$4,846,557.

The following three Amendments (14 through 16) increase First 5 Invoice Funded Program funds:

14. **Amendment No. 22 (MH121149) with Pathways Community Services, LLC**, for FY 2016-17 increases First 5 Invoice Funded Program funds in the amount of \$27,000. The revised MCA is \$7,712,001.

15. **Amendment No. 27 (MH121284) with Pacific Clinics** for FY 2016-17 increases First 5 Invoice Funded Program funds in the amount of \$30,000. The revised MCA is \$94,921,479.
16. **Amendment No. 16 (MH1211261) with ENKI Health and Research Systems, Inc.,** for FY 2016-17 increases First 5 Invoice Funded Program funds in the amount of \$27,000. The revised MCA is \$34,306,516.

The following one Amendment (17) increases California Work Opportunity and Responsibility to Kids (CalWORKs) Non-MC Funded Program funds:

17. **Amendment No. 29 (MH121146) with Penny Lane Centers** for FY 2016-17 increases CalWORKs Non-MC Funded Program funds in the amount of \$270,000. The revised MCA is \$29,899,698.

The following one Amendment (18) increases MHSA Full Service Partnership (FSP) MC Funded Program funds:

18. **Amendment No. 21 (MH121143) with Pacific Asian Counseling Services** for FY 2016-17 increases MHSA FSP MC Funded Program funds in the amount of \$159,990. The revised MCA is \$4,711,351.

The following one Amendment (19) adds a new service delivery site. There is no change to the MCA:

19. **Amendment No. 15 (MH121261) with ENKI Health and Research Systems, Inc.,** for FY 2016-17 adds a new service delivery site located at 6635 Florence Avenue, Suite 101, Bell Gardens, CA 90201.

The following one Amendment (20) decreases MHSA FSP Non-MC Funded Program funds and increases DMH Mental Health Services MC Funded Program funds:

20. **Amendment No. 21 (MH121161) with Tarzana Treatment Centers, Inc.,** for FY 2016-17 decreases MHSA FSP Non-MC Funded Program funds in the amount of \$100,000 and increases DMH Mental Health Services MC Funded Program funds in the amount of \$10,000. The revised MCA is \$10,490,520.

22. **Amendment No. 6 (MH121273) with Homes for Life Foundation** for FYs 2016-17 and 2017-18 increases MHSA IMD Step-Down Invoice Funded Program funds in the amount of \$155,000. The revised MCA is \$2,096,305 and \$2,147,405, respectively.

The following one Amendment (23) is a Technical Correction. There is no change to the MCA:

23. **Amendment No. 2 (MH110002) with Primex Clinical Laboratories, Inc.**, for FY 2016-17 is a Technical correction that eliminates a sentence from Amendment # 1 in Paragraph 4A (4).
