SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS FOR AUGUST 2016**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 15 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of six new Agreements processed in the month of August 2016 as follows:

1. **Agreement (MH29848) with Janet Agu, NP**, is a newly executed Medi-Cal Professional Services Agreement. The term of this Agreement commenced on August 11, 2016, and shall continue through June 30, 2017.
2. **Agreement (MH29847) with Cordelia Rose E. Onyekwe, NP**, is a newly executed Medi-Cal Professional Services Agreement. The term of this Agreement commenced on August 10, 2016, and shall continue through June 30, 2017.
3. **Agreement (MH29846) with Maryam T. Farmani, MFT**, is a newly executed Medi-Cal Professional Services Agreement. The term of this Agreement commenced on August 15, 2016, and shall continue through June 30, 2017.

6. **Agreement (MH9146) with Project IMPACT, Inc., dba Project IMPACT** is a newly executed Medi-Cal Professional Services Agreement. The term of this Agreement commenced on August 23, 2016, and shall continue through June 30, 2017.

17. **Amendment No. 1 (MH220048) with C. Ashen Psychological Consulting** for FYs 2016-17 and 2017-18 revises the Contractor's Obligation as a Business Associate under the HIPAA of 1996 to incorporate additional privacy and security requirements applicable to business associates.

***The following one Amendment (18) replaces Amendment No. 2 with Amendment No. 1 throughout the Agreement. There is no change to the MCA:***

18. **Amendment No. 2 (MH121270) with HealthView, Inc., dba Harbor View House** for FY 2016-17 Amendment No. 2 on page 1 of the Agreement is stricken and replaced with Amendment No. 1, and Amendment No. 2 is stricken and replaced with Amendment No. 1 on the following attachments: Financial Exhibit A, Attachment II, Financial Summary, Attachment IV, Service Delivery Site Exhibit, Attachment V, Service Exhibits, and Attachment X.

***The following one Amendment (19) increases MHSA Field Capable Clinical Services (FCCS) MC Funded Program funds:***
