SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS FOR  
OCTOBER 2016**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of seven Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of five new Agreements processed in the month of October 2016 as follows:

1. **Agreement (MH190136) with Penny Lane Centers** is a newly executed Drop-In Center for Transition-Age Youth Services Agreement. The term of this Agreement commenced on October 4, 2016, and shall continue through June 30, 2017.
2. **Agreement (MH220051) with Silvia Esqueda dba Esqueda Consulting Services** is a newly executed Master Agreement for Project Management Services. The term of this Agreement commenced on October 20, 2016, and shall continue through June 30, 2018.
3. **Agreement (MH200462) with Southern California Foster Family Agency dba Extraordinary Families** is a newly executed Master Agreement. The term of this Agreement commenced on October 13, 2016, and shall continue through June 30, 2019.

4. **Agreement (MH220050) with Kiely/Crary Associates, Inc., dba Kiely Group** is a newly executed Project Management Services Master Agreement. The term of this Agreement commenced on October 25, 2016, and shall continue through June 30, 2018.
5. **Agreement (MH29851) with Community Mental Health Associates, Inc.,** is a newly executed Medi-Cal Professional Services Agreement. The term of this Agreement commenced on October 1, 2016, and shall continue through June 30, 2017.

9. **Amendment No. 13 (MH121246) with Amanecer Community Counseling Services, Inc.,** for FY 16-17 increases MHSA PEI Non-MC Funded Program funds in the amount of \$200,000. The revised MCA is \$10,892,894.

***The following one Amendment (10) adds/deletes Service Delivery Site. There is no change to the MCA:***

10. **Amendment No. 25 (MH121284) with Pacific Clinics** for FY 2016-17 deletes service delivery site located at 2500 Wilshire Boulevard, Suite 704, Los Angeles, CA 90057, under Provider Number (PN) 7677, deletes service delivery site located at 2500 Wilshire Boulevard, Suite 500, Los Angeles, CA 90057, under PN 7678, and adds new service delivery site located at 679 South New Hampshire Avenue, Suite 400, Los Angeles, CA 90005, under PN 7678.

***The following one Amendment (11) increases First 5 MC/Non-MC/Invoice Funded Program funds:***

11. **Amendment No. 1 (MH121328) with Los Angeles Unified School District** for FY 2016-17 increases First 5 Non-MC Funded Program funds in the amount of \$13,000, increases First 5 Invoice Funded Program funds in the amount of \$86,136, and increases First 5 MC Funded Program funds in the amount of \$64,000. The revised MCA is \$7,143,150.

***The following one Amendment (12) increases Homeless Services C3 MC/Non-MC/Invoice Funded Program funds:***

12. **Amendment No. 15 (MH121157) with St. Joseph Center** for FY 2016-17 increases Homeless Services C3 Non-MC Funded Program funds in the amount of \$100,000, increases Homeless Services C3 Invoice Funded Program funds in the amount of \$36,500, and increases Homeless Services C3 MC Funded Program funds in the amount of \$280,000. The revised MCA is \$4,731,728.
