SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS FOR SEPTEMBER 2016**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 11 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of three new Agreements processed in the month of September 2016 as follows:

1. **Agreement (MH010121) with University of Southern California Keck School of Medicine** is a newly executed Affiliation Agreement for Student Professional Development Programs. The term of this Agreement commenced on September 1, 2016, and shall continue through June 30, 2021.
2. **Agreement (MH200458) with Hope of the Valley Rescue Mission** is a newly executed Master Agreement. The term of this Agreement commenced on September 27, 2016, and shall continue through June 30, 2019.
3. **Agreement (MH190129) with Maxim Healthcare Services, Inc.**, is a newly executed Respite Care Services Agreement. The term of this Agreement commenced on September 6, 2016, and shall continue through June 30, 2018.

***The following three Amendments (4 through 7) increase Projects for Assistance in Transition from Homelessness (PATH) McKinney, Catalog of Federal Domestic Assistance (CFDA) #93.150 Non-MC/Invoice Funded Program funds:***

7. **Amendment No. 22 (MH121139) with Mental Health America of Los Angeles** for FY 2016-17 increases PATH McKinney CFDA #93.150 Invoice Funded Program funds in the amount of \$200,000. The revised MCA is \$18,360,711.

13. **Amendment No. 10 (MH121140) with New Directions, Inc.**, for FY 2016-17 deletes service delivery site for PN 7909, located at 11303 Wilshire Boulevard, VA Building #116, Los Angeles, CA 90073.
