SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 18 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of two new Agreements processed in the month of August 2014 as follows:

1. **Agreement (MH050150) with Los Angeles County for the Mentally Ill aka Los Angeles County Coordinating Council (LACCC)** was executed under the Consultant Services Agreement. The term of this Agreement is from August 5, 2014, through June 30, 2018.
2. **Agreement (MH9133) with Multiservice Family Center, Inc.,** was executed under MC Professional Services Agreement. The term of this Agreement is from August 13, 2014, through June 30, 2015.
3. **Amendment No. 2 (MH121151) with SHEILDS For Families** adds Juvenile Day Reporting Center Non MC/Non Healthy Families (HF) funds in the amount of \$60,000 for Fiscal Years (FYs) 2014-15, 2015-16, and 2016-17. The revised Maximum Contract Amounts (MCAs) are \$11,908,239, \$10,150,199 and \$10,150,199, respectively.
4. **Amendment No. 1 (MH230013) with RD Technology Solutions, Inc.,** updated standard County provisions: Background and Security Investigations, Facsimile Representations, Health Insurance Portability and Accountability Act of 1996, Ownership of Materials, Software and Copyright, Publicity, and Subcontracting; and adds the following County provisions: Reports, Time Off for Voting, and Disabled Veterans Business Enterprise Preference Program.
5. **Amendment No. 2 (MH121158) with Star View Adolescent Center, Inc.,** revises the service site address, Provider Number (PN) 7503, from

5420 North Figueroa Street, Los Angeles, CA 99042, to Star View Community Services, 1625 W. Olympic Boulevard, Suite 600, Los Angeles, CA 90015. There is no change to the MCA.

The following two Amendments (6 and 7) revise Exhibit A-Statement of Work (SOW) Attachment I. There is no change to the Total Contract Amount (TCA).

The following nine Amendments (12 through 20) to LE Agreements increase and/or add Mental Health Service Act (MHSA) Prevention and Early Intervention (PEI) for Non MC/Non HF and MC/HF funds:

12. Amendment No. 1 (MH12111) with Bayfront Youth and Family Services increases MHSA PEI invoice funds program in the amount of \$500 for FY 2014-15 only. The revised MCA is \$1,438,077.

13. Amendment No. 1 (MH121121) with Dignity Health dba California Hospital Medical Center increases MHSA PEI MC funds in the amount of \$56,463 for FY 2014-15 only. The revised MCA is \$1,148,247.

14. Amendment No. 1 (MH121141) with One In Long Beach, Inc., increases MHSA PEI Non MC funds in the amount of \$25,600 for FY 2014-15 only. The revised MCA is \$153,600.

15. **Amendment No. 1 (MH121165) with The Guidance Center** increases MHSA PEI Non MC funds in the amount of \$63,349 for FY 2014-15 only. The revised MCA is \$11,758,329.
16. **Amendment No. 1 (MH121167) with The Village Family Services** increases MHSA PEI Non MC funds in the amount of \$4,008 for FY 2014-15 only. The revised MCA is \$5,385,096.
17. **Amendment No. 1 (MH121210) with Los Angeles Child Guidance Clinic** increases MHSA PEI Non MC funds in the amount of \$163,606 for FY 2014-15 only. The revised MCA is \$18,097,273.
18. **Amendment No. 1 (MH121212) with Los Angeles Unified School District** increases MHSA PEI Non MC funds in the amount of \$208 for FY 2014-15 only. The revised MCA is \$5,962,529.
19. **Amendment No. 1 (MH121218) with Personal Involvement Center, Inc.,** increases MHSA PEI MC funds in the amount of \$123,636 for FY 2014-15 only. The revised MCA is \$2,983,045.
20. **Amendment No. 1 (MH121232) with Vista Del Mar Child and Family Services** increases MHSA PEI Non MC funds in the amount of \$23,117 for FY 2014-15 only. The revised MCA is \$10,874,355.
