SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 22 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of seven new Agreements processed in the month of February 2015 as follows:

1. **Amendment No. 11 (MH050042) with Mental Health America of Los Angeles** decreases MHSA Supports funds in the amount of \$299,000. The revised Maximum Contract Amount (MCA) is \$381,400.
2. **Amendment No. 3 (MH121107) with Alcott Center for Mental Health Services** decreases MHSA Urgent Care Center (UCC) Non MC Funded Program funds in the amount of \$80,000; increases MHSA Adult Field Capable Clinical Services (FCCS) Non Early and Periodic Screening, Diagnosis, and Treatment (Non EPSDT) MC Funded Program funds in the amount of \$100,000; and increases MHSA Older Adult (OA) FCCS Non EPSDT MC Funded Program funds in the amount of \$60,000 for Fiscal Year (FY) 2014-15. The revised MCA is \$2,105,165.
3. **Amendment No. 4 (MH121117) with Community Family Guidance Center** shifts MHSA Full Service Partnership Non MC Funded Program funds in the amount of \$20,200 to MHSA Family Support Services Non MC Funded Program funds for FY 2014-15.
4. **Amendment No. 6 (MH121139) with Mental Health America of Los Angeles** increases MHSA Full Service Partnership (FSP) funding by \$359,675 for FYs 2014-15, 2015-16, and 2016-17. The revised MCAs are \$19,874,075, \$16,847,716, and \$15,786,050, respectively.

5. **Amendment No. 3 (MH121157) with St. Joseph Center** increases MHSA FCCS MC Funded Program funds in the amount of \$12,500 for FY 2014-15. The revised MCA will be \$4,464,551.
6. **Amendment No. 11 (MH121215) with Pacific Clinics** decreases Family Preservation Program funds in the amount of \$48,419 for FY 2014-15. The revised MCA is \$84,385,454.
7. **Amendment No. 9 (MH190063) with ValueOptions, Inc.**, merged with Merger Sub and has become a direct, wholly-owned, subsidiary of New Beacon.
8. **Amendment No. 3 (MH190096) with Pacific Clinics** revises the Statement of Work (Exhibit A with Exhibit A-1) to incorporate attachments to this program to better reflect the Statement of Work under Section III, Contractor's Responsibilities for FY 2014-15.
9. **Agreement (MH190124) with Step Up on Second Street, Inc.**, Drop-In Center for Transition Age Youth Services Agreement for FY 2014-15. The MCA is \$250,000.
10. **Agreement (MH200438) with New Hope Christian Counseling Foundation, Inc.**, is a Master Agreement for MHSA for FYs 2014-15 and 2015-16.
11. **Amendment No. 1 (MH200438) with New Hope Christian Counseling Foundation, Inc.**, revises the Business Associate Agreement (BAA) under the Health Insurance Portability and Accountability Act (HIPAA).
