SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 67 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of 20 new Agreements processed in the month of January 2015 as follows:

- 1. Agreement (MH050151) with Academy of Cognitive Therapy, LTD (ACT)** provision of MHSA Prevention and Early Intervention (PEI) consultant, technical assistance, and training services as a designated trainer of an Evidence-Based Practice (EBP) Program, to promote the implementation of the Individual Cognitive Behavioral Therapy (Ind CBT). ACT's total compensation amount is \$2,485,800 for Fiscal Years (FYs) 2014-15 through 2016-17.
- 2. Amendment No. 2 (MH121107) with Alcott Center for Mental Health Services** shifts \$80,000 from MHSA Urgent Care Center Non-MC Funded Program funds to MHSA Urgent Care Invoice Funded Program funds. There is no change to the Maximum Contract Amount (MCA).
- 3. Amendment No. 4 (MH121130) with Heritage Clinic and The Community Assistance Program for Seniors** shifts Field Capable Clinical Services (FCCS) MC by \$201,778 to Field Service Program (FSP) MC and FCCS Non-MC funds by \$33,620 to FSP Non-MC for FY 2014-15. There is no change to the MCA.
- 4. Amendment No. 3 (MH121132) with Jewish Family Service of Los Angeles** decreases MHSA Integrated Service Management Model (INN) MC Program funds by \$369,000 and increases MHSA INN Non-MC Program funds by \$184,500. The revised MCA is \$2,910,412 for FY 2014-15.
- 5. Amendment No. 3 (MH121149) with Providence Community Services, LLC,** decreases MHSA FSP Program (Non-MC) Funded Program funds in the amount

of \$28,253 and increases MHSA FSP (MC) Funded Program funds in the amount of \$56,506. The revised MCAs are \$7,066,554, \$6,792,263, and \$6,792,263 for FYs 2014-15, 2015-16, and 2016-17.

6. **Amendment No. 2 (MH121157) with St. Joseph Center** increases Homeless Services Non-MC Funded Program funds in the amount of \$16,241 for FY 2014-15 and \$19,505 for FY 2015-16; increases Homeless Services Invoice Funded Program funds in the amount of \$2,400 for FY 2014-15 and \$2,400 for FY 2015-16; increases Homeless Services MC Funded Program funds in the amount of \$180,000 for FY 2014-15 and \$180,000 for FY 2015-16. The revised MCA amounts are \$4,449,967 and \$1,787,138 for FY 2014-15. The MCA will remain the same for FY 2016-17.

The revised MCA is \$1,294,832 for FY 2014-15.
