SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 85 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of one new Agreement processed in the month of November 2014 as follows:

1. **Agreement (MH060065) with USC Verdugo Hills Hospital, LLC, dba USC Verdugo Hills Hospital**, this Fee-For-Service Hospital Agreement is being executed under authority delegated to the Director of Mental Health in the Board letter adopted on June 1, 2010. The term of this Agreement shall commence on September 11, 2014, and shall continue through June 30, 2015.
2. **Amendment No. 5A (MH120332) with Children's Institute, Inc.**, makes an adjustment to the Financial Summary, Exhibit A (Financial Provisions), Attachment II, Paragraph A (General), subparagraph (4)(a). There is no change to the Maximum Contract Amount (MCA).
3. **Amendment No. 2 (MH121132) with Jewish Family Services of Los Angeles** increases Mental Health Services Act (MHSA) Field Capable Clinical Services (FCCS) Funded Program funds totaling \$176,421. The revised MCA is \$3,094,912.
4. **Amendment No. 2 (MH121176) with Amanecer Community Counseling Services, Inc.**, shifts Comprehensive Share of Cost (SOC) Program Invoice Funded Program funds to Comprehensive SOC Program Non Medi-Cal Funded Program funds. There is no change to the MCA.
5. **Amendment No. 2 (MH121193) with Exodus Foundation** increases MHSA Urgent Care Center funding by \$373,141. The revised MCA is \$8,601,680.

6. **Amendment No. 3 (MH121193) with Exodus Foundation** adds a new provider number for Integrated Care Clinic, adds Mode 15 and Mode 45, and adds Mode 60 to the services provided by Integrated Care Clinic under the new provider number.
7. **Amendment No. 5 (MH121200) with Hathaway-Sycamores Child and Family Services** implements a technical correction to the Financial Summary (Attachment III) of the Agreement by correcting the amount allocated to the Specialized Foster Care Wraparound MC Funded Program, its associated Local Match Funds, and the MCA. The revised Specialized Foster Care Wraparound MC Funded Program Gross Amount is \$4,435,920; the revised Local Match Fund is \$302,086; and the revised MCA is \$40,545,450.
8. **Amendment No. 2 (MH121219) with Rosemary Children's Services**, the Contractor has entered into a Business Affiliation Agreement with Victor Treatment Center. There is no change to the MCA.
9. **Amendment No. 3 (MH180034) with Global Medical Staffing, Inc.**, increases hourly rate for Locum Tenens (LT) and revises Exhibit A "Statement of Work" and revises Exhibit B "Fee Schedule" for FYs 2014-15, 2015-16, and 2016-17.
10. **Amendment No. 3 (MH190055) with Ocean Park Community Center** increases Total Agreement Amount (TAA) to allow Contractor to provide additional on-site supportive services in a scattered site program to tenants.
11. **Amendment No. 6 (MH190075) with California State University, Long Beach, Research Foundation** extends the contract term for FY 2014-15.
12. **Amendment No. 2 (MH200263) with San Fernando Community Hospital, Inc., dba Mission Community Hospital - Panorama Campus (Assignor) and Deanco Healthcare, LLC, (Assignee)** is a Delegation and Assignment amendment. Deanco Healthcare, LLC, is now the Assignee for FYs 2014-15 and 2015-16. There is no MCA and/or Total Compensation Amount (TCA) connected with this Agreement.
