SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 28 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of three new Agreements processed in the month of December 2014 as follows:

1. **Amendment No. 9 (74144) with Sierra-Cedar** provides continued maintenance services of the Integrated System in the amount of \$4,005,095, extends the Term of the Agreement, provides an additional \$600,000 in Pool Dollars for Professional Services/Change Orders, and increases the Maximum Contract Amount (MCA) to \$36,340,646.
2. **Amendment No. 1 (MH050143) with Fairchild Consulting Services** extends the term for twelve months, to allow Provider to complete the Business Continuity Plan for DMH. There is no additional funding for the twelve months extension.
3. **Amendment No. 2 (MH050144) with California Institute for Behavioral Health Solutions** adds MHSA Prevention and Early Intervention (PEI) funding in the amount of \$147,200 for Spirituality and Mental Health training. The revised Total Compensation Amount for Fiscal Year (FY) 2014-15 is \$457,843 and for FY 2015-16 is \$482,357.
4. **Amendment No. 4 (MH121175) with Alma Family Services** increases MHSA Field Capable Clinical Services (FCCS) Non-MC/MC Funded Program funds in the amount of \$43,750. The revised MCA is \$12,022,420.
5. **Amendment No. 3 (MH121219) with Rosemary Children's Services** deletes Mode 10 from Provider Number (PN) 7374 and deletes Service Function Code (SFC) 98 from PN 7816. There is no change to the MCA.

***The following two Amendments (6 and 7) expand the definition of outreach and in-reach by including contracts with service providers with access to potential clients as valid outreach and in-reach encounters and revises the annual approval rate for submitted Medi-Cal applications to 75% of total applications submitted. There is no change to the MCA:***

7. Amendment No. 1 (MH190121) with Health Advocates, LLC

***The following two Amendments (8 and 9) increase MCA for specified Funding Sources for FY 2008-09:***

8. Amendment No. 16 (MH120267) with Telecare Corporation increases MCA by \$710,000. The revised MCA is \$11,046,401.
9. Amendment No. 4 (MH120392) with San Gabriel Children's Center increases MCA by \$70,000. The revised MCA is \$2,935,334.

***The following two Amendments (10 and 11) shift funds from Non-MC Funded Programs to Invoice Funded Program funds:***

10. Amendment No. 6 (MH121162) with Telecare Corporation shifts funds in the amount of \$378,314. There is no change to the MCA.
11. Amendment No. 3 (MH121140) with New Directions, Inc., shifts funds in the amount of \$64,218. There is no change to the MCA.

16. **Agreement (MH220020) with TurningWest, Inc.,** for FY 2014-15 through FY 2017-18. No MCA.

22. **Amendment No. 1 (MH150320) with Super Market Pharmacy** changes service delivery site from 6039 E. Florence Avenue, Bell Gardens, CA 90201, to 5985 E. Florence Avenue, Suite G, Bell Gardens, CA 90201. There is no change to the MCA.
23. **Amendment No. 1 (MH150324) with Zaher Pharmacy & Medical Supply, Inc., dba Nofel Pharmacy** changes service delivery site from 507 South Spring Street, Los Angeles, CA 90013, to 215 East 7<sup>th</sup> Street, Suite A, Los Angeles, CA 90014. There is no change to the MCA.
