SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 154 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of one new Agreement processed in the month of October 2014 as follows:

1. **Memorandum of Agreement Space Use Agreement with John Wesley Comprehensive Health Institute (JWCH)**, regarding the Rio Hondo Community Mental Health Co-Located Health Project.
2. **Amendment No. 9 (MH02272) with Providence Community Services, LLC**, implements a technical correction to shift MHSA – Full Service Partnership (FSP) Funded Program funds in the amount of \$65,840 to Senate Bill (SB) 90/Individuals with Disabilities Education Act (IDEA) (Assembly Bill [AB] 3632-Special Education Pupil [SEP]) Funded Program funds; the amount of \$65,840 was inadvertently typed on the wrong line of the Financial Summary. There is no change to the Maximum Contract Amount (MCA).
3. **Amendment No. 3 (MH120988) with Child and Family Center** implements a technical correction due to an oversight on the part of the County, intended to increase Field Capable Clinical Services (FCCS) (Medi-Cal/Healthy Families) Funded Program funds in the amount of \$8,000 and Prevention and Early Intervention (PEI) Programs (Medi-Cal/Healthy Families) Funded Program funds in the amount of \$3,000. The revised MCA is \$10,506,183.
4. **Amendment No. 11 (MH121002) with Didi Hirsch Psychiatric Service** implements a technical correction to decrease Post-Release Community Supervision-Community Reintegration Program (PRCS) (Non Medi-Cal/Non Healthy Families) funds by \$15,000 and increases PRCS (Medi-Cal/Healthy Families) funds by \$30,000. The revised MCA is \$36,627,201.

5. **Amendment No. 9 (MH121091) with Telecare Corporation** implements a technical correction by shifting funds in the FSP and FCCS categories, with a net decrease in the MCA by \$90,000. The revised MCA is \$19,533,243.
6. **Amendment No. 2 (MH121139) with Mental Health America of Los Angeles** shifts funds from FCCS to FSP in the amount of \$497,654. There is no change to the MCA.
7. **Amendment No. 4 (MH121150) with San Fernando Valley Community Mental Health Center, Inc.**, shifts MHSA Invoice Funded Program funds in the amount of \$6,981 to MHSA Family Support Services Invoice Funded Program funds in the amount of \$6,981. There is no change to the MCA.
8. **Amendment No. 1 (MH121169) with University Muslim Medical Association** decreases MHSA PEI Medi-Cal Funded Program funds in the amount of \$50,000 for Fiscal Years (FYs) 2014-15, 2015-16, and 2016-17. The revised MCA is \$692,280.
9. **Amendment No. 5 (MH121187) with Didi Hirsch Psychiatric Service** shifts funds from MHSA and PEI Funded Program from Non Medi-Cal funds to Invoice funds to enable Contractor to serve its Suicide Prevention Special Program clients. There is no change to the MCA.
10. **Amendment No. 1 (MH121193) with Exodus Foundation** increases MCA by \$1,371,422, increases MHSA Urgent Care Center Invoice Funded Program, increases MHSA Capital Facility Invoice Funded Program funds, and decreases MHSA UCC Non Medi-Cal and Post-Release Community Supervision Community Reintegration Funded program funds. The revised MCA is \$8,228,539.
11. **Amendment No. 4 (MH121195) with Five Acres-The Boys' & Girls' Aid Society of Los Angeles County** implements a technical correction to increase Specialized Foster Care (SFC) Wraparound Medi-Cal by \$180,000. The funding was inadvertently prorated mistakenly. The revised MCA is \$15,686,327.
12. **Amendment No. 2 (MH121203) with Hillside**s implements a technical correction to the Financial Summary (Attachment III) of Agreement by correcting the SFC Wraparound Medi-Cal Funded Program gross amount to \$2,247,920 and the Local Match Funds to \$153,083. The amendment will restore the two months of the allocation that was incorrectly prorated for FY 2014-15 only.
13. **Amendment No. 4 (MH190074) with Phillis Graduate Institute** extends the term of the Agreement for an additional 12 months through June 30, 2015. This

action will allow Department of Mental Health (DMH) to offer 52 Marriage and Family Therapist (MFT) stipends in return for a contractual commitment to work for one year in a hard to fill area of the County.
