SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 76 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 18 new Agreements processed in the month of August 2013 as follows:

1. **Agreement (MH9040) with Inpatient Consultants of California, Inc., A California Professional Medical Corporation dba IPC of California, Inc.,** is being executed under the Medi-Cal Professional Services Agreement. The term of the Agreement is from August 12, 2013, through June 30, 2014.
2. **Amendment No. 5 (MH120706) with Optimist Boys' Home and Ranch, Inc.,** corrects the Financial Summary Attachment. County inadvertently included \$42,432 in line 840N Healthy Way L.A. (HWLA)-Tier II One-Time instead of 830N Prevention and Early Intervention (PEI) training of the Financial Summary and Subprogram Schedule. There is no change to the Maximum Contract Amount (MCA).
3. **Amendment No. 7 (MH120891) with The Los Angeles Free Clinic dba The Saban Free Clinic** will provide 1115 Waiver Demonstration Project HWLA Tier II Specialty Mental Health Services and Client Supportive Services for MHSA Innovation Plan (INN) program Integrated Clinic Model at this site. The amendment also deletes MHSA INN and Client Supportive Services for MHSA INN Plan Programs Integrated Clinic Model from Provider Numbers (PNs) 4067 and 4068, located at 8405 Beverly Blvd., Los Angeles, CA 90048, and 5205 Melrose Ave., Los Angeles, CA 90038. There is no change to the MCA.
