SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 34 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of six new Agreements processed in the month of February 2013, as follows:

1. **Amendment No. 1 (MH050095) with KRS Edstrom** revises language in Exhibit A, Statement of Work (SOW), to include teacher training sessions under Phase II Training Module and adds report requirements, Student Stress and Anger Management (SSAM) Evaluation Report. There is no change to the Total Contract Amount (TCA).
2. **Agreement (MH101794) with Korean American Family** is being executed under the Technological Needs Projects Agreement. The term of the Agreement is from February 11, 2013, through June 30, 2016.
3. **Amendment No. 2 (MH120841) with California Institute of Health and Social Services, Inc., dba Alafia Mental Health Institute** corrects the Suite No. from 8929 S. Sepulveda Boulevard, Suite No. 200, Los Angeles, CA 90045, to 8929 S. Sepulveda Boulevard, Suite No. 201, Los Angeles, CA 90045, and corrects the dba name for Provider Number (PN) 7540 from California Institute of Health and Social Services, Inc., dba Alafia Mental Health Center to California Institute of Health and Social Services, Inc., dba Alafia Mental Health Institute. There is no change to the Maximum Contract Amount (MCA).
4. **Amendment No. 1 (MH120925) with South Bay Children's Health Center Association, Inc.**, temporarily relocates service delivery site at 1617 Cravens Avenue, Torrance, CA 90501, PN 1969, to 20725 Western Avenue, Suite 134, Torrance, CA 90501, for three months beginning, February 1, 2013, for

renovations of site. Once completed, the Service Delivery Site will revert back to the original location. There is no change in the MCA.

5. **Amendment No. 6 (MH120954) with Penny Lane Centers** implements the merger with Dubnoff Center for Child Development and Educational Therapy and Penny Lane Centers, where Penny Lane Centers assumes all Dubnoff's liabilities and audit exceptions, past, present, and future to the County. The MCA for Fiscal Year (FY) 2012-13 will be increased by various program funds specified as follows: Categorically Funded Programs: increases Specialized Foster Care-Department of Children and Family Services (DCFS) Multidisciplinary Assessment Team (MAT) Non Medi-Cal/Non Healthy Families (HF) in the amount of \$6,000; increases DCFS Child Welfare Services Medi-Cal/HF in the amount of \$17,000; adds Juvenile Justice Program Supportive Treatment Option Program (STOP) in the amount of \$39,000; adds STOP Co-occurring Disorder in the amount of \$5,000; increases Juvenile Justice Crime Prevention Act and Mental Health Screening, Assessment, and Treatment Program (JJCPA-MHSAT) in the amount of \$35,000, for County General Funds (CGF); increases Department of Mental Health (DMH) Medi-Cal/Non HF in the amount of \$4,000,000, MHSA, Prevention and Early Intervention (PEI) Non Medi-Cal/Non HF in the amount of \$24,000, consisting of \$4,000, in PEI Children funds and \$20,000, in PEI Training; increases PEI Medi-Cal/HF in the amount of \$20,000, consisting of \$9,000, in PEI Children funds in PEI Transition Age Youth (TAY) Medi-Cal funds and \$11,000, in PEI TAY HF, Unique MHSA, and adds Probation Camps in the amount of \$40,000. A new PN To Be Assigned (TBA) is added at service delivery site, 10526 Dubnoff Way, North Hollywood, CA 91606. The revised MCA is \$26,185,574, for FY 2012-13. The MCA for FY 2013-14 shall remain the same.

The following two Amendments (6 and 7) to LE Agreements replaces Service Exhibit 1048, with a technical correction of Mental Health Integration Program Model (MHIP), 1115 Waiver Demonstration Project Healthy Way L.A. (HWLA) Tier II and Specialty Mental Health Services. There is no change to the MCA:

The following two Agreements (8 and 9) are being executed under the Fee-For-Service Individual Providers for Medi-Cal Professional Specialty:

8. **Agreement (MH29452) with Kalpesh Bhavsar, M.D., Professional Services** the term of the Agreement is from January 24, 2013, through June 30, 2014.

9. **Agreement (MH29453) with Wing Ki, M.D.**, the term of the Agreement is from February 19, 2013, through June 30, 2014.

The following four Agreements (10 through 13) are being executed under the MHSA Master Agreement:

10. **Agreement (MH200386) with BREEYAH dba Vision of Wholeness** the term of the Agreement is from February 4, 2013, through June 30, 2016.
11. **Agreement (MH200388) with Destinies Global Harvest Ministries, Inc.**, the term of the Agreement is from February 22, 2013, through June 30, 2016.
12. **Agreement (MH120389) with Clare Foundation, Inc.**, the term of the Agreement is from February 26, 2013, through June 30, 2016.
13. **Agreement (MH200391) with First Presbyterian Church of Hollywood** the term of the Agreement is from February 22, 2013, through June 30, 2016.

The following four Amendments (14 through 17) to LE and Specialized Agreements add, delete, modify, Service Function Code (SFC), and/or move Service Delivery Sites. There is no change to the MCAs:

14. **Amendment No. 2 (MH120857) with For The Child, Inc.**, adds a new Service Delivery Site under Medi-Cal/Short-Doyle PN TBA, located at 3491 Elm Avenue, Long Beach, CA 90807-4430. Services provided are: Targeted Case Management Services, Mode 15, SFCs 01-09, Mental Health Services Mode 15, SFCs 10-19/30-59, Medication Support, Mode 15, SFCs 60-69, Crisis Intervention, Mode 15, SFCs 70-79, Mental Health Promotion, Mode 45, SFCs 10-19, and Community Client Services, Mode 45, SFCs 20-29.
15. **Amendment No. 4 (MH120859) with Hathaway-Sycamores Child and Family Services** deletes Therapeutic Behavioral Services (TBS), Mode 15, SFC 58, from PN 7602, and deletes Site Exhibit 3, and replaces with Exhibit 4.
16. **Amendment No. 2 (MH120914) with LeRoy Haynes Center for Children and Family Services, Inc.**, adds a new Service Delivery Site located at 1025 Sentinel Drive, Suites 200 and 206, La Verne, CA 91750, under PN 7565, deletes Attachment V, and replaces it with Exhibit 2.
17. **Amendment No. 3 (MH120945) with Counseling and Research Associates, Inc., dba Masada Homes** adds a new Service Delivery Site located at

Fedde Middle School at 21409 Elaine Avenue, Hawaiian Gardens, CA 90716-1025, PN TBD, Mode 15, SFCs 01-09, Targeted Case Management; Mode 15, SFCs 10-19/30-59, Mental Health Services; Mode 15, SFC 58, TBS; Mode 15, SFCs 70-79, Crisis Intervention; Mode 45, Outreach Services, SFC 10 Mental Health Promotion and Mode 45, SFC 20, Community Client.

The following seven Amendments (18 through 24) are being expanded and Family Support Services (FSS) Exhibit revised to provide Child Full Service Partnership (FSP), and FSS, as part of the implemented pilot program FSS Enhanced Respite Care Program, for short-term relief to caregivers that provide services to clients with Severe Emotional Disturbance (SED). There is no change to the MCA:

The following six Amendments (25 through 30) to LE and Specialized Agreements increases/decreases and/or adds MHSA FSP and Field Capable Clinical Services (FCCS), TAY, CGF, PEI, for Non Medi-Cal/Non HF and Non Medi-Cal/HF funds:

25. **Amendment No. 1 (MH120882) with Saint John's Health Center** decreases MHSA FCCS Non Medi-Cal/Non HF funds in the amount of \$60,000, and adds MHSA FCCS Medi-Cal/HF funds in the amount of \$120,000, for the Medi-Cal child population. The revised MCA's will remain the same for FYs 2012-13, 2013-14, and 2014-15, in the amount of \$2,860,714.
26. **Amendment No. 9 (MH120886) with Special Service for Groups** increases MHSA FSP slots for Older Adults; increases MHSA FSP Non Medi-Cal/Non HF in the amount of \$31,880, for each year; and increases MHSA FSP Medi-Cal/HF in the amount of \$24,000, for each year. The revised MCA's for

FYs 2012-13, 2013-14, and 2014-15, are \$35,612,123, \$35,273,219, and \$34,417,107, respectively.

27. **Amendment No. 11 (MH120912) with Hillview Mental Health Center, Inc.,** adds additional MHSA FSP Medi-Cal/HF in the amount of \$43,370. The revised MCA is \$11,116,447.
28. **Amendment No. 2 (MH120923) with Providence Community Services, LLC** decreases MHSA FSP Non Medi-Cal/Non HF in the amount of \$18,364, and increases the MHSA FSP Medi-Cal/HF in the amount of \$56,864, for Medi-Cal Child and TAY. The revised MCA is \$6,968,388.
29. **Amendment No. 4 (MH120945) with Counseling and Research Associates, Inc., dba Masada Homes** increases MHSA FCCS Medi-Cal/HF in the amount of \$28,752, and increases MHSA PEI Medi-Cal/HF in the amount of \$143,748. The revised MCA is \$12,542,894.
30. **Amendment No. 1 (MH120968) with Eggleston Youth Centers, Inc.,** decreases MHSA FCCS Child Medi-Cal/HF in the amount of \$11,502; decreases MHSA FCCS TAY Medi-Cal/HF in the amount of \$17,250; decreases MHSA PEI Program Children Medi-Cal/HF Funded Programs funds in the amount of \$57,498; decreases MHSA PEI Programs TAY Medi-Cal/HF Funded Programs funds in the amount of \$86,250; and decreases CGF DMH Medi-Cal/HF in the amount of \$51,750. The revised MCA is \$224,250.
