SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 43 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of ten new Agreements processed in the month of December 2013 as follows:

1. **Agreement (MH020045) with MedResponse, Inc.**, executed under the Patient/Client Transportation Services Agreement. The term of the Agreement is from December 2, 2013, through June 30, 2017.
2. **Amendment No. 2 (MH77676) with Netsmart Technologies, Inc.**, increases the amount of Pool Dollars available for other professional services/change notices; increases the contract sum; revises the terms and conditions, Statement of Work, and payment schedule of the Agreement; and adds and updates certain County standard terms and conditions.
3. **Administrative Amendment No. 3A (MH120921) with Pediatric & Family Medical Center dba Eisner Pediatric & Family Medical Center** deletes the current Additional Group Providers Attachment IV-2, in its entirety, and replaces it with Attachment IV-3A.

The following two Amendments (4 and 5) to LE Agreements extend the term of their current Agreement on a month-to-month basis:

4. **Amendment No. 7 (MH050049) with Los Angeles County Alliance for the Mentally Ill aka Los Angeles County Coordinating Council (LACCC)** effective January 1, 2014, and continuing on a month-to-month basis through June 30, 2014. The revised Total Compensation Amount (TCA) is \$241,926.

5. **Amendment No. 8 (MH190076) with Mental Health Advocacy Services, Inc.**, extends the term for Fiscal Year (FY) 2013-14, on a month-to-month basis, beginning January 1, 2014, through June 30, 2014. The TCA is \$202,450.

8. **Agreement (MH200419) with Los Angeles Youth Network** the term of the Agreement is from December 5, 2013, through June 30, 2016.

The following six Amendments (9 through 14) to LE and Specialized Agreements increase/decrease and/or add MHSA, Prevention & Early Intervention (PEI) Programs, Full Service Partnerships (FSP), Field Capable Clinical Services (FCCS), Post-Release Community Supervision-Community Reintegration Program (PRCS-CRP), for Non Medi-Cal/Healthy Families (HF) and Medi-Cal/HF funds:

9. **Amendment No. 11 (MH120928) with Tessie Cleveland Community Services Corporation** adds MHSA FSP Non Medi-Cal/Non HF funds in the amount of \$305,400; adds MHSA FSP Medi-Cal/HF funds in the amount of \$685,000; adds MHSA FCCS Non Medi-Cal/Non HF funds in the amount of \$34,118; and adds MHSA FCCS Medi-Cal/HF funds in the amount of \$110,133. The revised Maximum Contract Amount (MCA) is \$10,134,573.

12. **Amendment No. 8 (MH210004) with Central City Community Health Center, Inc.**, increases MHSA PEI funds for the provision of Specialty Mental Health Services in the amount of \$37,118; increases MHSA PEI funds for the provision of Team Consolation in the amount of \$3,000; and decreases MHSA PEI One-

Time Funding for staff training in the amount of \$3,000. The Estimated Maximum Amount (EMA) is \$191,319.

13. **Amendment No. 5 (MH210013) with Harbor Community Clinic** increases MHSA PEI funds for the provision of Specialty Mental Health Services in the amount of \$9,994. The revised EMA is \$93,612.
14. **Amendment No. 1 (MH210037) with Korean Health, Education, Information and Research Center** increases MHSA PEI funds for the provision of Specialty Mental Health Services in the amount of \$15,000; increases MHSA PEI funds for the provision of Team Consolation in the amount of \$5,000; and decreases MHSA PEI One-Time Funding for staff training in the amount of \$15,000. The revised MCA is \$94,692.
