SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 20 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 137 new Agreements processed in the month of January 2014 as follows:

- 1. Amendment No. 14 (MH010089) with The Regents of the University of California, Los Angeles (UCLA)** restores \$46,000 for the Post-Doctoral Training and Consultation Program, related to Addendum A, Subsection A2.5 (Additional Academic and Medical Teaching Services through Harbor-UCLA Medical Center) to cover the months of July 2013 and August 2013 services.
- 2. Agreement (MH101194) with Personal Involvement Center, Inc.,** is being executed under the Technological Needs Project Agreement. The term of the Agreement is from January 14, 2014, through June 30, 2016.
- 3. Amendment No. 1 (MH121014) with Exodus Recovery, Inc.,** adds Psychiatric Emergency Services (PES) Relief Plan Non Medi-Cal/Non Healthy Family (HF) funds in the amount of \$586,126 and \$343,094, respectively; adds PES Relief Plan to Medi-Cal/HF funds in the amount of \$872,048 and \$1,200,854, respectively, for Fiscal Years (FYs) 2013-14 and 2014-15. The revised Maximum Contract Amounts (MCAs) are \$21,661,973 and \$21,747,747, respectively. The amendment also, enables the Contractor to implement a Psychiatric Health Facility (PHF) and provides services to 16 individuals who are in need of psychiatric inpatient services; adds a new PHF location at 9808 Venice Blvd., Suite 300, Culver City, CA 90232, under a new Provider Number (PN) To Be Determined (TBD); and adds services as follows: PHF, Mode 5, Services Function Code (SFC) 20, and Life Support/Board and Care, Mode 60, SFC 40.

4. **Amendment No. 1 (MH121046) with The Los Angeles Free Clinic dba The Saban Free Clinic** decreases *Projects for Assistance in Transition from Homelessness* (PATH) McKinney funds in the amount of \$19,315. The revised MCA is \$1,846,270.
5. **Amendment No. 1 (MH121099) with VIP Community Mental Health Center, Inc., (VIP CMHC)** adds Department of Community and Senior Services (DCSS) forensic center services Non Medi-Cal/Non HF funds in the amount of \$75,000 and adds Service Exhibit 10 - Comprehensive Neuropsychological Evaluations of Elders and Dependent Adults. The revised MCA is \$7,579,440.
6. **Amendment No. 2 (MH180034) with Global Medical Staffing, Inc., dba G Medical Staffing, Inc.,** amends Agreement to reflect the business address change of Contractor for Temporary Psychiatrist from 2450 Fort Union Boulevard, Salt Lake City, UT 84121, to 3995 South 700 East, Suite 100, Salt Lake City, UT 84107.
7. **Agreement (MH655973) with AstraZeneca Pharmacy** is being executed under the Reimbursement Agreement; the term of the Agreement is from January 1, 2014, to December 31, 2016.

The following two Administrative Amendments (8 and 9) to LE Agreements enable the parties to delete Group Providers by modifying the current Additional Group Providers attachments. There is no change to the MCA:

The following three Amendments (10 through 12) to Specialized Agreements are being amended under the Service Agreement for (D-Rate) Clinical Assessment Program and revise the Service Exhibit A, Statement of Work (SOW) - Specialized Foster Care, and Service Exhibit B, Payment Schedule, to ensure Contractors (15 Assessors) are in compliance with their Agreement:

10. **Amendment No. 2 (MH030187) with Michael C. Knapp, Ph.D.,** revises Specialized Foster Care, and Service Exhibit B, Payment Schedule, to ensure

Contractors are in compliance with their Agreement. There is no change to the MCA.

11. **Amendment No. 2 (MH050133) with Rainbow Services, Ltd.**, decreases the groups required by Deliverable 2, Triple P Level 3, Discussion Groups from 100 groups to 86 groups and increases the number of sessions required by Deliverable 3, Triple P Level 2, Seminars from 10 sessions to 25 sessions. The Total Contract Amount (TCA) will decrease \$200 for FYs 2013-14, 2014-15, and 2015-16, and is \$99,800, \$99,800, and \$99,800 respectively.
12. **Amendment No. 1 (MH190102) with Sunovion Pharmaceuticals** amends Agreement to extend the term of the contract; modifies Usage Data format and requirements; and adds product Latuda 60mg. There is no change to the MCA.

The following three Agreements (13 through 15) are being executed under the MHSA Agreement funds:

17. **Amendment No. 8 (MH210002) with Antelope Valley Community Clinic** increases MHSA PEI funds in the amount of \$58,061; increases MHSA PEI funds for the provision of Team Consultation in the amount of \$5,000; and decreases MHSA PEI One-Time Funding for staff training in the amount of \$5,000. The revised Estimated Contract Amount (EMA) is \$250,157.

18. **Amendment No. 7 (MH210001) with Altamed Health Services Corporation** increases MHSA PEI funds for the provision of Specialty Mental Health Services in the amount of \$26,000; decreases MHSA PEI funds for the provision of Team Consultation in the amount of \$13,000; and decreases MHSA PEI One-Time Funding for staff training in the amount of \$13,500. There is no change to the EMA.
