

SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 38 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of nine new Agreements processed in the month of February 2014 as follows:

1. **Amendment No. 8 (MH050042) with Mental Health America of Los Angeles** increases Service Extenders Program funds in the amount of \$12,000. The revised Total Contract Amount (TCA) is \$674,800.
2. **Amendment No. 2 (MH050123) with Korean American Family Service Center, Inc.**, deletes the current Exhibit A Statement of Work (SOW) Attachment 1, in its entirety, and replaces it with Attachment 1A.
3. **Agreement (MH121051) with Multiservice Family Center, Inc.**, was superseded under the Legal Entity Agreement from January 1, 2014, through June 30, 2014.
4. **Amendment No. 1 (MH121098) with The Village Family Services** increases Specialized Foster Care-Child Welfare Services Medi-Cal/Healthy Family (HF) funds in the amount of \$150,000 for Fiscal Year (FY) 2013-14 only. The revised Maximum Contract Amount (MCA) is \$5,413,501.

23. **Amendment No. 2 (MH220005) with Congnosante, LLC**, changes business address for the Project Management Services Master Agreement from 7926 Jones Branch Drive, Suite 330, McLean, VA 22102, to 8200 Greensboro Drive, Suite 1200, McLean, VA 22102.

The revised MCA is \$4,733,099.

41. **Amendment No. 1 (MH121067) with Providence Community Services, LLC,** increases Non Medi-Cal/Non HF funds in the amount of \$8,008 for FY 2013-14 only. The revised MCA is \$7,038,280.
42. **Amendment No. 1 (MH121069) with Saint John's Health Center** increases Non Medi-Cal/Non HF funds in the amount of \$8,008 for FY 2013-14 only. The revised MCA is \$2,871,595.
43. **Amendment No. 1 (MH121070) with San Fernando Valley Community Mental Health Center, Inc.,** increases Non Medi-Cal/Non HF funds in the amount of \$8,008 for FY 2013-14 only. The revised MCA is \$33,283,344.

44. **Amendment No. 1 (MH121076) with SCHARP** increases Non Medi-Cal/Non HF funds in the amount of \$8,008 for FY 2013-14 only. The revised MCA is \$11,505,535.
45. **Amendment No. 1 (MH121078) with Special Services for Groups** increases Non Medi-Cal/Non HF funds in the amount of \$8,008 for FY 2013-14 only. The revised MCA is \$39,989,892.
46. **Amendment No. 1 (MH121080) with St. Anne's Maternity Home** increases Non Medi-Cal/Non HF funds in the amount of \$8,008 for FY 2013-14 only. The revised MCA is \$3,866,633.
47. **Amendment No. 2 (MH121099) with VIP Community Mental Health Center, Inc.,** increases Non Medi-Cal/Non HF funds in the amount of \$5,523 for FY 2013-14 only. The revised MCA is \$7,584,963.
