SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 103 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 12 new Agreements processed in the month of May 2013 as follows:

- 1. Amendment No. 5 (MH050049) with Los Angeles County Alliance for the Mentally Ill aka Los Angeles County Coordinating Council (LACCC)** extends the term of this Agreement, beginning July 1, 2013 and continuing on a month-to-month basis through December 31, 2013, to avoid a disruption in services while the Department completes its pending Statement of Eligibility and Interest (SEI) solicitation process for Consultant Services Agreement. The Total Compensation Amount (TCA) for Fiscal Year (FY) 2013-14 to cover six monthly extension periods is \$241,926.
- 2. Amendment No. 9 (MH010089) with The Regents of the University of California, Los Angeles (UCLA)** adds \$10,100 for training, consultation, and education services regarding assessment and treatment of the older adult population for FY 2012-13 only; the revised TCA is \$2,608,201. Adds \$30,300 for training, consultation, and education services regarding assessment and treatment of the older adult population for FY 2013-14 only; the revised TCA is \$2,014,547.
- 3. Administrative Amendment No. 14A (MH120736) with Children's Institute, Inc.**, rescinds Amendment No. 13 that decreases the Maximum Contract Amount (MCA). The revised MCA is reverting back to FY 2011-12 in the amount of \$20,623,763.

4. **Amendment No. 1 (MH120915) with Los Angeles Unified School District** extends the term of this Agreement for a period of three years, beginning July 1, 2013, through June 30, 2016; amends Financial Exhibit A to add language provisions to allow Contractor to provide additional Medi-Cal mental health services using Los Angeles Unified School District funds as local match at no cost to the County; and adds federal/State Revenue in the amount of \$1,750,000. The revised MCA for FY 2012-13 is \$6,139,442.
5. **Amendment No. 1 (MH120927) with Southern California Alcohol and Drug Programs, Inc.**, adds Post-Release Community Supervision (PCS) Community Reintegration Program (CRP) Non Medi-Cal/Non Healthy Families (HF) funds in the amount of \$19,490 to enable Contractor to provide Institutions for Mental Diseases (IMD) Step-Down services to new clients under PCS, CRP; increases County General Funds (CGF), Medi-Cal/HF funds in the amount of \$40,000; decreases CGF Non Medi-Cal/Non HF funds in the amount of \$20,000; and adds Exhibit No. 6 to the Agreement. The revised MCA is \$239,490.
6. **Amendment No. 5 (MH190075) with California State University, Long Beach Research Foundation (CSULBRF)** extends the term of this Agreement for an additional 12 months beginning July 1, 2013 through June 30, 2014, to continue offering Masters of Social Work (MSW) and four Psychiatric Nurse Practitioner (NP) stipends in return for a contractual commitment to work for one year in a hard to fill area of the County and replaces Health Insurance Portability and Accountability Act (HIPAA) for FY 2013-14 only. There is no change to the MCA.

The following two Amendments (7 and 8) to LE Agreements add, increase/decrease Juvenile Justice Program (JJP), Title IV-E-Functional Family Therapy (FFT), Non Medi-Cal/Non HF and Medi-Cal/HF funds:

7. **Amendment No. 6 (MH120960) with Star View Adolescent Center, Inc.**, adds Non Medi-Cal/Non HF funds in the amount of \$15,000 and increases Medi-Cal/HF funds in the amount of \$60,000 for FY 2012-13 only. The revised MCA is \$35,441,108.
8. **Amendment No. 5 (MH120956) with SHIELDS For Families** increases Non Medi-Cal/Non HF funds in the amount of \$20,000 and increases Medi-Cal/HF funds in the amount of \$100,000 for FY 2012-13 only. The revised MCA is \$13,268,588.

The following two Agreements (9 and 10) are being executed under the Fee-For-Service Group Agreement:

9. **Agreement (MH9037) with Renew Behavioral Health Medical Corporation dba Renew Behavioral Health, Inc.,** the term of the Agreement is from April 22, 2013, through June 30, 2014.
10. **Agreement (MH9038) with Circle of Help Foundation,** the term of the Agreement is from May 21, 2013, through June 30, 2014.

The following two Agreements (11 and 12) are being executed under the Technological Needs Project Funding Agreement:

11. **Agreement (MH100200) Penny Lane Centers,** the term of the Agreement is from May 1, 2013 through June 30, 2016.
12. **Agreement (MH100216) with Stirling Academy, Inc.,** the term of the Agreement is from May 7, 2013 through June 30, 2016.

The following two Amendments (13 and 14) to LE Agreement enter an agreement with the Los Angeles County Children and Families First-Proposition 10 Commission aka First 5 LA to accept funds for Parent-Child Interaction Therapy (PCIT) through June 30, 2017:

13. **Amendment No. 15 (MH120886) with Special Service for Groups** adds First 5 LA funds in the amount of \$25,000. The revised MCA is \$37,578,705 for FY 2012-13 only.
14. **Amendment No. 4 (MH120910) with Hamburger Home dba Aviva Family and Children's Services dba Aviva Center** adds First 5 LA funds in the amount of \$25,000. The revised MCA is \$11,622,465 for FY 2012-13 only.

The following two Amendments (15 and 16) to LE Agreements are being amended to roll over unspent funds to provide Substance Abuse and Mental Health Services Administration (SAMHSA) for Project ABC Family Wellness Network to existing Amendments:

15. **Administrative Amendment No. 13 (MH120736) with Children's Institute, Inc.,** rolls over unspent funds in the amount of \$65,653 from Agreement MH120846 to Agreement MH120736 through executed Post-Term Amendment No. 4 (MH120846) for FY 2012-13. The revised MCA is \$20,558,110 for FY 2012-13 for Agreement MH120736.

16. **Amendment No. 4 (MH120846) with Children's Institute, Inc.**, decreases funds in the amount of \$65,653 for Agreement MH120736 for FY 2011-12 and increases Non Medi-Cal/Non HF funds in the amount of \$65,653 for FY 2012-13 only. The revised MCA is \$21,807,198.

The following three Amendments (17 through 19) are being executed under the Katie A. Strategic Plan to provide Wraparound Services and increase Specialized Foster Care-Child Welfare Services:

17. **Amendment No. 6 (MH120846) with Children's Institute, Inc.**, increases Medi-Cal/HF funds in the amount of \$200,000. The revised MCAs for FYs 2012-13, 2013-14, and 2014-15, are \$22,007,198, \$21,818,995, and \$21,818,995, respectively.

59. **Amendment No. 4 (MH120891) with The Los Angeles Free Clinic dba The Saban Free Clinic** increases MHSA INN Non Medi-Cal/Non HF funds in the amount of \$58,187; increases MHSA INN Medi-Cal/ HF funds in the amount of \$68,960; and modifies the current Financial Summary Subprogram Schedule for FY 2012-13 only. The revised MCA is \$1,477,455.
60. **Amendment No. 2 (MH120897) with Vista Del Mar Child and Family Services** increases FCCS Non Medi-Cal/Non HF funds in the amount of \$7,788 and increases FCCS Medi-Cal/HF funds in the amount of \$62,314 for FY 2012-13 only. The revised MCA is \$11,354,158.
61. **Amendment No. 13 (MH120912) with Hillview Mental Health Center, Inc.,** decreases MHSA FSP Non Medi-Cal/Non HF funds in the amount of \$70,000 and increases MHSA FSP Medi-Cal/HF funds in the amount of \$140,000 for FY 2012-13 only. The revised MCA is \$11,475,137.
