SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 68 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 11 new Agreements processed in the month of April 2012, as follows:

- 1. Amendment No. 3 (MH050038) with California Mental Health Directors Association** adds Mental Health Services Act (MHSA) – Prevention and Early Intervention (PEI) funds in the amount of \$11,623 to the Total Compensation Amount (TCA), with a revised TCA of \$336,000.
- 2. Amendment No. 1 (MH050041) with Triple P America, Inc.,** for Fiscal Year (FY) 2011-12, through FY 2012-13, increases the MHSA funds in the amount of \$462,993, with a revised TCA of \$2,777,993.
- 3. Amendment No. 3 (MH050045) with Pacific Clinics** extends the term of this Agreement for a period of 12 months, beginning July 1, 2012, through June 30, 2013, and adds MHSA Workforce Education and Training (WET) funds for the Mental Health Rehabilitation Specialist Training Program in the amount of \$400,000, with a revised TCA of \$400,000.
- 4. Agreement (MH050054) with The Regents of the University of Washington School of Medicine AIMS Center (UW)** is being executed as a MHSA-PEI Consultant Services Agreement.
- 5. Amendment No. 4 (MH120714) with Step Up on Second Street, Inc.,** changes the name of Provider Number 7526 from Assertive Community Treatment Program to Step Up on Second Street – FCCS Plus, with no change to the Maximum Contract Amount (MCA).

6. **Amendment No. 5 (MH120727) with Braswell Rehabilitation Institute for Development of Growth and Education Services, Inc.**, shifts funds in the amount of \$50,000 from MHSA Institution for Mental Disease (IMD) Step-Down (Medi-Cal/Healthy Families) to MHSA Wellness Centers (Medi-Cal/Healthy Families). The MCA will remain the same at \$2,481,656.
7. **Amendment No. 8 (MH120735) with Childrens Hospital Los Angeles** for FY 2011-12 increases the Specialized Foster Care – Child Welfare Services (Medi-Cal/Healthy Families) Funded Program in the amount of \$600,000 to provide Enhanced Mental Health Services under the Katie A. Strategic Plan, with a revised MCA of \$13,566,195.
8. **Amendment No. 11 (MH120736) with Children’s Institute, Inc.**, increases the Project ABC Wellness Network grant funds in the amount of \$65,175 as a rollover and \$146,321 for FY 2011-12 for a total of \$211,496, with a revised MCA of \$20,623,763.
9. **Amendment No. 4 (MH120757) with For The Child, Inc.**, increases Project ABC Family Wellness Network grant funds in the amount of \$11,646, with a revised MCA of \$1,964,620 for FY 2011-12.
10. **Amendment No. 6 (MH120758) with Gateways Hospital and Mental Health Center** adds \$140,986 in IMD Step-Down services to Post-Release Community Supervision clients, with a revised MCA of \$17,894,077.
11. **Amendment No. 8 (MH120766) with Hillview Mental Health Center, Inc.**, for FY 2011-12 only, Transition Age Youth (TAY) Full Service Partnerships (FSP) Funded Program, Medi-Cal/Healthy Families is increased in the amount of \$192,014, and TAY FSP Funded Program, Non Medi-Cal/Indigent is decreased in the amount of \$17,650, with a revised and increased MCA of \$10,080,535.

18. **Amendment No. 5 (MH120809) with The Guidance Center** MHSA FSP (Non Medi-Cal/Non Healthy Families) funds in the amount of \$130,000 are shifted to MHSA FSP (Medi-Cal/Healthy Families) funds for FY 2011-12, with no change to the MCA.
19. **Agreement (MH120831) with Eldorado Community Service Center** is being executed as a new LE Agreement.
20. **Agreement (MH190085) with Volunteers of America Los Angeles (VOALA)** is being executed as a new MHSA Housing Trust Fund Agreement.
21. **Amendment No. 1 (MH190085) with Volunteers of America Los Angeles (VOALA)** amends the Agreement to Contractor's Obligations in order to comply with its obligations as a Business Associate under the Health Insurance Portability and Accountability Act (HIPAA) of 1996.
22. **Agreement (MH210030) with City of Pasadena, Public Health Department**, is being executed as an 1115 Waiver Demonstration Project Partner Agreement.
23. **Agreement (MTC442392) with Astrazeneca, Inc.**, is being executed using delegated authority granted in Recommendation 6 of the December 18, 2007, Board letter on Pharmaceutical rebates. The term of this Agreement shall commence on January 1, 2012, and shall continue through December 31, 2013.

There is no County cost for this contract. Each rebate is not contingent on purchases but to permit their products to be on DMH formulary.
