SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 35 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of eight new Agreements processed in the month of January 2013, as follows:

- 1. Amendment No. 7 (MH010089) with The Regents of the University of California, Los Angeles (UCLA)** adds Post-Doctoral Training and Consultation Program related to Addendum A, Subsection A2.5 (Additional Academic and Medical Teaching Services through Harbor-UCLA Medical Center), to obtain services of an additional Post-Doctoral Psychology fellow in the amount of \$41,000, with the revised Maximum Contract Amount (MCA) of \$4,667,204.
- 2. Amendment No. 8 (MH010089) with The Regents of the University of California, Los Angeles (UCLA)** reduces \$320,000 for the Peer Employment, Education and Recovery Support (PEERS) Programs, related to Addendum A, Subsection A2.6 (Additional Academic and Medical Teaching Services for Recovery-Oriented Education and Training).
- 3. Agreement (MH010098) with Fuller Theological Seminary** is being executed under the Affiliation Agreement For Student Professional Development. The term of this Agreement will be January 2, 2013, through June 30, 2017.
- 4. Agreement (MH100213) with South Bay Children's Health Center Association, Inc.**, is being executed under the Technological Needs Projects. The term of this Agreement will be January 8, 2013, through June 30, 2016.

5. **Amendment No. 1 (MH120892) with The Los Angeles Gay and Lesbian Community Services Center dba L.A. Gay and Lesbian Center** makes a technical correction to add MHSA Innovation – Integrated Clinic Model; One-Time Expense Associated with Starting a new MHSA Innovation Program; Client Supportive Services for MHSA Innovation Plan Programs Integrated Clinic Model; Targeted Case Management Services (Rehab. Option); Mental Health Services (Rehab. Option); Crisis Intervention Services (Rehab. Option); and 1115 Waiver Demonstration Project Healthy Way L.A. (HWLA) Tier II Specialty Mental Health Services for adults (19-64 Years Old).
6. **Amendment No. 2 (MH120911) with Heritage Clinic and The Community Assistance Program for Seniors** increases MHSA Full Service Partnership (FSP) Non Medi-Cal/Healthy Families (HF) in the amount of \$495 and increases MHSA FSP Medi-Cal/HF in the amount of \$180,000, with a revised MCA of \$4,263,544.
7. **Amendment No. 3 (MH120936) with WISE & Healthy Aging** rescinds Amendment No. 2 that increases the MCA to enable Contractor to provide Non Medi-Cal/Non HF services to new or additional eligible HWLA enrollees. The rescission of Amendment No. 2 is necessary because Contractor does not wish to participate in providing services to new or additional eligible HWLA enrollees and County has agreed to grant Contractor's request. The MCA will revert back to \$380,251.
8. **Amendment No. 4 (MH120954) with Penny Lane Centers** defunds MHSA Programs – Unique MHSA Programs – Probation Camps for Fiscal Years (FYs) 2012-13 and 2013-14 in the amount of \$100,000, with a revised MCA for FY 2012-13 for \$25,419,574, and FY 2013-14 for \$24,949,923.
9. **Amendment No. 5 (MH120954) with Penny Lane Centers**, Provider Number (PN) 6863, consolidates its service delivery site mailing address from three current street addresses into one street address which is located at 15305 Rayen Street, North Hills, CA 91343. There is no change to the MCA.
10. **Amendment No. 4 (MH120959) with St. Joseph Center** increases MHSA Field Capable Clinical Services (FCCS) Medi-Cal/HF in the amount of \$80,000; increases MHSA Innovation Non Medi-Cal/Non HF in the amount of \$70,000; decreases MHSA FCCS Non Medi-Cal/Non HF in the amount of \$40,000; decreases MHSA Innovation Medi-Cal/HF in the amount of \$140,000; and shifts MHSA Prevention and Early Intervention Programs (PEI) Non Medi-Cal/Non HF from PEI Training to PEI Older Adult in the amount of \$86,000, with a revised MCA of \$3,585,572.

11. **Amendment No. 9 (MH120965) with Telecare Corporation** shifts \$150,000 from FCCS to FSP. There is no change to the MCA.
12. **Agreement (MH190105) with HealthView, Inc., dba Harbor View House** is being executed under the Settlement Agreement. The term of this Agreement will be January 7, 2013, through June 30, 2013.

The following two Amendments (13 and 14) to Fee-For-Service Group Agreements modify the current Financial Summary Subprogram Schedule (Attachment VIII). This Administrative Amendment shall not result in a change in the MCA:
