SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 21 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 10 new Agreements processed in the month of August 2012, as follows:

1. **Agreement (MH9035) with Ultimate Lifestyle Center** is being executed under the Fee-For-Service Group Agreement. The term of the Agreement is August 23, 2012, through June 30, 2014.
2. **Agreement (MH050109) with University of California, San Diego**, is being executed under the Consultant Services Agreement. The term of the Agreement is July 17, 2012, through December 31, 2014.
3. **Agreement (MH100120) with FamiliesFirst, Inc.**, is being executed under the Technological Needs Project Agreement. The term of the Agreement is August 17, 2012, through June 30, 2016.
4. **Amendment No. 1 (MH120918) with Mental Health America of Los Angeles** decreases MHSA Full Service Partnerships (FSP) (Non Medi-Cal/Non Healthy Families (HF)) in the amount of \$399,057 and increases MHSA FSP Medi-Cal/HF in the amount of \$798,114, with a revised Maximum Contract Amount (MCA) of \$17,335,430.
5. **Amendment No. 1 (MH120954) with Penny Lane Centers** adds California Work Opportunity and Responsibility to Kids (CalWORKs) in the amount of \$673,471, with a revised MCA of \$25,049,923.

6. **Amendment No. 2 (MH120965) with Telecare Corporation** for Fiscal Years (FYs) 2012-13 and 2013-14, adds County General Funded (CGF) Institutions for Mental Disease (IMD) Step Down Non Medi-Cal/Non HF in the amount of \$659,020, with a revised MCA for FY 2012-13 of \$12,298,904 and for FY 2013-14, with a revised MCA of \$11,221,904.
7. **Amendment No. 2 (MH150292) with Pacific Healthcare Pharmacy, Inc., dba B&B Pharmacy** correction to the name of the Contractor from Pacific Healthcare Pharmacy, Inc., dba B&B Pharmacy to Pacific Healthcare, Inc., dba B&B Pharmacy. There is no change to the MCA.
8. **Agreement (MH150293) with Hygeia Apothecary, Inc.**, is being executed under the Pharmacy Agreement. The term of the Agreement is August 7, 2012, through June 30, 2015.
9. **Agreement (MH210029) with City of Long Beach, Department of Health and Human Services** is being executed under the 1115 Waiver Demonstration Project Community Partner Agreement. The term of the Agreement is July 1, 2012, through December 31, 2014.

The following two (2) Amendments (10 and 11) to LE Agreements add or delete Service Delivery Site:

10. **Amendment No. 1 (MH120862) with Helpline Youth Counseling, Inc.**, adds Mode 15, Service Function Codes (SFCs) 60-69 (Medication Support) to Provider No. 7574, located at 12440 E. Firestone Blvd., Suite 1000, Norwalk, CA 90650. There is no change to the MCA.

Avalon Boulevard, Los Angeles, CA 90011 to SSG Weber Community Center located at 5849 Crocker Street, Los Angeles, CA 90003. There is no change to the MCA.
- 17. Amendment No. 1 (MH120966) with Eldorado Community Service Center** adds a new service location at 2272 Pacific Avenue, Suite A, Long Beach, CA 90806 and 100 E. Market Street, Long Beach, CA 90805, under new Provider No. To Be Determined (TBD). There is no change to the MCA.
