SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 69 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of three new Agreements processed in the month of November 2012, as follows:

1. **Amendment No. 1 (MH029446) with Meza Mental Health Services, Inc.**, changes legal name from George J. Meza, LCSW, to Meza Mental Health Services, Inc.
2. **Amendment No. 1 (MH040104) with LAMP, Inc.**, adds Contractor's Obligations as a Business Associate under the Health Insurance Portability and Accountability Act of 1996.
3. **Agreement (MH060064) with Long Beach Memorial Medical Center dba Community Hospital Long Beach** is being executed under Fee-For-Services Hospital Agreement. The term of the Agreement is from July 16, 2012, through June 30, 2015.
4. **Amendment No. 2 (MH120858) with Gateways Hospital and Mental Health Center** increases the Maximum Contract Amount (MCA) to enable Contractor to provide four additional inpatient acute indigent beds under the Psychiatric Emergency Services (PES) Relief Plan Non Medi-Cal/Non Healthy Families (HF) funds by \$949,000, with the revised MCA of \$19,173,830.

It will include Mode 15, SFCs 01-09, Targeted Case Management Services; Mode 15, SFCs 10-19/30-59, Mental Health Services (MHS); Mode 15, SFCs 70-79, Crisis Intervention, Mode 45, SFCs 10-19, Mental Health Promotion, and Mode 45, SFCs 20-29 Community Client Services. There is no change to the MCA.
11. **Amendment No. 7 (MH120912) with Hillview Mental Health Center, Inc.**, adds Outpatient Service Mode 15 – Targeted Case Management Service; and Mode 15, SFCs 01-09; MHS with Psychiatric Testing Mode 15, SFCs 10-19/30-59; Medication Support, Mode 15, SFCs 60-69; Crisis Intervention Mode 15, SFCs 70-79; Outreach Services Mode 45, Mental Health Promotion Mode 45, SFCs 10-19; and Community Client Services, Mode 45, SFCs 20-29, to PN 6758. There is no change in the MCA.

15. **Amendment No. 5 (MH120924) with San Fernando Valley Community Mental Health Center, Inc.**, shifts \$26,065 from PEI Non Medi-Cal/Non HF Training to PEI Adult Non Medi-Cal/Non HF Community Outreach Services. There is no change in the MCA.
16. **Amendment No. 2 (MH120954) with Penny Lane Centers** increases the Second Chance Grant funds in the amount of \$69,700 to the Juvenile Justice Program Family Function Therapy (FFT) Non Medi-Cal/Non/HF Funded Program. The revised MCA will be \$25,119,623.
17. **Amendment No. 3 (MH120956) with Shields for Families** increases Federal Grant funds for the Second Chance Act for Adult and Juvenile Offenders for the FFT services Non Medi-Cal/Non HF funded program through December 31, 2012, in the amount of \$184,000. The revised MCA will be \$13,148,588.
18. **Amendment No. 1 (MH120963) with SunBridge Harbor View Rehabilitation Center dba Harbor View Adolescent Center** decreases Medi-Cal HF funding in the amount of \$623,937, and also deleted PN 7180, located at 490 W. 14<sup>th</sup> Street, Long Beach, CA 90813. The revised MCA will be \$5,010,391.
