SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 164 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of five (5) new Agreements processed in the month of January 2012, as follows:

1. **Amendment No. 3 (MH9018) with Traditions Psychology Group, Inc., dba Traditions Behavioral Health** enables the parties to add and/or delete Providers from the Additional Group Providers through an administrative amendment process.
2. **Agreement (MH020032) with Impulse Ambulance, Inc.,** is being executed under Patient/Client Transportation Services. The term of this Agreement is from January 17, 2012, through June 30, 2012.
3. **Amendment No. 3 (MH120706) with Optimist Boys' Home and Ranch, Inc.,** adds Specialized Foster Care – Department of Children and Family Services (DCFS) Multidisciplinary Assessment Team (MAT) (Non Medi-Cal/Non Healthy Families (HF)) funds in the amount of \$36,000 and the Specialized Foster Care – Child Welfare Services (Medi-Cal/HF Only) funds in the amount of \$144,000, for a combined total of \$180,000, with the revised Maximum Contract Amount (MCA) of \$6,083,983.
4. **Amendment No. 2 (MH120707) with Penny Lane Centers** adds for Fiscal Year (FY) 2011-12 only, U.S. Department of Justice 2<sup>nd</sup> Chance Grant \$66,000, for the provision of Mental Health Functional Family Therapy (FFT) services for incarcerated youth and their families, with a revised MCA of \$20,732,557.

14. **Amendment No. 2 (MH120809) with The Guidance Center** increases California Work Opportunity and Responsibility to Kids (CalWORKs) in the amount of \$50,000, with a revised MCA of \$11,967,655.
