SUBJECT: MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 47 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of eight (8) new Agreements processed in the month of December 2010, as follows:

1. **Agreement (MH9028) with LaVelle Youth Homes** is a Fee-For-Service (FFS) Group Agreement being executed under delegated authority. The term of this Agreement shall commence on December 21, 2010, through June 30, 2014.
2. **Amendment No. 22 (MH010054) with The Regents of the University of California, Los Angeles (UCLA)** increases MHSA Prevention and Early Intervention (PEI) funding by \$120,045 for the expansion of services related to Addendum A, sub-section A2.6. The revised total funding for Addendum A will be \$2,284,247, and the revised Total Contract Amount for Fiscal Year (FY) 2010-11 will be \$3,730,697.
3. **Amendment No. 4 (MH120584) with San Fernando Valley Community Mental Health Center, Inc.**, intends to add Mode 15, Service Function Codes (SFCs) 30-39 (Psychological Testing) at a rate of \$2.61 to Provider Numbers (PNs) 7320 and 7485.
4. **Amendment No. 6 (MH120586) with South Central Health and Rehabilitation Program (SCHARP)** decreases MHSA Field Capable Clinical Services (FCCS) Medi-Cal/Healthy Families (HF) Funded Program in the amount of \$240,138, and increases MHSA FCCS Non-Medi-Cal/Indigent Funded Program in the amount of \$92,237. The Maximum Contract Amount (MCA) will decrease by \$147,901; the revised MCA will be \$7,183,025.

5. **Amendment No. 7 (MH120586) with SCHARP** decreases MHSA Full Service Partnership (FSP) Adult Non-Medi-Cal/Indigent Funded Program in the amount of \$18,654, and increases MHSA FCCS Medi-Cal/HF Funded Program in the amount of \$334,000. The MCA will increase by \$315,346; the revised MCA will be \$7,498,371.
6. **Amendment No. 3 (MH120630) with Florence Crittenton Services of Orange County, Inc., dba Crittenton Services for Children and Families** changes the following Provider names to Crittenton Services for Children and Families: Crittenton Child Family-Lynwood (PN 7661), Crittenton Child and Family-Chapman (PN 7518), Crittenton Child and Family-Harbor (PN 7523), Crittenton Child and Family-Valley View (PN 7524), Crittenton Child and Family-Brookdale (PN 7554), Crittenton Child and Family-Pomona (PN 7659), and Crittenton Family Center (PN 7605). The MCA and the PNs shall remain the same.
7. **Amendment No. 7 (MH120664) with SHIELDS For Families** includes the United States Department of Justice, Office of Justice Programs called Second Chance Act – Adult and Juvenile Offender Reentry Demonstration Grant and adds funds to the Juvenile Justice Program – Functional Family Therapy in the amount of \$115,500. The Program will serve high-risk, high-need youth experiencing Juvenile Justice involvement and will implement provisions of the Countywide Gangs and Violence Reduction Initiative.
8. **Agreement (MH200097) with Center for Empowering Minds, Inc.**, is being executed to be added to the MHSA Master Agreement list beginning December 6, 2010 through June 30, 2011.
9. **Amendment No. 1 (MH200097) with Center for Empowering Minds, Inc.**, provides revised language regarding Contractor's Obligations as a Business Associate Under the Health Insurance Portability and Accountability Act (HIPAA) of 1996, and the Health Information Technology for Economic and Clinical Health Act (HITECH) to bring the Agreement into compliance with changes in HIPAA laws and regulations.
10. **Amendment No. 2 (MH200097) with Center for Empowering Minds, Inc.**, adds new provisions to the Agreement pursuant to the new Ordinance No. 2009-0026 (Los Angeles County Code 2.206), Defaulted Property Tax Reduction Program.

The following two (2) Amendments (11 and 12) to LE Agreements increase/decrease General Relief Opportunities for Work (GROW) funding for FY 2010-11:

11. **Amendment No. 3 (MH120599) with Alma Family Services** increases by \$5,000; the revised MCA will be \$7,003,750.
12. **Amendment No. 5 (MH120664) with SHIELDS For Families** decreases by \$5,000; the revised MCA will be \$9,389,510.

The following two (2) Amendments (13 and 14) to LE Agreements increase/decrease Other Mental Health Services (MHS) for clients under the age of 21 years Medi-Cal/HF Funded Program for FY 2010-11:

13. **Amendment No. 5 (MH120582) with PROTOTYPES, Centers for Innovation in Health, Mental Health and Social Services** decreases by \$74,999; the revised MCA will be \$6,210,003.
14. **Amendment No. 3 (MH120631) with Foothill Family Service** increases by \$74,999; the revised MCA will be \$11,346,909.

The following two (2) Amendments (15 and 16) to LE Agreements change the following providers' addresses:

15. **Amendment No. 5 (MH120599) with Alma Family Services** changes from 9140 Whittier Boulevard, Pico Rivera, CA 90660 to 9101 Whittier Boulevard, Pico Rivera, CA 90660, under the existing PN 7019. There is no change to the MCA.
16. **Amendment No. 8 (MH120654) with Pacific Clinics** changes from 1126 North Grand Avenue, Covina, CA 91724 to 1126 North Grand Avenue, Suite D, Covina, CA 91724. There is no change to the MCA.
