SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 99 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 79 new Agreements processed in the month of May 2011, as follows:

1. **Agreement (MH050049) with The Los Angeles County Alliance for the Mentally Ill aka Los Angeles County Coordinating Council (LACCC)** is being executed under the New Consultant Services Agreement for MHSA – Prevention and Early Intervention (PEI). The term of the Agreement will be from May 26, 2011 through June 30, 2012.
2. **Agreement (MH190068) with Bristol-Myers Squibb Company** is being executed under the Pharmaceutical Rebate Agreement. The term of the Agreement will be from January 1, 2011 through March 31, 2013.
