SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 61 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 18 new Agreements processed in the month of August 2011, as follows:

1. **Agreement (MH101227) with David and Margaret Home, Inc.**, is being executed under the Technological Needs Funding Agreement. The term of the Agreement will be from August 24, 2011, through June 30, 2016.
2. **Agreement (MH160211) with Windsor Hall Care Home** is being executed under the Community Care Residential Facility Agreement. The term of the Agreement will be from July 1, 2011, through June 30, 2014.
3. **Agreement (MH190092) with Patton State Hospital** is being executed under the State Hospital Patient/Client Transportation Support Services Agreement. The term of the Agreement will be from July 1, 2011, through June 30, 2014.
4. **Amendment No. 2 (MH050042) with Mental Health America of Los Angeles** adds Prevention and Early Intervention (PEI) One-Time funding in the amount of \$100,000 to extend the current Adult System of Care Service Extender "Wellness Outreach Workers" Program for Fiscal Year (FY) 2011-12, with a revised Total Contract Amount (TCA) of \$630,800.
5. **Amendment No. 2 (MH060052) with Prime Healthcare Services – Encino, LLC, dba Encino Hospital Medical Center** adds Psychiatric Mobile Response Team (PMRT) Psychiatric Outreach Diversion Program (PDP) services from July 1, 2011, through June 30, 2015.

6. **Amendment No. 7 (MH120621) with Drew Child Development Corporation, Inc.**, corrects the address of Provider Number (PN) 7721 which was inadvertently listed as Suite #525 instead of Suite #550 in the Service Delivery Exhibit in the Agreement for FY 2010-11.
7. **Amendment No. 2 (MH120703) with Jewish Family Services of Los Angeles** deletes PNs 7725 and 7728 service delivery sites located at 2114 Artesia Blvd., Redondo Beach, CA 90276 and 15519 Crenshaw Blvd., Gardena, CA 90249; deletes Targeted Case Management, Mode 15, Service Function Codes (SFCs) 01-09; Mental Health Services (MHS), Mode 15, SFCs 10-19/30-59; Medication Support, Mode 15, SFCs 60-69; Crisis Intervention, Mode 15, SFC 70-79; and Community Client, Mode 45, SFCs 20-29.
8. **Amendment No. 1 (MH120735) with Childrens Hospital Los Angeles** adds California Work Opportunity and Responsibility To Kids (CalWORKs) funding on a month-to-month basis for the six months of FY 2011-12, beginning July 1, 2011, through December 31, 2011, to allow contract negotiations to be finalized for the CalWORKs solicitation process. For FY 2011-12 only, the Maximum Contract Amount (MCA) shall be increased by \$197,500, with a revised MCA of \$12,112,609.
9. **Amendment No. 2 (MH120742) with Didi Hirsch Psychiatric Service** adds MHSA PEI Non Medi-Cal/Non Healthy Families (HF) Program funds in the amount of \$10,000, with a revised MCA of \$26,840,751.
10. **Amendment No. 4 (MH120742) with Didi Hirsch Psychiatric Service** increases and decreases various program funds to meet client needs at the Glendale Facility acquired from bankrupted Verdugo, May 21, 2011. The program funds impacted include: Specialized Foster Care (SFC), County General Funds (CGF), MHSA Full Service Partnership (FSP), Field Capable Clinical Services (FCCS) and Wellness. The net result is an increase of \$386,031, with a revised MCA of \$27,476,782.
11. **Amendment No. 1 (MH120808) with The Children's Center of the Antelope Valley** makes technical corrections to Financial Exhibit A (Financial Provisions), Attachment II, Paragraph N (Cash Flow Advance (CFA) in expectation of services/activities to be rendered), Subparagraph (8)(a) of the Agreement to correct the amount of monthly CFA that Contractor may request, which may not exceed 1/12th of the MCA.
