SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 71 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of ten (10) new Agreements processed in the month of April 2010, as follows:

1. **Amendment No. 8 (MH050011) with California Mental Health Directors Association** adds MHSA by \$20,000 to the Total Compensation Amount (TCA). The revised TCA will be \$312,327.
2. **Amendment No. E4 (MH050013) with California Institute for Mental Health** adds Katie A. Enhanced Specialized Foster Care funds by \$326,000 and MHSA Full Service Partnership (FSP) by \$80,000. The revised TCA will be \$1,163,700.
3. **Amendment No. 2 (MH120287) with Tri-City Mental Health Center** increases Non-Early and Periodic Screening, Diagnosis and Treatment (EPSDT) – Federal Financial Participation (FFP) by \$448,262; EPSDT FFP by \$268,108 and decreases EPSDT – State General Funds (SGF) by \$294,468. The revised Maximum Contract Amount (MCA) will be \$4,396,174.
4. **Amendment No. 3 (MH120316) with AIDS Project Los Angeles** changes the Provisional Rate from Negotiated Rates to Cost Report for Fiscal Year (FY) 2008-09 for Outreach Services (Mode 45, Service Function Codes (SFCs) 10-19 and 20-29). There is no change in the MCA.
5. **Amendment No. 6 (MH120432) with Braswell Rehabilitation Institute for Development of Growth and Educational Services, Inc. (BRIDGES)** adds Crisis Intervention (Mode 15, SFCs 70-79) under existing Provider Number (PN) 7595.

6. **Amendment No. 7 (MH120437) with Children's Bureau of Southern California** intends to reflect a technical correction to transfer \$6,900 from Planning Outreach Engagement (POE) funds to Field Capable Clinical Services (FCCS) funds. There is no change to the MCA.
7. **Amendment No. 5 (MH120447) with Exodus Recovery, Inc.**, revises the Statement of Work (SOW) to increase by \$370,000; the total amount of one-time costs that may be claimed shall be increased from \$496,687 to \$866,687 to reflect the additional funds that may be claimed for tenant improvements. There is no change in the MCA.
8. **Amendment No. 4 (MH120459) with Institute for Multicultural Counseling & Education Services (I.M.C.E.S.)** allows for additional services to be provided under the MHSA FCCS by \$18,272. The revised MCA will be \$2,441,419.
9. **Amendment No. 4 (MH120468) with Olive Crest Treatment Centers, Inc.**, decreases Specialized Foster Care Funded – Intensive In-Home Services Program Medi-Cal/Healthy Families (HF) by \$160,000. The revised MCA will be \$2,307,870.
10. **Amendment No. 7 (MH120477) with Social Model Recovery Systems, Inc.**, adds Client Supportive Services (Mode 60, SFCs 70, 71, 72, 75 and 78) (Cost Reimbursement) to PN 7131 and also deletes Day Treatment services (Mode 10, SFC 95). There is no change to the MCA.
11. **Amendment No. 9 (MH120478) with Special Service for Groups (SSG)** adds funding as a sole source funding allocation by \$15,152, \$90,909 and \$75,757 for FYs 2009-10, 2010-11, and 2011-12. The revised MCAs for FYs 2009-10, 2010-11 and 2011-12 are \$25,383,304, \$25,609,061 and \$23,616,790.
12. **Amendment No. 4 (MH120484) with The Los Angeles Child Guidance Clinic** effective February 1, 2010, the State of California Department of Mental Health (SDMH) anticipated implementing the transition of the SDMH Medi-Cal claiming system to comply with the Health Insurance Portability and Accountability Act (HIPAA) of 1996 in Los Angeles County. This amendment is to provide additional Cash Flow Advances (CFA) for up to four (4) additional months.
13. **Amendment No. 1 (MH190062) with Venice Family Clinic** revises the rates to be in alignment with the County of Los Angeles DMH Published Charges, Non-Medi-Cal rates for services that are billed to non-Medi-Cal responsible parties.

This will require Contractor to transform those general outpatient services previously funded with Non-MHSA and/or other State and/or County funds to new and/or expanded MHSA-CSS Plan programs and will require Contractor staff to provide services prescribed and approved under the MHSA-CSS Plan and the applicable service exhibit(s); various funding will be added/shifted and also will increase funds to the MCA for FYs 2009-10, 2010-11, and 2011-12:

by \$21,450; increases MHSA FCCS Child Medi-Cal/HF Maximum by \$470,722.
The revised MCA will be \$28,715,129.
