SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 169 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 15 new Agreements processed in the month of October 2009, as follows:

1. **Amendment No. 2 (DMH-02427) with Cri-Help** makes corrections to the original MHSA Master Agreement list and adds new insurance language for Fiscal Years (FYs) 2008-09 through 2010-11.
2. **Agreement (MH010063) with California School of Professional Psychology – Los Angeles dba Alliant International University** is being renewed for FYs 2009-10 through 2011-12 for Student Professional Development Programs.
3. **Amendment No. 1 (MH030133) with Meredyth Alpert Leafman, LCSW**, amends the Agreement to reflect the contractor's name change from Meredyth Alpert to Meredyth Alpert Leafman.
4. **Amendment No. 2 (MH060020) with San Pedro Peninsula Hospital dba Little Company of Mary San Pedro** changes the name from San Pedro Peninsula Hospital dba Little Company of Mary San Pedro to Providence Health System-Southern California dba Providence Little Company of Mary Medical Center San Pedro.
5. **Agreement (MH060031) with Prime Healthcare Services – Encino LLC dba Encino Hospital Medical Center** will allow for uninterrupted, medically necessary acute psychiatric inpatient hospital services and administrative day services to severely mentally ill clients who reside throughout the County of Los Angeles.

Angeles. This Agreement replaces the contract that was terminated on October 21, 2009 with Encino-Tarzana Regional Medical Center.

6. **Amendment No. 1 (MH060031) with Prime Healthcare Services – Encino LLC dba Encino Hospital Medical Center** allows contractor to participate in the Psychiatric Mobile Response Team (PMRT) Psychiatric Outreach Diversion Program (PDP) from October 22, 2009 through June 30, 2010.
7. **Amendment No. 11 (MH120282) with Jewish Family Services of Los Angeles** decreases Mental Health Services (MHS) Field Capable Clinical Services (FCCS) Older Adult (OA)-Client Supportive Services (CSS) (Flex Funds) by \$26,676, Local Mental Health Plan (MHP) Non-Medi-Cal MHSA Non-FSP OA Services Extenders by \$2,500; increases Non-Early and Periodic Screening, Diagnosis, and Treatment (Non-EPSTD) – Federal Financial Participation (FFP) by \$16,922 and Non-EPSTD MHSA FCCS by \$16,905. For FY 2008-09 only, the Maximum Contract Amount (MCA) will increase by \$4,651 with a revised MCA of \$1,055,951.
8. **Amendment No. 2 (MH120345) with Ettie Lee Homes, Inc.**, decreases Non-EPSTD – FFP by \$14,218; increases EPSTD FFP by \$86,582 and EPSTD- State General Funds (SGF) by \$69,477. For FY 2008-09 only, the MCA will increase by \$141,841 with a revised MCA of \$2,450,941.
9. **Amendment No. 2 (MH120447) with Exodus Recovery, Inc.**, adds Adult FCCS MHSA to an existing service delivery site located at 8401 South Vermont Avenue, Los Angeles, CA 90044; adds the corresponding services: Targeted Case Management (TCM) (Mode 15, Service Function Codes (SFCs) 01-09); MHS (Mode 15, SFCs 10-19/30-59); Medication Support Services (Mode 15, SFCs 60-69); Crisis Intervention (Mode 15, SFCs 70-79); Mental Health Promotion (Mode 45, SFCs 10-19); and Community Client Services (Mode 45, SFCs 20-29) under Provider No. (PN) 7385. There is no change to the MCA.
10. **Amendment No. 1 (MH120469) with Pacific Clinics** corrects the misallocation of MHP County General Fund (CGF) and MHSA Adult FCCS for FYs 2009-10, 2010-11, and 2011-12. MHP CGF funds in the amount of \$289,750 will be shifted to MHSA Adult FCCS. The MCA of \$79,460,000 will remain the same.
11. **Amendment No. 1 (MH120477) with Social Model Recovery Systems, Inc.** shifts Non-EPSTD Medi-Cal/Healthy Families (HF) Wellness Center funds in the amount of \$390,400 to Non-EPSTD Medi-Cal/HF Adult FCCS. There is no change to the MCA.
